Introduction: Project Overview

The Substance Abuse and Mental Health Services Administration (SAMHSA) through the GAINS Center for Behavioral Health and Justice Transformation recently convened a group of peer leaders to develop a draft set of core competencies specifically for individuals providing peer support in criminal justice settings.

The draft set of core competencies build upon SAMHSA's previous work – via its Bringing Recovery Supports to Scale Technical Assistance Strategy (BRSS TACS) – to develop core competencies for peer workers in behavioral health services.

The draft set of core competencies for peers providing peer support in criminal justice settings are addition to existing core competencies and are specific to individuals providing peer support in criminal justice settings.

SAMHSA would like to give the public an opportunity to review and comment on each of the additional core competencies. A general comment box is also available for overall comments.

Core Competency Development

Developing core competencies is a three phase process, requiring input from many people involved in peer services in the criminal justice system. Phase 1 began in May 2017. Phase 2 has started because of you. By responding to this survey, you are helping us make sure that we have clearly defined the knowledge, skills and abilities that a peer specialist must have to effectively work in a criminal justice setting. In May 2017, through the GAINS Center for Behavioral Health and Justice Transformation, convened a subject matter expert (SME) panel who worked together to establish the draft core competencies for peers working in the criminal justice system. *Please download and read the Core Competencies for Peers Working in the Criminal Justice System DRAFT Report (7/12/17) for detailed information.*

The SME panel members agreed to start with the assumption that the peer specialist already must have training and experience related to nationally recognized peer support specialist core competencies, ethical standards, and practice guidelines. From this starting point, the SMEs developed 48 additional core

competencies <u>specific to peer support in criminal justice</u> The competencies are allocated across seven (7) performance domains.

Advocacy*: 4 competencies

Mentoring/Shared Learning*: 4 competencies

Recovery and Wellness Support*: 8 competencies

Professional and Ethical Responsibilities*: 6 competencies

Foundations of Criminal Justice Systems: 10 competencies

<u>Trauma-informed Care in Criminal Justice</u>: 8 competencies

Integration, Reintegration and Re-entry: 8 competencies
