I. Program Description

A. Short Description of Funding Opportunity

This Notice of Funding Opportunity (NFO) is issued under 10 U.S.C. 4001, which provides the authority for issuing a grant under this announcement for basic research. The definitions of basic research may be found at 32 CFR 22.105.

This NFO is for the Bilateral Academic Research Initiative Pilot Program (BARI), which is jointly sponsored by the US Office of the Secretary of Defense (OSD) and the Economic and Social Research Council (ESRC) as part of United Kingdom Research and Innovation (UKRI). The BARI program addresses high risk basic research as an international collaboration. This research should attempt to understand new phenomena or produce discoveries that would impact understanding societal resilience in relation to social influence and information campaigns. The goal of the program is to produce significant scientific breakthroughs with far reaching consequences in understanding and influencing behavior below the threshold of armed conflict, specifically in relation to countering influence that leads to socio-economic and political instability. Proposals focused on specific devices or components are beyond the scope of this NFO.

The Department of Defense (DoD) agencies and ESRC involved in this program reserve the right to select one or none of the proposals submitted in response to this announcement for award. The participating DoD agencies and ESRC will provide no funding for direct reimbursement of proposal development costs.

The program focus is Understanding and Influencing Behavior Below the Threshold of Armed

Conflict: Countering Influence that Leads to Socio-economic and Political Instability.

B. Background

The BARI program supports basic research in science and engineering stemming from interactive collaborative efforts between U.S. institutions of higher education (hereafter referred to as "U.S. universities") and U.K. research institutions (hereafter referred to as "U.K. research organizations"; see https://www.ukri.org/apply-for-funding/before-you-apply/check-if-you-are-eligible-for-research-and-innovation-funding/eligibility-as-an-organisation/#contents-list) that is of potential interest to U.S. DoD and ESRC.

The program is focused on international collaborative research efforts where teams from the United States and the United Kingdom combine unique skillsets and approaches to provide rapid advances in scientific areas of mutual interest to the U.S. DoD and ESRC. In this edition of the BARI program, the focus is on information influence and socio-political (in)stability. Each proposal submitted under this NFO will be a joint US/UK proposal, with a US research team and a UK research team collaborating on a research solution.

A single proposal will be submitted by the US Research Team, for the two research teams. The single proposal must show that the proposed research is collaborative and interactive between the research teams and provide a distinct budget for the US Research Team (in US Dollars) and a distinct budget for the UK Research Team (in Pounds). The two principal investigators (PI's), one belonging to the US Research Team and one belonging to the UK Research Team, will work with the US and UK technical points of contact (POCs) to ensure the research stays collaborative as the research progress.

C. Program Description/Objective:

We are looking for collaborative research, teams that must include US IHEs and UK research organizations. A single technical proposal must be submitted that including a discussion of how the bi-national teams will work together. However, OUSDR&E will fund the US academic team and ESRC will fund the UK team through separate grant funding mechanisms. Each will have their own applicable terms and conditions. See SECTION F for US specific requirements and SECTION I for UK specific requirements.

The BARI Social Science Program competition is for research that falls within the purview of the topic:

Understanding and Influencing Behavior Below the Threshold of Armed Conflict: Countering Influence that Leads to Socio-economic and Political Instability.

Research focus outline

Both the COVID-19 pandemic and conflict in Ukraine have exposed vulnerabilities in the highly interconnected and interdependent world in which we live, with these very different shocks each quickly turning into major international social, political, and economic crises. The

United Kingdom, United States and their allies need to build societal resilience to these shocks and play a leading role in maintaining a secure international order. The rapid socio-economic, political, and technological changes of the Information Age are also driving substantial shifts in defense and security strategy needed to stay ahead of changes in the nature and character of warfare. New tools and tactics and being used to undermine political, social, and economic stability and cohesion. There is a need to better understand adversarial acts that influence population attitudes and behaviors and undermine institutions, infrastructure, and social cohesion in order to help mitigate against their impact and inform countermeasures. The funders expect to support social science-led interdisciplinary projects that bring together a broad and diverse range of academic expertise and stakeholders to tackle pressing questions in this field. Research should expand understanding of vulnerability and susceptibility to advanced adversarial information warfare techniques that undermine social cohesion and trust in different cultural and environmental contexts. We are looking to identify areas of US-UK coordinated research that could most effectively move this field forward. Through this initiative, the funders will support research that is international in focus, which can involve comparing or contrasting information campaigns and sub-threshold conflict contexts in different countries. Applicants to this call may select their countries of focus and are required to justify how their selection allows them to meet the objectives of the call. The funders recognize that applicants may need to consider one or multiple country contexts and include activities both internal and external to the US and UK in order to undertake their study.

• understand what constitutes societal resilience, how it is maintained or strengthened, and how it is weakened

Through this initiative, the funders will support research that aims to:

- understand the motivations and strategies of (international) information campaigns on target states and populations
- identify and examine coordinated attempts to influence population attitudes and behaviors and the techniques and tools used to undermine socio-economic and political stability
- examine the immediate, incremental, and cumulative effects of narratives and information campaigns on populations occurring through single instances or through multiple sources of information
- understand how cultural, economic, social dynamics, and individual traits (thoughts, feelings, and behaviors) influence susceptibility to, and the impact of, information campaigns
- explore whether particular communities (both online and offline) are more or less vulnerable to influence and socio-political instabilities, and the implications this has for countering influence
- examine the relationship between environmental or contextual characteristics and susceptibility to disinformation, deception, and negative influence, and explore how this can be measured
- examine how information campaigns affect social cohesion and trust in different national, local, and organizational cultures, and how efforts to influence populations (online and offline) affect group affinity, identity, behavior, and affiliation
- identify where sub-threshold techniques are influencing populations or causing socioeconomic instability, examine how this is impacting the socio-political environment and

- political decision-making, and characterize the role of culture and context in the effectiveness of such efforts
- examine how different nations, governments, administrations, and state and local jurisdictions respond to information campaigns and sub-threshold warfare efforts
- examine efforts of state and non-state actors (media, private sector, charities, and others) in information counter-narratives, interception and regulation of messaging, and the effectiveness of their approaches
- develop new or further develop existing methodological approaches to understanding misinformation, disinformation, deception, and international efforts to interfere and influence societies

What we want:

- Innovative proposals that will add to existing knowledge and consider how to build societal resilience to nefarious activities that adversely influence populations
- Research that will advance the state of the art and make significant advances in the field of social sciences and other disciplines
- Proposals that include a means for an enduring Trans-Atlantic Academic Alliance

What we do not want:

- Proposals that fail to take account of previously identified pitfalls in understanding and
 influencing behavior below the threshold of conflict, such as a lack of reliable measures
 of the effects on behaviors; behavioral changes over time; or sociocultural differences at
 the group, organizational, and societal levels
- Research that would not be considered revolutionary, that duplicates existing work, and delivers only incremental advances to existing theories and concepts

Basic Research requirements

This initiative will only fund basic (foundational) research that has the aim of improving academic understanding and developing social scientific theories or concepts that can form the basis for future applied research studies. Basic research, as defined within DOD 7000.14-R, Vol. 2B, Ch. 5, "is systematic study directed toward greater knowledge or understanding of the fundamental aspects of phenomena and observable facts without specific applications towards processes or products in mind." Funding cannot be used to design interventions.

Ethics and risk assurance

We expect that applicants will follow the guidance provided by the funders on research ethics which sets out what we consider best practice for social science research. Overall responsibility for ensuring that all funded research is subject to appropriate ethics review and monitoring lies with the applicant's research organization (RO). By submitting a proposal to the funders, the RO accepts the proposal's ethics information and confirms that it is prepared to administer any resulting grant on the basis specified in the proposal (and any additional conditions) and is committed to an appropriate and iterative ethics review process.

Applicants are advised to consider Human Research Protections guidelines for the DoD alongside ESRC research ethics guidance (https://www.ukri.org/councils/esrc/guidance-for-applicants/research-ethics-guidance/)

It is further expected that UK and US applicants will demonstrate that their projects are taking sufficient steps to address national security risks and outline this in the section on "ethical and

risk assurance," to explain how the proposal has considered and taken steps to mitigate risks that the research would:

- a) Expose participants to harm
- b) Compromise or expose researchers to harm (e.g. impact on security if researchers travel to some countries, or researchers based in countries that require disclosure of sensitive material to authorities)
- c) Present risks for national security interests—through the conduct of the research, data collections, or outcomes

Similarly, we expect the applicants will follow best practices for responsible research and innovation, such as those outlined in Human Research Protections protocols, UKRI guidance on responsible innovation (https://www.ukri.org/what-we-do/good-research-resource-hub/responsible-innovation/), and trusted research and innovation (https://www.ukri.org/about-us/policies-standards-and-data/good-research-resource-hub/trusted-research-and-innovation/.) Data management

A data management plan is mandatory in all applications. This plan should incorporate data management into the research cycle to ensure that generated data can be made available and reused to the maximum extent possible at the end of a grant, in line with the ESRC Research Data Policy—UKRI (https://www.ukri.org/publications/esrc-research-data-policy/).

Routes to impact and involvement of research users

Applicants should consider how they will or might achieve impact throughout their projects and include this as part of their application. Plans for enabling impact should make clear when and how non-academic research users will be involved in activity, and how these activities will enable the impacts that are anticipated. Projects must build in time for members of the research team to participate in knowledge exchange and impact generating activities.

D. Authorization

The authorization to make awards under this funding opportunity is 10 U.S.C. 4001 Research and Development Projects.

E. Legal Requirements

Any awards made under this announcement will be governed by the general terms and conditions in effect at the time of the award that conform to the DoD's implementation of OMB guidance applicable to financial assistance in 2 CFR 1100 [Subchapter D – Administrative Requirements Terms and Conditions for Cost-Type Grants and Cooperative Agreements to Nonprofit and Government Entities] which are located at https://www.nre.navy.mil/work-with-us/manage-your-award/manage-grant-award/grants-terms-conditions. These terms and conditions are incorporated by reference in this announcement.

II. Federal Award Information

The DOD will award one grant to the lead institution of the US Research Team which will only fund research performed by the US Research Team. The UK will make a corresponding award to fund performance under the selected proposal by the UK Research Team. Information

regarding the UK Research Team award can be found in section II.I.

Anticipated Period of Performance: The grant awarded under this NFO will have a three (3) year period of performance.

Instrument Type:

The type of funding instrument selected by the Government is planned to be a grant. A grant is defined as a legal instrument that, consistent with 31 U.S.C. 6304, is used to enter into a relationship:

- a. The principal purpose of which is to transfer a thing of value to the recipient to carry out a public purpose of support or stimulation authorized by a law or the United States, rather than to acquire property or services for the Federal Government's direct benefit or use.
- b. In which substantial involvement is not expected between the Federal Government and the recipient when carrying out the activity contemplated by the grant.
- c. No fee or profit is allowed.

Award Information:

The total funding from the US DoD available for the grant awarded from this NFO is estimated to be \$3,000,000.00. The US DoD funding will be used exclusively for research performed by the US Research Team. The grant awarded from this NFO is contingent on availability of funds, the specific topic, and the scope of the proposed work. For the US Research Team, expected annual funding will not exceed \$1,000,000.00 per year.

III. Eligibility Information

A. Eligible Applicants

As a result of this BARI competition, a program of international collaboration between the United States and the United Kingdom will be created. Consequently, the proposal will include two research teams, one of which will be from the U.S. and the other from the U.K. Accordingly, the BARI competition is open only to teams comprised of at least one (1) US institution of Higher Education as defined in 34 CFR 600.4 with a degree granting program in science or engineering (US University) and at least one (1) UK research institution (UK research organization). Proposals may only be submitted by UK research organizations who are eligible to apply to UKRI. Check if your institution is eligible for funding: https://www.ukri.org/apply-for-funding/eligibility-as-an-organisation/#contents-list.

US DoD Laboratories and Federally Funded Research and Development Centers (FFRDCs)) are not allowed to receive funds directly or via sub-awards.

B. Cost Sharing or Matching

Cost sharing or matching is not required under this NFO and is not an evaluation factor.

C. Conflict of Interest: General Requirement for Disclosure

Within the white paper submissions, organizations must disclose any potential or actual scientific or nonscientific conflict of interest(s). Organizations must also disclose any potential or actual conflict(s) of interest for any identified sub-recipient included in the application. Depending on the circumstances, the Government may request a conflict-of-interest mitigation plan. Government approval is required for all mitigation plans. Offerors with conflicts of interest that are not mitigated will be ineligible for award.

Marking Proprietary or Confidential Information

The DOD will make every effort to protect any proprietary information submitted in white papers and full applications. Any proprietary information included in application materials must be identified. Prospective proposers should be aware, however, that under the Freedom of Information Act (FOIA) requirements, proprietary information contained in white papers and applications (marked or unmarked) may still potentially be subject to release.

It is the prospective applicants' responsibility to notify the DOD of applications containing proprietary information and to identify the relevant portions of their applications that require protection. The entire application (or portions thereof) without protective markings or otherwise identified as requiring protection will be considered to be furnished voluntarily to WHS/AD without restriction and will be treated as such for all purposes.

It is the intent of WHS/AD to treat all white papers and full applications as proprietary information before the award and to disclose their contents to reviewers only for the purpose of evaluation.

IV. Application and Submission Information

A. Introduction on Submissions:

The announced application due date and procedures for submission will be strictly observed. Applications received after the established time and date above will not be considered; the burden of timely delivery (including requests for delivery confirmation) is on the Applicant.

When applicable, the application due date is determined by the timestamp and date of the Applicant's submission on https://www.grants.gov/. Applications received after the due date and timestamp will not be considered.

It is essential that all applications be complete and accurate at the time of submission. OUSD(R&E) and ESRC (hereafter referred to as "Funders") reserve the right to reject applications that are incomplete or that do not comply with submission instructions. All documentation submitted under this NFO is unclassified.

B. Two Stages of Submissions

The BARI application process is conducted in two stages:

Stage One – White Paper submission (via email to technical point of contact) o Deadline: 15 September 2023, 4:00 PM ET

Stage Two – Full Application submission (via Grants.gov) o Deadline:31 January 2024, 4:00 PM ET

Stage One –Based on an assessment of the white papers submitted, the technical point-of-contact (POC) will advise prospective proposers whether the proposals outlined in their white papers were judged to be competitive for BARI award selection, and will then invite the most promising subset of proposals to submit a full proposal for funding consideration. NB: White Papers are optional, though strongly encouraged.

Stage Two – Subsequent to white paper feedback, interested entities will be asked to submit full proposals. All proposals submitted under the terms and conditions cited in this NFO will be evaluated in accordance with the evaluation criteria stated herein. NB: Entities may submit a proposal without submitting a white paper, though this is discouraged.

Applicants must complete all mandatory forms and any optional forms (e.g., SF-LLL Disclosure of Lobbying Activities) in accordance with the instructions on the forms and the additional instructions below. Please ensure that your attachments are not password protected.

Stage Two applications will only be accepted if submitted through grants.gov. Organizations must have a Unique Entity Identifier (UEI), active System for Award Management (SAM) registration, and Grants.gov account to apply for grants.

C. Format for Submissions

The following formatting rules apply for the file attachments for White Paper and Full Proposal submissions, except as indicated below:

- Paper size when printed 8.5 x 11-inch white paper, one-sided
- Margins 1 inch
- Spacing single
- Font No smaller than Times New Roman, 12-point font (excluding mandatory forms, which may have other font requirements)
- Number of pages
 - o WHITE PAPER: 4 pages.
 - FULL PROPOSAL: 25 pages. The 25-page limit applies to the technical portion of the application, which consists of the following: Project Summary/Abstract and Project Narrative. Pages exceeding this limit will not be considered in the application evaluation.

D. Application Withdrawal:

An applicant may withdraw an application at any time before award by written notice. Notice of withdrawal shall be sent to the grants officer identified in this announcement. Withdrawals are effective upon receipt of notice by the grants officer.

E. White Papers

1. White Paper Format and Content

Submitted documentation should be in PDF format and include in a single document:

- A cover letter (optional), not to exceed one page.
- A cover page, labeled "APPLICATION WHITE PAPER," that includes the Notice of Funding Opportunity number, proposed project title, and prospective applicant's technical point of contact with telephone number, and e-mail address.
- Curriculum vitae (CV) of key investigators (optional)
- The white paper (four (4) page limit, single-sided) including:
 - o Identification of the research and issues including the state of the field
 - Proposed methods
 - o Potential contribution to fundamental social science basic research
 - o Potential implications for national defense
 - o Potential team and management plan
 - Data management plan for data or tools to be generated in the course of research
 - Summary of estimated costs
 - Reference citations are not required but may be included outside the fourpage limit
- The white paper will detail, separately, both US and UK efforts

OUSD(R&E) and ESRC are interested in the research outlined in the Program Description of this NFO. For this reason, the application narrative must clearly describe what research the US Research Team and UK Research Team will accomplish collaboratively as well as what will be accomplished by the US and UK research teams individually. The white paper must also provide detailed budget breakouts for the US Research Team, in US Dollars, and the UK Research Team, in Pounds.

The white paper should provide sufficient information on the research being proposed (e.g., hypothesis, theories, concepts, methods, approaches, data collection, measurement and analyses) to allow for an assessment by a subject matter expert.

2. White Paper Submission

White papers and supporting documentation must be submitted as email attachments to both osd.minerva@mail.mil AND osd.minerva@mail.mil AND osd.minerva@mail.mil AND osd.minerva@mail.mil AND osd.minerva@serc.ukri.org no later than 4:00 p.m. Eastern Daylight Time / 9:00 p.m. British Summer Time on 15 September 2023. E-mail transmission is not instantaneous and delays in transmission may occur anywhere along the route. The Funders takes no responsibility for any delays in the transmission of an e-mail. The prospective applicant is responsible for allowing enough time to complete the required application components, upload the white paper, and submit via e-mail before the deadline. It is not necessary for white papers to carry official institutional signatures.

The submission email subject line should indicate the BARI WP submission.

An e-mail confirmation will be sent to the applicant within three days of submission. Documents submitted after the deadline or found to be noncompliant with the requirements described above will not be reviewed.

F. Full Proposals

1. Unique Entity Identifier and System for Award Management Several one-time actions must be completed in order to submit the stage two application through Grants.gov. These include obtaining a Dun and Bradstreet Data Universal Numbering System (DUNS) number, registering with the System for Award Management (SAM), registering with the credential provider, and registering with Grants.gov. Each member of the US Research Team listed on the proposal submitted to this NFO is required to (a) be registered in SAM prior to submitting its application; (b) provide a valid DUNS number in its application; and (c) continue to maintain an active SAM registration with current information at all times during which it has an active federal award or an application or plan under consideration by a federal agency.

The DOD will not make an award to an applicant until the applicant has complied with all applicable DUNS and SAM requirements. If an applicant has not fully complied with the requirements by the time the DOD is ready to make an award, the evaluation panel will determine that the applicant is not qualified to receive an award and use that determination as a basis for making an award to another applicant.

- a. Project Summary/Abstract (Field 7 on the form) (Mandatory) The Project Summary/Abstract must be no longer than a single page. The abstract must be marked that it is publicly releasable, as abstracts for all awarded applications will be placed on a DoD website(s) searchable by the public. The abstract should provide a concise description of the equipment/instrumentation requested, using terminology the public can understand, and the research/research-related education that it will support. The header of the abstract should identify the PI, the institution, and the application title.
- b. Project Narrative (Field 8 on the form) The project narrative must address how the proposed research is relevant the DoD and ESRC mission focus on security in the following format:
- a. DoD Basic Research Office and ESRC to evaluate the application, if known;
- b. Scientific Division(s) or Directorate(s), if known; and
- c. Technical Area(s)/Program Manager(s), if known.

The Project Narrative must also describe the research and explain how it will help the DoD and ESRC meet its goals and objectives outlined in II.A. In the description of work of the UK research team, cover the vision, approach, organization's support for the project, project partners, team capability to deliver, data management and sharing, and ethics. - 10. Requirements for an Institution of Higher Education Concerning Military Recruiters and Reserve Officers Training Corps (ROTC).
 - a. As a condition for receiving funds available to the DoD under this award, you agree that you are not an institution of higher education (as defined in 32 CFR part 216) that has a policy or practice that either prohibits, or in effect prevents:

 - ii. May suspend or terminate those awards unilaterally for material failure to comply with the award terms and conditions.
- 11. Historic preservation. You must identify to us any:

 - b. Potential under this award for irreparable loss or destruction of significant scientific, prehistorical, historical, or archeological data, and provide any help we may need, with respect to this award, to comply with the Archaeological and Historic Preservation Act of 1974 (54 U.S.C. chapter 3125).
- 12. Relocation and real property acquisition. You must comply with applicable provisions of 49 CFR part 24, which implements the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 (42 U.S.C. 4601, et seq.) and provides for fair and equitable treatment of persons displaced by federally assisted programs or persons whose property is acquired as a result of such programs.
- 13. Confidentiality of patient records. You must keep confidential any records that you maintain of the identity, diagnosis, prognosis, or treatment of any patient in connection with any program or activity relating to substance abuse education, prevention, training, treatment, or rehabilitation that is assisted directly or indirectly under this award, in accordance with 42 U.S.C. 290dd–2.

14. Pro-Children Act.

You must comply with applicable restrictions in the Pro-Children Act of 1994 (Title 20, Chapter 68, subchapter X, Part B of the U.S. Code) on smoking in any indoor facility:

- a. Constructed, operated, or maintained under this award and used for routine or regular provision of kindergarten, elementary, or secondary education or library services to children under the age of 18.

- UKRI-funded grant-holders are expected to provide a Final Expenditure Statement (FES) as part of the financial reporting on the grant.
