1. The Church

Our congregation is a strong Christian group that gets along well together in all age groups. We are a loving and caring congregation. We've been here a long time. We recently have been searching within ourselves for ways to help our church grow and ways that we might read out to our community. We would really like to see our church grown in numbers and young people and young families so that our church will continue to be here in the future. We have not been trained in the skills needed for outreach. Our congregation is willing to learn to do whatever is necessary for reaching out at this time in our church life. Within the last five years we totally remodeled our sanctuary. Antioch Church is surrounded by the Antioch Community Cemetery. The manse sits across the road from the church on a corner lot surrounded by pine trees.

2. The Community

We situated in a suburban area of approximately 2,000 near the very quant town of Quitman. We have an excellent school at Quitman, Grades K-12, with approximately 651 students. Jonesboro/Hodge/North Hodge (approximately 5 miles) has a combined population of about 5,500. Jonesboro is the parish seat of Jackson Parish (Population of 16,274). Jonesboro has an annual Christmas In The Pines Parade the Saturday after Thanksgiving, with fireworks, and the lighting of the Christmas lights which number more than 7 million plus. People travel from many of the surrounding cities for this event and view the light display through January 1.

Caney Lake is located in Jackson Parish and offers some very good fishing, boating, and camping. Bienville Wildlife Refuge is a hot spot for deer and turkey hunting.

Timber is Jackson Parish's major industry. Rock Tenn is located in Hodge ((approximately 7 miles toward Jonesboro) and is this area's largest manufacturing firm. Other industries are plan nurseries, cattle ranching, poultry and egg farming and numerous truck crops.

Ruston (population 21,859) is located approximately 14 miles north of us and Louisiana Tech University is located there. There are six colleges and technical colleges within driving distance. The North Louisiana Medical Center is in Ruston also.

Monroe (population of 48,815) is located approximately 46 miles away and Shreveport (population 200,327) is located approximately 76 miles away. These are large towns and offer all the attractions of larger towns-museums, mall shopping, large hospitals and treatment centers, airports, zoos, etc.

We hold worship services on Sunday morning and night. We also have a service on Wednesday nights. We usually have a fifth Sunday night pot luck supper. On occasion the church will go out to eat together at a local restaurant.
