ABOUT THE POSITION: GRANTS OFFICER - FISCAL

OneStar Foundation seeks to fill the full-time position of Grants Officer - Fiscal. This position supports the development and implementation of OneStar's grants portfolio in the area of service and volunteerism. Primary functions are related to supporting OneStar's role in administering the AmeriCorps*Texas program, primarily monitoring compliance with financial management of AmeriCorps*Texas grants. The Grants Officer - Fiscal position performs advanced professional work under limited supervision with considerable latitude for the use of initiative and independent judgment. This position reports to the Director of National Service Programs and serves on the AmeriCorps*Texas team, currently with 6 people total.

The successful candidate will be a self-motivated, hands-on, organized professional with a positive, can-do attitude. She/he must enjoy the challenges and rigors of a growing and evolving service-oriented organization and must enjoy working with a variety of organizations, including faith-based and small grassroots community organizations. Flexibility, focus and commitment to the goals of the organization will be critical.

Primary Responsibilities

- Provides sound fiscal oversight of organizations receiving AmeriCorps*Texas grants from OneStar through formal monitoring and day-to-day communication, including analysis of: budgets and financial systems, organizational capacity surveys, internal control reviews, grant narratives, A-133 and financial statement audits, pre-award fiscal system and document reviews, expenditure documentation, expenditure and in-kind match documentation, fiscal monitoring reviews, OMB Circulars, federal regulations, funder directives, grantees policies, procedures, and systems, and verbal and written communication with grantees.
- 2. Conducts fiscal monitoring activities and site visits, writes reports of fiscal monitoring findings, and works with involved parties to resolve findings.
- 3. Reviews and approves grantee reimbursement requests for consistency and allowability of costs in accordance with OneStar policies and procedures and grant terms and conditions, and maintains accurate records of grantee expenditures and fiscal documentation related to compliance, deliverables, and other key performance benchmarks.
- 4. Serves as a specialist in assessing grantees' organizational capacity, financial systems, documentation and reports, and recommends financial best practices of grants management to current and potential grantees on matters related to financial management of AmeriCorps grants.
- 5. Works as part of a two-person team structure (1 program-focused Grants Officer and 1 fiscal-focused Grants Officer per grantee) in development and implementation of OneStar's service and volunteerism strategies.
- 6. Works with the AmeriCorps*Texas team to identify non-compliance issues and may develop recommendations to management on steps to resolve non-compliance ranging from corrective action plans to termination of grant awards; develops and monitors corrective action plans for organizations in assigned portfolio. Keeps manager informed of all significant developments, and immediately alerts management of any possible signs of fraud or mismanagement of funds.
- 7. Collects and analyzes data, assists with preparing required reports; communicates data to stakeholders; and manages ongoing grantee risk assessment and system improvement processes.
- 8. Reviews and recommends amendments or other revisions to the agreed upon grant deliverables, timelines, budgets, and/or other grant requirements for organizations in assigned portfolio.
- Supports the grant making process for AmeriCorps*Texas, including pre-award risk assessment, application development, selection process, negotiation process, post-award monitoring and reporting, and general technical assistance to grantees and potential grantees. Supports and may lead the fiscal negotiation of grant awards.
- 10. Provides high quality customer service and proactively provides written and verbal feedback to organizations in assigned portfolio to build relationships and foster continuous improvement.
- 11. Assesses and analyzes training and technical assistance needs and continuous improvement issues specific to individual grantees and/or a larger portfolio to ensure high quality/high performing programs. Works with AmeriCorps*Texas team to develop training that will provide value to grantees, improving their capabilities, scale and impact.
- 12. Contributes to OneStar's thought leadership efforts by helping to write content for publications, newsletters, website, social media, and online resources, and the design and presentation of workshops and/or other trainings on topics related to service and volunteerism.
- 13. Engages in research and general reading on issues and events related to OneStar's mission and federal and financial grants management in particular.
- 14. May work in coordination with the social media team to implement strategies that ensure the marketing of OneStar grants and services reaches a broad and appropriate constituency.
- 15. May work with the Director, Research and *Texas Connector* to capture learning and implement quantitative and qualitative evaluation tools, including evaluation of the AmeriCorps*Texas portfolio.

- 16. May be assigned to develop expertise and manage special projects within a particular focus area, such as AmeriCorps program income, in-kind documentation, other grant compliance issues, or training and resource development.
- 17. May support the procurement process for contracts with consultants or other training providers as needed; including the process by which OneStar team members and other can utilize the services of the contractors.
- 18. May represent OneStar at meetings, conferences, events and other functions, including making remarks or presentations.
- 19. May facilitate meetings, focus groups, training or other events with OneStar grantees.
- 20. May assist with developing grant applications that support the area of service and volunteerism.
- 21. May supervise and/or coordinate the project work of others.
- 22. Aligns work duties with the OneStar Mission and Vision.
- 23. Exemplifies OneStar Core Values and adheres to the Code of Ethics.
- 24. May be assigned to cross-functional teams to support OneStar goals and initiatives.
- 25. May perform other duties as assigned consistent with current duties and responsibilities.

Minimum Qualifications

- 1. 3 to 7 years of relevant work experience; at least 5 years of relevant work experience is preferred.
- 2. Understanding and commitment to OneStar's mission and strategies and to all its programs and initiatives.
- 3. Understanding and commitment to OneStar's Core Values and Code of Ethics.
- 4. Federal financial grant management experience is strongly preferred.
- 5. AmeriCorps experience preferred, but not required.
- 6. Experience working with nonprofit organizations is preferred, including faith-based and other grassroots community organizations, and/or other social service sector organizations.
- 7. Must thrive in a work environment of significant growth, development and change.
- 8. Willing to travel in Texas, and occasionally to other states, for grantee monitoring visits and special events (approximately 20% time).
- 9. Graduation from an accredited university with major coursework in a relevant field (in special cases equivalent work experience may be substituted for this requirement).

Knowledge, Skills and Abilities Required

- 1. Knowledge of best practices in federal grants management.
- 2. Knowledge of best practices in accounting, budgeting, and/or auditing and fiscal monitoring.
- 3. Knowledge of federal regulations, OMB Circulars, and other federal grant directives.
- 4. Knowledge of allowable cost directives and ability to determine if grantee systems will result in allowable costs and if grantee documentation substantiates associated costs.
- 5. Ability to coach grantees and/or other organizations, particularly related to fiscal compliance issues.
- 6. Ability to research, interpret, apply and communicate complex regulations, policies and procedures.
- 7. Ability to communicate effectively orally and in writing; to exercise sound judgment in making critical decisions; to analyze complex information and develop plans to address identified issues; and to effectively demonstrate negotiation and facilitation skills.

- 8. Ability to define problems, collect data, establish facts, draw valid conclusions and provide recommendations.
- 9. Ability to manage and prioritize work in an environment of significant growth, development and change.
- 10. A strong passion for supporting a portfolio of organizations with diverse community driven missions, and an ability to work with a variety of organization types (faith-based and community organizations, state/local governments, colleges/universities).
- 11. Intellectual curiosity, creativity, high-energy, persistent, quick study, positive attitude.
- 12. Excellent time management and organizational skills, detail oriented, and the ability to work both independently with general supervision and as part of a project team.
- 13. Strong verbal and written communication skills.
- 14. Excellent customer service skills.
- 15. Ability to think strategically in relationship building and partnership development.
- 16. Ability to lead teams where appropriate.
- 17. Comfort in working respectfully with persons of diverse faith backgrounds.
- 18. Ability to relate to, and engender trust with people of different ages, races, ethnicity, and socioeconomic status.
- 19. Thorough knowledge of Microsoft Office products.
- 20. Ability to manage multiple tasks simultaneously and meet multiple deadlines.
- 21. Ability to exercise sound judgment in making critical decisions; to analyze complex information and effectively communicate it to others.
- 22. Strong interpersonal skills to develop and maintain cooperative, professional and productive work relationships with others.
