General Information about Tools

Child Rapid Indicator Tool "Rapid Child ST Tool"

The indicators help to determine whether a child may be a victim of sex trafficking, or is at risk of being a victim of sex trafficking. These factors are to be considered as a means to determine whether there is reasonable cause to believe the child is a victim or at risk of being a victim, in which case a more comprehensive assessment of the child's experiences and service needs is required.

Child Sex Trafficking Indicators Tool "Child ST Tool"

This tool is used in the identification of victims of sex trafficking and children and youth at risk of sex trafficking. The tool is to be used as a more comprehensive assessment of risk and victimization when any one or more indicator is recorded on the Child Rapid Indicator Tool.

General Human Trafficking Tool "General HT Tool"

The indicators help to determine whether a person may be a victim of human trafficking, or is at risk of being a victim of human trafficking.

Healthcare professionals should be mindful of the HIPAA Privacy Rule.

Human trafficking can be reported without divulging individually identifiable information. For example, you could report the gender and age of the individual and type of trafficking but not the date of service.

Question: Is a healthcare professional (HCP), covered by HIPAA, permitted to disclose protected health information (PHI) in the case of a suspected HT victim?

Answer: Yes, the HCP, covered by HIPAA, is permitted to disclose PHI in the case of a suspected HT victim under the following conditions:

- (1) With the patient's permission, or
- (2) If the patient does not give permission, then reporting is only permitted under specific exclusions or exemptions defined by HIPAA:
- (2a) Mandated reporting: the reporting must be made only to the legal entity authorized to receive these reports and should include a disclosure of only the information required under mandated-reporting laws. - (2b) Imminent danger of patient or staff: The HCP is directed to make decisions in "good faith" and may disclose PHI when "it is felt to be necessary to prevent or lessen a serious and imminent threat to the health or safety of a person or the public" (DHHS, 2013b, p. 94).
