



Week of August 8 to August 15, 2021

Monday August 9th

8:40AM 1700 Blk of California St Burglary Case #210505125

Officer Pitcher and Officer Coffaro responded to the area on a report of a burglary. Their investigation revealed an unknown subject pried their way into the building and stole several peices of electronic equipment. This investigation is being handled by the Special Investigation Division.

Thursday August 12th

8:40PM Polk St & Redwood St Robbery, Aggravated Assault Case #210514295

Officer Fuller and Officer Phillips responded to the area on a report of an aggravated assault. The officers contacted a victim who had serious injuries. The victim reported that a subject, who was riding a bicycle, approached and attacked him with a shovel. The victim was struck on his upper body and head multiple times and briefly lost consciousness. The victim woke to the subject stealing his phone. The victim attempted to retrieve the phone and the subject kicked him and escaped on the bike. The victim was treated for non-life threatening injuries at a local hospital. This incident is currently under investigation.

Saturday August 14th

1:50AM Geary Blvd & Steiner St Vehicle Collision Case #210519687 A solo motorcycle collision occurred in the intersection. The rider was ejected from the motorcycle and succumbed to fatal injuries. This incident is being investigated by the Traffic Collision Unit.

5:30PM Greenwich St & Polk St Robbery Case #210518899

Officer Lynch and Officer Orengo responded to the area on a report of a strong-arm robbery. They met with a victim who told the officers that he was in the area taking photographs. A vehicle pulled up and the passenger initiated a conversation with the victim to coax him closer. The passenger grabbed the camera hanging from the victim's neck and fled in the vehicle. The victim suffered minor injuries from being dragged by the vehicle and was treated at the hospital. This incident is currently under investigation.

Sunday August 15th

1:40AM 2000 Blk of Lombard St Stabbing Case #210521864

Officer Fuller and Officer McCarter responded to Marin County on a report of a possible stabbing that occurred on the listed date and time. They met with a victim who said his vehicle was broken into on the 2000 Blk of Lombard St. While checking on his vehicle, the victim saw that his friend was engaged in a physical altercation with two other subjects. The victim attempted to intervene but was tackled to the ground by one of the subjects. The victim was kicked and punched multiple times. When the victim returned home, he realized he also suffered multiple puncture wounds. The victim transported himself to a hospital in Marin County for medical treatment. This incident is currently under investigation.

9:00PM Steiner St & Vallejo St Armed Robbery Case #210521808
Officer Gala and Officer Dragon responded to the area on a report of a robbery with a gun. The officers contacted a victim who stated she was riding her own bike when she was accosted by a subject on a bike. The subject pointed a handgun at the victim and demanded her belongings. The victim feared for safety and surrendered her property to the subject. The subject fled on his bike and when officers conducted an area search they located the subject's bike discarded on the 200 block of Moulton St. This incident is currently under investigation.



San Francisco Police Arrest Noe Valley Attempted Armed Robbery Suspect

On Saturday May 25, 2021, at approximately 3:07 pm, San Francisco Police officers from Mission Station responded to the 3800 block of 24th Street for a report of an armed robbery. Officers located the victim, a 70-year-old Asian male, who told them the following: he was standing outside on the sidewalk when a white sedan stopped near him. An unknown male suspect exited the vehicle, grabbed the victim, and pointed a firearm at him. The suspect demanded the victim's watch. A family member of the victim, a 30-year-old Asian female, observed what was happening and attempted to intervene and a physical struggle ensued. Both victims fell to the ground during the incident and sustained non-life-threatening injuries. The suspect was unsuccessful in taking the victim's watch. He ran to a waiting vehicle, got in, and fled the scene. The victims were treated for their injuries at the scene.

The SFPD Robbery Detail led the investigation. Investigators were able to obtain a sample of the suspect's DNA on the victim's clothing. Investigators also obtained the suspect's phone records, which placed him at the scene. The suspect was identified as 23-year-old Dreshaun Townsend of South San Francisco. On August 10, 2021, investigators from the SFPD Robbery Detail along with members of the SFPD Tactical Unit served search and arrest warrants on the 3700 block of Radburn Drive in South San Francisco. Townsend was taken into custody and placed under arrest without incident.

Townsend was later transported to San Francisco County Jail where he was booked on charges of attempted robbery (664/211 PC), assault by means likely to cause great bodily injury (245(a)(4) PC), and a firearm enhancement (12022.53(a) PC). Townsend also had two outstanding warrants based out of San Benito and Kern Counties.

San Francisco Police Arrest Attempted Homicide Suspect

On Tuesday August 3, 2021, at approximately 6:39p.m., San Francisco Police officers from Bayview Station responded to the area of Bacon Street and Bayshore Boulevard for a report of a shooting. While responding to the call officers were advised that a shooting victim was privately transported to a local hospital. The victim, a 34-year-old male, was admitted with life-threatening injuries. Responding officers located a crime scene consistent with a shooting incident at Bacon Street and Bayshore Boulevard.

Officers spoke with the victim's friend who told officers that the two of them were in a vehicle stopped at a stoplight when they heard gunfire coming from the vehicle in front of them. The victim was struck by the gunfire. The victim's friend drove to a nearby hospital for treatment.

Investigators from the SFPD Night Investigations Unit led the investigation. Investigators obtained a photo of the vehicle and identified the suspect as 60-year-old Albert Grigsby of San Francisco. On August 3, 2021, an SFPD officer from Southern Station was working in the area of 3rd Street and Carroll Avenue when he observed the suspect vehicle. The officer conducted a traffic stop on the vehicle and identified the driver as Grigsby. Grigsby was taken into custody without incident.

Grigsby was later transported to San Francisco County Jail where he was booked on charges of attempted murder (664/187 PC), assault with a firearm (245(b) PC), possession of a firearm by a prohibited person (29800(a) PC), carrying a concealed firearm (25400(a)(1) PC), and carrying a concealed firearm in public (25850(a) PC).

San Francisco Police Arrest Second Suspect Wanted in Connection with Jace Young Homicide

On July 4, 2020, at approximately 10:44 p.m., San Francisco Police responded to the unit block of Whitfield Court for a report of a shooting. Officers arrived and found a juvenile victim suffering from a gunshot wound. The victim, 6-year-old Jace Young, was transported to the hospital with life-threatening injuries. Despite the best efforts of the medical staff, Jace succumbed to his injuries. A second shooting victim was taken to a local hospital with non-life-threatening injuries.

Investigators from the SFPD Homicide Detail developed information that led to the identity of two suspects; 18-year-old James Harbor and 18-year-old Deshaune Lumpkin, both of San Francisco. Investigators obtained arrest warrants for Harbor and Lumpkin. On January 6, 2021, San Francisco Police officers arrested 18-year-old James Harbor of San Francisco and booked him on charges of homicide (187 PC), attempted homicide (664/187 PC), and carrying a loaded firearm with the intent to commit a felony (25800(a) PC).

On Wednesday August 11, 2021, San Francisco Police officers from the Northern Housing Unit and Community Violence Reduction Team located and arrested Deshaune Lumpkin on the 1100 block of Scott Street. Lumpkin was arrested for his outstanding warrant for the homicide of Jace Young.

San Francisco Police Seek Public's Help to Solve 2006 Cold Case Homicide

San Francisco Police Homicide Investigators are seeking assistance in solving the 2006 murder of Aubrey Abrakasa. On August 14, 2006, at 3:14 PM, the 17 year-old student was shot multiple times and killed at the intersection of Grove and Baker Streets.

Aubrey's mother, Paulette Brown, has been a tireless advocate for her son and for the families of other murder victims. In partnership with the SFPD's Homicide Detail and Crime Strategies Division, Ms. Brown helped spearhead the creation of a digital posterboard of homicide victims reward bulletins to be displayed in our district stations' lobbies.

On **Friday, August 13, 2021 at 3:00 PM**, Ms. Brown will be at Grove and Baker Streets handing out fliers and available to speak to the media. A member of the SFPD Homicide Detail and Media Relations staff will be available to the press as well. Please refer to **Core Guidance for COVID-19** to reduce the spread of illness.



San Francisco Police Make Arrests in SOMA Homicide

On Saturday May 22, 2021, at approximately 11:17 pm, San Francisco Police officers from Southern Station responded to the 1100 block of Mission Street for a report of a shooting. Officers located a 25-year-old male victim in his vehicle suffering from multiple gunshot wounds. The victim was pronounced deceased at the scene. The suspect went to a waiting vehicle being driven by a second suspect. The vehicle then fled the scene.

The SFPD Homicide Detail led the investigation that identified the two suspects as 20-year-old Tam Hoan Ly of San Bruno and 25-year-old Juju Anino of San Francisco. Investigators obtained warrants for the arrest of Ly and Anino. On Thursday August 5, 2021, members of the SFPD Homicide Detail and SFPD Tactical Unit served simultaneous search warrants on the 100 block of Congdon Street in San Francisco and the 200 block of San Luis Avenue in San Bruno. Anino and Ly were both taken into custody without incident. Anino and Ly were later transported to San Francisco County Jail where they were both booked on charges of murder (187 PC) and conspiracy (182(a) PC). Ly was also booked on a warrant based out of San Mateo County.

Turn off the ignition

Never leave your car running unattended

Car thieves only need seconds to break into your car. So Park Smart, and especially keep your trunk clear.

Take everything with you.









PREVENT GARAGE DOOR BREAK-INS

Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.





ALWAYS CLOSE YOUR GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and you'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.



INSTALL MOTION-SENSITIVE

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



REINFORCE THE GLASS ON THE GARAGE DOOR

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.



DON'T LEAVE GARAGE DOOR REMOTE IN YOUR CAR

A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a keychain.



INSTALL AN INTERIOR MANUAL GARAGE DOOR LOCK

When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.



TIE EMERGENCY RELEASE CORD

Tying your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



INSTALL SURVEILLANCE CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.



SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



HAVE A QUALITY, FUNCTIONING GARAGE DOOR

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.



INSTALL INTERIOR MAIL SLOT HOOD COVER

If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.
