Dear Chairs Scott and Murray and Ranking Members Foxx and Burr,

On behalf of the undersigned associations, I write to urge you to pass the bipartisan Building Civic Bridges Act (H.R. 6843/S. 4530) before the end of the 117<sup>th</sup> Congress. We strongly support this bipartisan legislation to deepen civic engagement. Fostering civic engagement across deep divides – no matter whether the divides are religious, racial, economic, or partisan – is paramount if we wish to protect our democracy at a time of intense polarization.

There is an urgent need to expand and enhance efforts to preserve our republic's democratic values. Ideological polarization and partisan hostility are at historic levels, as the majority of Americans now have a "very unfavorable" view of people in the other party.¹ These divisions will only continue to worsen over time if we do not address them now. Civic dialogue is crucial to the fabric of our democracy. Across the country, our nation's colleges and universities bring together people from diverse backgrounds and are often flashpoints for deep and partisan disagreements. We know the importance of bridging divides and seek to foster the kinds of civic engagement and participation that are essential to sustaining our country's democratic traditions. Engaging with a wide range of people has the potential to increase sensitivity to differences in perspective and improve our ability to function in a heterogeneous community,² and this is exactly what the Building Civic Bridges Act would do.

The legislation would create an office of Civic Bridgebuilding that would provide competitive grants to civic bridgebuilding programs across the country and track their success, train AmeriCorps members in bridgebuilding skills, and serve as a public coordinator and

convener for the larger national civic bridgebuilding movement. The bill sets up a rigorous, evidence-based, peer-reviewed grant application process for applicants like community nonprofits, universities, civic clubs, and religious organizations to follow. The Building Civic Bridges Act would also fund research on civic bridgebuilding and social cohesion.

Strengthening civic bridgebuilding in communities across the country is vital to fostering constructive political discourse that advances our nation's democratic values and national interests. The Building Civic Bridges Act represents a meaningful step to addressing these problems in a bipartisan way, and we look forward to working with you to advance this important legislation.
