## ***CODI CANDEMIC***

To whom it may concern,

Starting today, March 17<sup>th</sup>, CODI will offer **free** mobile canning. Filling machines and trucks are getting ready today to meet our industry's needs.

### **Who is this for?**

CODI manufacturing is offering this service to small beverage companies that have tanks full of product and no ability to package in cans or bottles. Today CODI is ready to service the Colorado market only, but we are looking into options for other areas. The intention is for small businesses to survive without tap room draft sales.

### **What do I do with the cans after?**

- Many breweries are offering home delivery and drive up sales. (You are responsible for looking into legal compliance)
- Product should be shelf stable for 6 months(ish).

### **What conditions does the product need to be in?**

- 28-35F temperature is ideal. Up to 50F is possible
- CO2 volumes of 0-3.5 is ideal. Up to 4.5 CO2 vols with non-protein based products.

### **How is the machine sanitized/sterilized?**

- CODI can handle caustic cleaning at 180F
- The complete filling line is steam cleanable
- We are working with industry partners to develop an advanced cleaning procedure to not spread any new problems around the industry.
- CODI technicians will only be sent out showing no fever, coughing or sneezing. We will not enter facilities with personal showing signs of flu or confirmed cases of COVID-19.

### **What about cans, labels, multipacks....?**

CODI is in contact with preferred suppliers and will start building inventory immediately. We are hoping to bring these supplies with us.

## TTB label approval?

CODI is in contact with the TTB to get this program going. What we have learned so far:

- TTB is open for business and approval process is rolling as normal
- Label approval is not required for product sold inside CO.
- CODI is working on a universal label that each customer will be able to digitally print their information on. The information needed:
  - o Brewery Name
  - o Net contents of the can
  - o Nature of the product such as beer, ale, porter, stout....
  - o The place of production
