Dear Dr. Kanack:

This letter is in response your request that the Food and Drug Administration (FDA) issue an Emergency U. Author zation (E-A) for emergency use of your product,³ pursuant to Section 564 of the Federal Prug, and Cosmetic Act (the Act) (21 U.S.C. §360bbb-3).

On February 4, 2020, possuant to Section 564(b)(1)(C) of the Act, the Secretary of the Department of Health and Human Services (HHS) determined that there is a public health emergency that has a significant potential to affect national security or the health and security of United States citizens living abroad, and that involves the virus that causes COVID-19. Pursuant to Section 564 of the Act, and on the basis of such determination, the Secretary of

HHS then declared that circumstances exist justifying the authorization of emergency use of in vitro diagnostics for detection and/or diagnosis of the virus that causes COVID-19 subject to the terms of any authorization issued under Section 564(a) of the Act.⁴

Having concluded that the criteria for issuance of this authorization under Section 564(c) of the Act are met, I am authorizing the emergency use of your product, described in the Scope of Authorization Section of this letter (Section II), subject to the terms of this authorization.

I. Criteria for Issuance of Authorization

I have concluded that the emergency use of your product meets the criteria for issuance of an authorization under Section 564(c) of the Act, because I have concluded that:

- 1. The SARS-CoV-2 can cause a serious or life-threatening disease condition, including severe respiratory illness, to humans infected by the virus
- 2. Based on the totality of scientific evidence available to FD to it he ease able to believe that your product may be effective in diagnosing COV D-19 and that the known and potential benefits of your product when used for diagnosing COVID-19, outweigh the known and potential risks of your product, and
- 3. There is no adequate, approved, and available at mative to the emergency use of your product. ⁵

II. Scope of Authorization

I have concluded, pursuant to Section 4(d) 1) of the Act, that the scope of this authorization is limited to the indication above.

Authorized Product mils

Your product is smultiply sed nucleic acid test intended for the simultaneous qualitative detection and different ation or nacleic acids from multiple respiratory viral and bacterial organisms, including acleic acid from the SARS-CoV-2 virus, in nasopharyngeal swabs (NPS) obtained from individual suspected of COVID-19 by their healthcare provider.

The BioFire Respiratory Panel 2.1 (RP2.1) is intended for the detection and differentiation of nucleic acid from SARS-CoV-2 and the following organism types and subtypes identified using the BioFire RP2.1: Adenovirus, Coronavirus 229E, Coronavirus HKU1, Coronavirus NL63, Coronavirus OC43, Human Metapneumovirus, Human Rhinovirus/Enterovirus, Influenza A, including subtypes H1, H1-2009, and H3, Influenza B, Parainfluenza Virus 1, Parainfluenza Virus 2, Parainfluenza Virus 3, Parainfluenza Virus 4, Respiratory Syncytial *Virus, Bordetella*

parapertussis (IS1001), Bordetella pertussis (ptxP), Chlamydia pneumoniae, and Mycoplasma pneumoniae.

SARS-CoV-2 ribonucleic acid (RNA) and nucleic acids from the other respiratory viral and bacterial organisms identified by this test are generally detectable in NPS during the acute phase of infection. The detection and identification of specific viral and bacterial nucleic acids from individuals exhibiting signs and/or symptoms of respiratory infection is indicative of the presence of the identified microorganism and aids in the diagnosis of respiratory infection if used in conjunction with other clinical and epidemiological information. Positive results are indicative of the presence of the identified organism, but do not rule out co-infection with other pathogens. The agent(s) detected may not be the definite cause of disease.

Your product is authorized to test NPS specimens using the FilmArray 2.0 and the FilmArray Torch Systems, as outlined in the "BioFire Respiratory Panel 2.1 (RP2.1." instructions for use, or other authorized instrument systems, to be used in laboratories certificate under the Clinical Laboratory Improvement Amendments of 1988 (CLIA), 42 U.S.C. §2 3a, to perform high or moderate complexity tests.

ch Systems, or other Your product, when used with the FilmArray 2.0 and the Film Arr authorized instrument systems, automates all aspects of recleration including sample hair reaction (r CR) amplification using preparation, nucleic acid extraction and polymeras acids from multiple nested multiplex PCR, and detection and differentiation RS-CoV-2 virus, in a single-use respiratory viral and bacterial organisms, includ cartridge. The BioFire Respiratory Panel 2.1 ((P2.1)luces the following materials or other authorized materials: BioFire RP2.1 pouches, Sample Buffer ampoules, Single-use ngle-u pre-filled Hydration Injection Vials, Single Injection Vials, and individually packaged Transfer Pipettes.

Your product also includes in the capadge the following controls, or other authorized controls, that are processed along with the protein samples when tested with your product. The controls listed below must general expected results in order for a test to be considered valid, as outlined in the Instruction for Use

- RNA Process control targets an RNA transcript from the yeast *Schizosaccharomyces pombe*. The year is present in the pouch in a freeze-dried form and becomes rehydrated when sample is loaded. The control material is carried through all stages of the test process, including lysis, nucleic acid purification, reverse transcription, PCR1, dilution, PCR2, and DNA melting. A positive control result indicates that all steps carried out in the BioFire Respiratory Panel 2.1 (RP2.1) were successful.
- PCR2 Control detects a DNA target that is dried into wells of the array along with the corresponding primers. A positive result indicates that PCR2 was successful.

You also recommend use of the external positive and negative controls, to be run regularly as outlined in the instructions for use, described below. Your product also requires the use of additional authorized materials and authorized ancillary reagents that are not included with your product and are described in both sets of instructions for use, described below.

The above described product is authorized to be accompanied with labeling entitled, "BioFire Respiratory Panel 2.1 (RP2.1)" instructions for use (available at https://www.fda.gov/medical-devices/emergency-use-authorizations), together with the following product-specific information pertaining to the emergency use, is required to be made available to healthcare providers and patients:

- Fact Sheet for Healthcare Providers: BioFire Respiratory Panel 2.1 (RP2.1)
- Fact Sheet for Patients: BioFire Respiratory Panel 2.1 (RP2.1)

The above described product, when accompanied by the instructions for use (identified above) and the two Fact Sheets (referenced to as "authorized labeling") is authorized to be distributed to and used by authorized laboratories under this EUA, despite the fact that it does not meet certain requirements otherwise required by applicable federal law.

I have concluded, pursuant to Section 564(d)(2) of the Act, that it is resonable to believe that the known and potential benefits of your authorized product, when used for the qualitative detection of SARS-CoV-2 and used consistently with the Scope of Saraham on of this letter (Section II), outweigh the known and potential risks of your product.

I have concluded, pursuant to Section 564(d)(3) of the A α , based the totality of scientific evidence available to FDA, that it is reasonable to below the indication above, when used consistently with the State of Authorization of this letter (Section II), pursuant to Section 564(c)(2)(A) of the A α .

FDA has reviewed the scientific information as Table to FDA, including the information supporting the conclusions described in Section I above, and concludes that your product (as described in the Scope of Authorization 5th letter (Section II)) meets the criteria set forth in Section 564(c) of the Act concerning afety and potential effectiveness.

The emergency use the project under this EUA must be consistent with, and may not exceed, the terms of this later, including the Scope of Authorization (Section II) and the Conditions of Authorization IV). Subject to the terms of this EUA and under the circumstances set it is in the Secretary of HHS's determination under Section 564(b)(1)(C) described above and its Secretary of HHS's corresponding declaration under Section 564(b)(1), your product is authorized for the indication above.

This EUA will cease to be effective when the HHS declaration that circumstances exist to justify the EUA is terminated under Section 564(b)(2) of the Act or when the EUA is revoked under Section 564(g) of the Act.

III. Waiver of Certain Requirements

I am waiving the following requirements for your product during the duration of this EUA:

• Current good manufacturing practice requirements, including the quality system requirements under 21 CFR Part 820 with respect to the design, manufacture, packaging, labeling, storage, and distribution of your product.

IV. Conditions of Authorization

- D. You and authorized distribute (s) will inform authorized laboratories and relevant public health authorities of his UA, including the terms and conditions herein, and any updates hade you product, authorized labeling and authorized Fact Sheets.

- F. You and authorized distributor(s) will collect information on the performance of your product. You will report to FDA any suspected occurrence of false positive and false negative results and significant deviations from the established performance characteristics of the product of which you become aware.
- G. You and authorized distributor(s) are authorized to make available additional information relating to the emergency use of your product that is consistent with, and does not exceed, the terms of this letter of authorization.

- J. You may request to make available additional authorized labeling and fact sheets specific to an authorized distributor. Such additional labeling and fact sheets may use another name for the product, but otherwise must be consistent with the authorized labeling, and not exceed the terms of authorization of this letter. Such request will be made in consultation with, and require concurrence of, DMD/OHT7-OIR EQ/CDRH.
- K. You may request changes to the Scope of Authorization (Section II in the letter) of your product. Such requests will be made in consultation with a CDAUTE OIR/OPEQ/CDRH, and require concurrence of, Office of Counterterrorism and Emerging Threats (OCET)/Office of the Chief Scientis (OCS) office of the Commissioner (OC) and DMD/OHT7-OIR OPEC/CDR.
- L. You may request the addition of other instrument and associated software for use with your product. Such requests will be more in a psub-tion with, and require concurrence of, DMD/OHT7-OIR/OPEQ/CDRH.
- M. You may request the addition of othe specimen types for use with your product. Such requests will be made in consultation with, and require concurrence of, DMD/OHT7-OIR/OPEQ/CDRH.
- N. You may recrease e ad alon a d/or substitution of primers or probes for use with your product. Such red ests which made in consultation with, and require concurrence of, DMD/O1 57-OY 550/CDRH.
- O. You may request the addition and/or substitution of control materials for use with your product. Such requests will be made in consultation with, and require concurrence of, DMD/OHT7-OIR/OPEQ/CDRH.
- P. You may request the addition and/or substitution of other ancillary reagents and materials for use with your product. Such requests will be made in consultation with, and require concurrence of, DMD/OHT7-OIR/OPEQ/CDRH.
- Q. You will evaluate the analytical limit of detection and assess traceability⁷ of your product with any FDA-recommended reference material(s). After submission to FDA and DMD/OHT7-OIR/CDRH's review of and concurrence with the data, You will update labeling to reflect the additional testing. Such labeling updates will be made in

- consultation with, and require concurrence of, DMD/OHT7-OIR/OPEQ/CDRH.
- R. You will track adverse events, including any occurrence of false results and report to FDA under 21 CFR Part 803.

Authorized Laboratories

- S. Authorized laboratories using your product will include with test result reports, all authorized Fact Sheets. Under exigent circumstances, other appropriate methods for disseminating these Fact Sheets may be used, which may include mass media.
- T. Authorized laboratories using your product will use your product as outlined in the "BioFire Respiratory Panel 2.1 (RP2.1)" instructions for use. Deciations from the authorized procedures, including the authorized instruments, and the ed extraction methods, authorized clinical specimen types, authorized contrainmeter is, authorized other ancillary reagents and authorized materials required to us your product are not permitted.
- U. Authorized laboratories that receive your product will party the relevant public health authorities of their intent to run your product prio to init. It testing.
- V. Authorized laboratories using your product will have a process in place for reporting test results to healthcare providers and relevant put tic halth authorities, as appropriate.
- W. Authorized laboratories will collect informatic on the performance of your product and report to DMD/OHT7-OIR/OREQ/C VRH (via email: CDRH-EUA-Reporting@fda.hhs.gov) and you ort@BioFireDX.com) any suspected occurrence of false positive or false regarder results and significant deviations from the established performance characteristics of your product of which they become aware.
- X. All laboratory personnel using your product must be appropriately trained in performing and interpreting a late of your product, use appropriate personal protective equipment was handling this kit, and use your product in accordance with the authorized laborage.

- AA. No descriptive printed matter, including advertising or promotional material relating to the use of your product may represent or suggest that this test is safe or effective for the detection of SARS-CoV-2.
- BB. All advertising and promotional descriptive printed matter relating to the use of your product shall clearly and conspicuously state that:
 - This test has not been FDA cleared or approved;
 - This test has been authorized by FDA under an EUA for use by authorized laboratories;
 - This test has been authorized only for the detection an differentiation of nucleic acid of SARS-CoV-2 from multiple respiratory iral an organisms; and,
