I. Funding Opportunity Description

A. Background and Context

The Office of Energy Efficiency and Renewable Energy (EERE), on behalf of the Vehicle Technologies Office (VTO), is issuing a Funding Opportunity Announcement (FOA) entitled, “Fiscal Year 2024 Vehicle Technologies Office Program Wide Funding Opportunity Announcement”. The activities supported by this FOA are authorized under Public Law (P.L.) 109-58, the Energy Policy Act of 2005 (EPAAct 2005), as amended, Section 911 (codified at 42 U.S.C. § 16191).

Awards made under this announcement will fall under the purview of 2 CFR Part 200 as amended by 2 CFR Part 910.

i. Background and Purpose

This FOA supports the administration goals of building a clean and equitable energy economy and addressing the climate crisis which is a top priority of the Biden Administration. This FOA will advance transportation sector decarbonization to achieve the overall goal of economy-wide decarbonization by 2050. The Department of Energy is committed to pushing the frontiers of science and engineering, catalyzing clean energy jobs through research, development, demonstration, and deployment (RDD&D), and ensuring environmental justice and inclusion of underserved communities.

The research and development (R&D) activities to be funded under this FOA will support the government-wide approach to the climate crisis by driving the innovation and deploying clean transportation technologies, all while maintaining transportation service quality and safety.

ii. Technology Space and Strategic Goals

This funding opportunity announcement (FOA) seeks research projects to address priorities in the following areas: the increase in energy density of battery cells containing phosphate-based cathodes; the development of innovative technologies capable of significantly decreasing greenhouse gases; the production and manufacturing of new high-performance E-steels using domestic resources; the advancement of state of the art Na-ion batteries; the improvement of efficiency and convenience of the mobility-system using V2X; the development of planning tools and/or models to identify, quantify, and assess the impact of convenience strategies on regions and/or communities; addressing vulnerabilities and potential cybersecurity threats posed by the nature of EVs and charging infrastructure integrated with the grid, to improve fuel economy and reduce GHG emissions with the goals of carbon pollution free electricity by 2035 and net-zero of GHG emissions by 2050.

Area of Interest 1: Next Generation Phosphate-Based Cathodes

Introduction

The most common cathodes being used in commercial electric vehicles are lithium NMC due to their high specific energy and durability. Lithium Iron Phosphate (LFP, LiFePO₄) cathodes are currently gaining traction as an alternative low-cost solution because they don't contain any critical materials such as cobalt and nickel. The technology has demonstrated long cycle and calendar life as well as safety tolerance. However, LFP's energy density is limited due to its lower specific capacity and nominal voltage.

Objective

This area of interest (AOI) targets the development of phosphate-based cathode materials that surpass the performance of state-of-the-art LFP cathode materials. The primary objective of this area of interest is to develop high energy density battery cells containing phosphate-based cathodes at the material and cell level.

Additionally, the proposed material should strive to show powder and electrode coating scalability, processability and reproducibility for manufacturing as demonstrated by the delivery of high energy density cells. While improvements to the cathode material are desired, the cost target of the next-generation phosphate material should be comparable to industrial grade LFP. The proposed R&D plan should resolve challenges in developing much denser material than LFP, and with improved slurry quality resulting in enhanced electrode packing density and higher cell level energy density.

The targets for the cell performance are identified in the table below:

Anticipated technology approaches include, but are not limited to:

- Commercially available LMFP with an effort on improving processability and reproducibility of electrode manufacturing;
- High Mn content Lithium Manganese Iron phosphate (LMFP) cathode material; and
- Other novel phosphate cathode materials

General Requirements

1. Include plans to demonstrate increased energy density of next-generation Phosphate based cathode material compared to current state-of-the-art LiFePO4;
2. Include plans to demonstrate increased full cell performance of next-generation Phosphate based cathode compared to current state-of-the-art LiFePO4 full cells;
3. Identify the cell components' composition/construction with a focus on the next-generation Phosphate based material, but also describe and justify the choice of graphite anode material(s) and electrolyte solution(s) composition. The cathode composition/construction must be described;
4. Electrolyte stability should be addressed, but not studied as a main focal point of the proposed work;
5. Quantify and qualify electrode packing density, loading achieved and quality.
The following quality control tests are not exhaustive or restrictive:
 - a) Electrode flexibility when bent or wrapped around a mandrel;
 - b) Electrode adhesion;
 - c) Electrode camber;
 - d) Electrode resistivity;
 - e) Electrode cross section to evaluate packing density;
 - f) Electrode- to electrolyte wetting tests;
 - g) Slurry stability versus time (Ex: Identify slurry gelling issues).
6. Describe the materials and component optimization pathway that achieves cell performance requirements;
7. Demonstrate an understanding of the major issues and barriers impeding the use of the proposed cell chemistry, and how the particular barrier(s) will be overcome during the proposed project;

8. Identify performance targets that represent the highest risk for achievement during the project and the strategies to mitigate these risks;
9. Describe the testing and diagnostics to be performed to understand performance and life issues for the targeted active cathode material:
 - a) Indicate if data is from half-cells or paired with a graphite material;
 - b) Full cell data is preferred, however in the event only half-cell data is available coulombic efficiency must be included;
 - c) Include the electrode loading (mAh/cm²) of all cell performance data;
 - d) Indicate what temperature the experiments were performed at as well as the upper and lower voltage used for cycling the cell.
10. Include plans to annually participate in the VTO Annual Merit Review in Washington, DC and an annual U.S. DRIVE Electrochemical Energy Storage Technical Team Meeting in Southfield, MI;
11. For both the pulse power capabilities (PPCs) and partial charge carbon (PCCs), the cells delivered to DOE will be tested according to the protocol provided below:

*The thermal cycling protocol will be specified by the applicant in consultation with DOE.

Deliverables

In addition to the deliverables required in the Federal Assistance Reporting Requirements Checklist, the following deliverables are required for awards made under this topic:

1. Eighteen (18) PPCs of ≥500 mAh delivered to a to-be-designated DOE testing laboratory for performance testing at midpoint of the project length. Anode material is limited to graphite;
2. Eighteen (18) PCCs of ≥1 Ahr delivered to a to-be-designated DOE testing laboratory for performance testing at the end of the project. Anode material is limited to graphite;

3. Report and associated data resulting from at least thirty (30) days of PPC retained cell testing following test protocols approved by the DOE. This data will be shared with the testing lab;
4. Include plans to obtain at least 30 days of cycle life and calendar life (30°C and 50°C) test data from the retained cells prior to shipment of the deliverable cells to DOE;
5. Report associated data resulting from at least thirty (30) days of PCC retained cell testing following test protocols approved by the DOE. This data will be shared with the testing lab.

Note: All midpoint cell deliverables must be greater than 500mAh . All final cell deliverables must be greater than 1Ah. Deliverables with the highest capacity possible are strongly encouraged. It is acceptable to deliver cells that do not meet performance targets, as long as the cell components (electrodes with similar active material content, porosity, thickness, loading, etc. and separator thickness) in the delivered cells, when scaled to automotive size (40Ah or greater) are capable of meeting the targets: i.e., an applicant will not be penalized for packaging inefficiencies of small cells, but needs to deliver cells with automotive relevant electrodes, separators, and electrolyte volume.

All deliverable cells shall be provided to DOE for validation testing at a designated DOE National Laboratory. Non-Destructive Performance Validation testing will be conducted on the cells to validate performance. This testing will be conducted outside the Statement of Project Objectives (SOPO) for the cooperative agreement and therefore should not be addressed in the SOPO nor included in the total estimated project costs associated with the application. Test procedures for the delivered cells will be agreed to between the Applicant, the test lab, and the government. Participation by a DOE National Laboratory in test planning and execution will be addressed by a Nondisclosure Agreement (NDA) between the national laboratory and the end item manufacturer. Test procedures will be provided by the Applicant and shall incorporate specifications and limits supplied by the manufacturer for the specific technology such as voltage and current limits, state of charge, charging, temperature recommendations, number of test sequences, and/or other relevant test conditions as appropriate. The results of the DOE national laboratory testing may be documented in a publicly releasable Summary Test Report (approved by both DOE and the Applicant prior to release) that validates performance of the deliverables relative to the end item performance targets as well as the technology deployment impact relative to DOE strategic goals. The Summary Test Report will be approved by, and delivered to, DOE (Vehicle Technologies Office) and end item manufacturer. Test cells or special test equipment supplied by the end item manufacturer for the purposes of the test will be returned or disposed of at the conclusion of testing at no cost to the Applicant or the project.

Area of Interest 2: Na-ion Battery Seedling Projects for Electric Vehicle Applications**Introduction**

In 2022, Li-ion battery pack prices increased for the first time in a decade which was driven by price instability in key raw materials including lithium, nickel, and cobalt. While shifting to alternative cathode materials like lithium iron phosphate (LFP) can alleviate the impact of nickel and cobalt, the impact of lithium has not been adequately addressed. One alternative to lithium is sodium. Supply concerns with sodium are drastically reduced given it is over 1,000 times more abundant than lithium in the Earth's crust and over 100,000 times more abundant in the oceans. The United States is particularly well situated for the adoption of sodium due to producing 14.5% of sodium chloride (salt) globally and 68.8% of natural sodium carbonate (soda ash) globally. Recently, Na-ion batteries have shown favorable performance metrics and with additional R&D could match the performance of commercialized LFP chemistries. These advancements when coupled with potential cost and safety improvements present a promising new chemistry that could reduce the electric vehicle (EV) sector's dependence on lithium. The US would further benefit from a diversification of battery technology that would prove to be resilient toward future market and supply chain disruptions as well as the continued electrification of society.

While there is much promise for Na-ion chemistries, key issues still limit their adoption. On the anode side, hard carbon is the material of choice, but inconsistent material processing has led to high variability in performance. Layered oxides are the dominate cathode due to their similarity with Li-ion cathodes, but these materials display sloping and step voltage-profile features that lead to reduced energy density and performance. For the electrolyte, poor SEI forming characteristics limit the ability to protect the active material surfaces leading to a decline in performance.

Objective

This objective of this area of interest is to advance the state of the art for Na-ion batteries by solving key challenges for the cathode, anode, or electrolyte through the development of 1 Ah full cells utilizing cell chemistries that are significant advancements over current industry state-of-the-art Na-ion technology.

General Requirements

Proposed work should address at least one of the key areas of cathode, anode, or electrolyte development in high energy full cell systems that rival commercial LFP systems. Electrode development should look to address challenges with sloping and step-voltage profiles in materials that have well-defined sodiation mechanisms. Electrolyte development should focus on SEI formation while maintaining high safety performance. Material development should put emphasis on utilizing low cost, non-critical materials without supply chain concerns as much as possible.

All proposals must:

1. Identify the cell components' composition/construction and describe and justify the choice of cathode/anode material(s) including conductive components, catalysts (if any), binder, and electrolyte composition;
2. Identify major issues impeding the proposed cell chemistry and the specific barriers to be overcome during the research effort to reach the deliverable targets for energy density and cycle life;
3. Describe how the proposed effort is different than past and current research efforts;
4. Include supporting theoretical predictions and/or relevant experimental data supporting performance claims;
5. Indicate if data is from half-cells or paired with a relevant cathode/anode; full cell data is preferred, however in the event only half cell data is available coulombic efficiency must be included:
 - a. Include the electrode loading (mAh/cm² and mg/cm²) and composition (weight %), and electrolyte loading (μL/mg) and electrolyte composition of all cell performance data; and
 - b. Indicate what temperature the experiments were performed at as well as the upper and lower voltage and the c-rate for cycling the cell.
6. Identify performance targets that represent the highest risk for achievement during the project and the strategies to mitigate these risks;

7. The cell specific energy milestone of this topic is 160 Wh/kg, but to remain competitive with phosphate cathodes in Li-ion cells, higher energy densities will be required. Detail a viable strategy to achieve 190 Wh/kg or higher through improvements to cell design such as lean electrolyte formulations, high electrode loadings, etc. that is compatible with the materials and design that will be pursued to meet the 160 Wh/kg deliverable;
 8. Describe the testing and diagnostics planned to characterize, investigate, and mitigate issues; and
 9. Go-No Go decision points based on internal full cell test results demonstrating progress towards final targets must be included in the SOPO.

Deliverables

1. Five ≥ 1 Ah cells meeting the above requirements to be delivered to DOE for independent testing; and
2. At least one month of testing data for all deliverable cell builds will be carried out by the Applicant following test protocols approved by the DOE. This data will be shared with DOE and the testing lab prior to deliverable shipment to the testing laboratory.

Note: All cell deliverables must be greater than 1 Ah. It is acceptable to deliver cells that do not meet performance targets, as long as the cell components (electrodes with similar active material content, porosity, thickness, loading, etc. and separator thickness) in the delivered cells, when scaled to automotive size (40Ah or greater) are capable of meeting the targets. An applicant will not be penalized for packaging inefficiencies of small cells, but needs to deliver cells with automotive relevant electrodes, separators, and electrolyte volume. If the deliverable cells do not meet performance targets, a model validating the proposed scaling factors will also be required for final cells.

All cells shall be provided to the DOE for validation testing at a to-be-designated DOE National Laboratory. Non-Destructive Performance Validation testing will be conducted on the cells to validate performance. This testing will be conducted outside the scope of the proposed project and should not be included in the total estimated project costs included with the application. Participation by a DOE National Laboratory in test planning and execution will be addressed by a Non-Disclosure Agreement (NDA) between the National Laboratory and the Applicant.

Test procedures will be provided by the Applicant and shall incorporate specifications and limits supplied by the manufacturer for the specific technology such as voltage and current limits, state of charge, charging, and temperature recommendations, number of test sequences, and/or other relevant test conditions as appropriate. The results of the DOE national laboratory testing may be documented in a publicly releasable Summary Test Report (approved by both DOE and the Applicant prior to release) that validates performance of the deliverables relative

Applications utilizing cathode active materials with cobalt, lithium, or high nickel content (>60%); sodium metal anodes; or solid-state electrolytes.

Area of Interest 3: Low-GHG Concepts for Off-Road Vehicles

Introduction

Off-road vehicles used for industry and agriculture consume more than 2 quadrillion BTUs of energy. They are a substantial source of greenhouse gases (GHG) and criteria emissions, including nitrogen oxides and fine particulate matter that contribute to poor air quality. Off-road vehicles have unique requirements for durability, power/torque density, daily run times, and operation in remote and harsh locations. These requirements are typically met by using compression-ignition engines running on diesel fuel and fluid-power systems (hydraulics) for the work and/or drive circuits. Fluid power systems utilize throttling for control, which leads to low over-all efficiency. Deep reductions in the GHG emissions from these vehicles can be achieved by partial or full vehicle electrification or by using renewable fuels including hydrogen.

Objective

The objective of the topic area is to develop and validate technology concepts capable of significantly decreasing GHGs, energy use, harmful criteria emissions, and total cost of ownership across the entire off-road vehicle sector, including construction, agriculture, mining, forestry, ports, warehouses, etc. Concepts must demonstrate they can meet the unique requirements for off-road vehicles and gain customer acceptance.

Approaches may include, but are not limited to:

- Technologies that reduce GHG emissions through increased utilization of low-carbon fuels including hydrogen, propane, natural gas, and dimethyl ether, and by partial or full vehicle electrification while meeting prevailing criteria emissions standards and maintaining similar durability to current off-road vehicles;
- Technologies that represent a breakthrough in the efficiency of fluid power systems and are widely applicable across the off-road sector;
- Technologies which address specific barriers (*e.g.*, impacts on fuel injection equipment/aftertreatment systems, material/component selections for hydrogen combustion engines, powertrain hybridization, etc.) to utilizing a low-carbon fuel that is, or will be, widely available;
- Technologies which greatly increase the efficiency of compression ignition engines used in off-road vehicles when operating on low-carbon fuels;
- Technologies that automate vehicle operation and/or movements to maximize their efficiency.

General Requirements

Applications **must**:

1. Include an estimate of the applicability of the proposed technology across the off-road sector;
2. Include an estimate of efficiency improvement and/or GHG reduction when compared to the baseline off-road sector vehicle;
3. Include an estimate of criteria emissions impacts;

4. Include a cost analysis of the proposed technologies that justifies any claimed reduction in the total cost of ownership;
 5. Include an explanation of how durability, manufacturability and customer acceptance will be evaluated; and
 6. Include a detailed test plan, including duty cycle, to demonstrate the benefit of the developed technology, the plan should consist of two phases:
 - Phase 1 – Technology Development: (Not to exceed two budget periods) This phase should culminate in a Go/No-Go milestone that provides a proof-of-concept and validation of the new technology leading to GHG and criteria emissions improvement.
 - Phase 2 – Demonstration: (At least one budget period), this phase should include integration of the technology and demonstration of the GHG reduction benefits on a test-bed that can simulate the relevant duty-cycles (regulatory and/or real world), or on a vehicle.
 7. Include a plan for participation in the VTO Annual Merit Review, typically held in Washington, DC.

Teaming Arrangements

Applicant teams are encouraged to include an off-road vehicle Original Equipment Manufacturer (OEM) and/or Tier 1 supplier.

Area of Interest 4: Saving Energy with Connectivity

Introduction

Research has shown that vehicle-to-everything (V2X) communications can lead to meaningful energy savings at the vehicle and transportation system level by integrating interoperable vehicle-to-vehicle (V2V), vehicle-to-infrastructure (V2I), and vehicle-to-pedestrian (V2P) communications.^{1,2,3} Energy savings can be achieved with interoperable, cooperative messaging in a system with advanced driver assist, autonomous systems, and human operated vehicles.

Historically, there has been uncertainty about the timeline for deployment of this technology, which stalled market adoption. Now that there has been some clarity on the use of the safety spectrum (e.g., 30 MHz within the 5.9 GHz spectrum), and that the technology platform will include Long-Term Evolution (LTE) Cellular-V2X (LTE C-V2X),⁴ the time has come to accelerate the deployment of interoperable V2X connectivity to save energy and enhance safety.

In October 2023, the U.S. Department of Transportation (DOT) released a draft deployment plan (“[Savings Lives with Connectivity: A Plan to Accelerate V2X Deployment](#)”) with short-, medium-, and long-term goals and targets to achieve interoperable connectivity at a national scale. The plan was accompanied by a [Notice of Funding Opportunity](#) (NOFO) to accelerate funding and investment to deploy this technology to enhance safety. This draft deployment plan and NOFO complements other DOT grant programs including [Strengthening Mobility and Revolutionizing Transportation \(SMART\)](#) and [Advanced Transportation Technology and Innovation \(ATTAIN\)](#) grant programs to improve transportation efficiency and safety. As part of a whole-of-government approach, the Energy Efficient Mobility Systems’ (EEMS’) AOI 4 supports and is aligned with DOT’s efforts.

By making a push now for national interoperable connectivity, the U.S. will lay the foundation to invest in infrastructure and systems to save energy, reduce congestion, enhance safety, and modernize fleets to provide improved vehicle and traffic integration. This will save energy and enhance safety of the near-term vehicle fleet, and will also achieve energy, environmental, and safety benefits as the overall vehicle fleet becomes more automated. For example, adaptive cruise control (ACC) has been shown to increase fuel consumption on average across the fleet, unless paired with V2X communications of the vehicles which provides additional energy savings to both the connected and surrounding vehicles.⁵

Objective

The objective of Area of Interest 4 is to develop and deploy V2X technologies with a focus on the efficiency and convenience of the mobility ecosystem, while reducing transportation's environmental impacts. Examples could include but are not limited to: eco-driving along connected corridors, transit or freight priority, integrated corridor management, or passenger or freight trip-chaining optimization.⁶

To realize the benefits of interoperable connectivity with V2X, the use of the foundational set of messages, such as the basic safety message (BSM), signal phase and timing (SPaT), and map data (MAP) is required.⁷ Additional application-specific message sets may be necessary for achieving the intended energy and environmental benefits. When combined, these message sets will inform vehicles and traffic management centers in real-time to achieve greater safety and system efficiencies and could be used for future analysis and system planning.

C-V2X communication devices employed under this FOA must be interoperable; this means that in-vehicle, infrastructure, roadside, and other devices must be able to communicate ubiquitously, efficiently, and securely regardless of the variety of the make or model of devices. Research may include simulation and hardware testing of complex V2X communications, including bandwidth and latency requirements in various settings, and culminate in the deployment of hardware in settings controlled by State and local governments, serving as a model for deployment by other Metropolitan Planning Organizations (MPOs), tribes, local agencies, or States. Research should leverage current and past connected vehicle work with recognition of current standards and/or specifications in progress.

General Requirements

Applications must:

1. Proposals to this FOA must include a real-world field testing or early deployment and should address long-term operations and maintenance of the deployed systems;
2. Deployments must exhibit cybersecure awareness within their technologies and systems; and should demonstrate an understanding of threat mitigation technology;
3. Proposals must include mixed fleets in at least one of the following attributes: powertrain, automation, connectivity, or vehicle class. Battery electric vehicles are encouraged;
4. Proposals must define project baseline and greenhouse gas emissions (especially given COVID-19 disruptions to both time series);

5. Proposals must describe attributes of the vehicles used in the deployment – for example, level of automation (SAE Levels 0 – 5)⁸ and class of connectivity (SAE Class A-D)⁹, classes of vehicles, and the powertrain technology;
 6. Deployments must include a form of interoperable V2X connectivity¹⁰ that uses either:
 - a. C-V2X using PC5 mode (direct communication with vehicles or infrastructure, as described in the SAE J3161 family of standards) in the 5.9 GHz band;
 - b. Cellular Uu mode (communications are transmitted through a cellular network, either 4G or 5G);
 - c. Unlicensed Wi-Fi;
 - d. Satellite;
 - e. Other emerging options such as ultra-wideband (with appropriate technical description about how it would work); or
 - f. Any combination of the above.The type of wireless communications and its security to be used should be clearly specified. When using the C-V2X PC5 communications, use of the IEEE 1609.2.1 security credential management is required.
 7. Proposals must include and describe community engagement activities including partnerships that result in community-driven strategic plans that define community goals and strategies for reducing mobility system carbon emissions and/or pollution (e.g., listening session, needs assessment, or strategic planning discussions);
 8. Applications and services employed in research or deployments are encouraged to address disparities in transportation equity;
 9. Proposals must quantify the expected energy, mobility, and/or affordability benefits that would result from the deployment of the technology to be developed, supported by analysis, modeling, or simulation results as appropriate;
 10. Proposals must describe how data generated by the project will quantify the energy, mobility, environmental, affordability and equity gains that result from the proposed technology, describe which metrics will be used, and how the project team will share this data with DOE and its National Laboratories through the Livewire Data Platform (<https://livewire.energy.gov>);
 11. Proposals must describe how they will document the detailed benefits gained and costs incurred throughout the project and share with DOE;
 12. Proposals must describe the project outreach plan to communicate results, including lessons learned, best practices, cost and benefits, and case studies, to educate the broader transportation community;

13. Proposals must include a plan for participation in the Annual Merit Review held in Washington DC;
 14. Proposals must describe the Intelligent Transportation Systems (ITS) or other standards or specifications that will be implemented, and will further describe how the research and/or lessons learned in deployment will be documented to inform the US DOE and DOT about the gaps in standards or specifications, identify any new messages sets developed and used to address the gaps during the project, or document other information that can lead to the adaption of existing standards or development of new standards;
 15. Proposals must include plans to provide input to the VTO Annual Report.

Teaming Arrangements

Applicant teams must include a local agency or state agency or other entity (e.g., university) with authority to approve an on-road demonstration of the technology. Partnerships with OEMs and Mobile Network Operators (MNOs) are encouraged to ensure industry acceptance, which is needed for large scale deployment. Solutions need to be interoperable across platforms, so they have the potential to be scaled.

Deliverables

1. Recipients will work with the DOE Technology Manager to provide all relevant modeling, testing, and validation data produced in the project validation and deployment phase to the to the EEMS Livewire Data Platform (<https://livewire.energy.gov>) in a timely manner. Data that the project teams do not wish to be made public will be protected through a Non-Disclosure Agreement with the relevant DOE National Laboratories;
2. Recipients must include a plan to participate in the VTO Annual Merit Review (AMR) in Washington, D.C.; and
3. Recipients must include a plan to provide report on annual project accomplishments for inclusion in the VTO Annual Accomplishments Report.

Applications Discouraged

1. Applications that are primarily about procurement or straightforward implementation of existing technologies.
2. Applications that do not clearly identify the mobility or environmental technology solution to be developed and implemented and the required partnering team members will not be considered for participation.

Area of Interest 5: Domestically Produced E-Steels

Introduction

The US transportation sector is in a technology revolution where light-duty vehicles are rapidly transitioning from internal combustion engines to electrified powertrains. Although most of the vehicles are produced in the US, many of the powertrain components rely on imports and foreign supply chains. Of particular interest are traction motors and their components.

The rotors and stators in high efficiency traction motors are currently produced with thin layers of steel separated by insulating layers to form a laminate. The thinner a layer of steel can be, the less eddy current will be induced, and higher efficiencies can be obtained. To ensure optimal performance, tight tolerances must be maintained on gauge uniformity and the sheet must be free of waviness and wrinkles.

To ensure that the US fully benefits from the transition to electrified powertrains, high-performance E-steels must be developed that can be completely produced and manufactured using domestic resources. The E-steels developed under this AOI will have improved ductility and magnetic properties while maintaining cost parity with current materials.

Objective

The objective of this Area of Interest is to develop E-Steels meeting the properties below:

Attribute	Target
Frequency	>400 Hz
Core loss	<6 w/lb at 400 Hz
Thickness	<0.4 mm
Ductility	>15%
Cost	≤ current E-steels
Manufacturability	Compatible with existing supply chain processing techniques
Sheet uniformity	Less than 10% thickness deviation over laminate dimensions

Fully integrated teams are sought which include basic material production through traction motor manufacturing that can develop cost competitive high-performance traction motors in the United States for the US transportation industry.

General Requirements

Applications must:

1. Identify a commercial E-steel baseline;
2. Propose to meet or exceed the above targets;
3. Include laminate production at a thickness relevant for traction motors with minimal losses;
4. Describe material opportunities in secondary markets:

- a. Target properties (Hz, core loss, permeability, coercivity, resistivity) must be specified at the relevant frequencies and cost targets based on existing supply chains; and
 - b. Team members with capabilities and experience in those markets along with the scale up facilities requirements.
5. For existing low TRL materials, the proposal must provide the measured properties and the technological pathway to achieve opportunity objectives; and
 6. Proposals must provide a technology commercialization plan that provides a clear pathway from performance validation to high volume market penetration. Planned mechanisms to obtain any required capital investment should be articulated in the commercialization plan.

Teaming Arrangements

Applicant teams **must** include team members capable of moving the technology from laboratory scale validation, to processing validation, component level validation, and demonstrate the material in a traction motor.

Deliverables

In addition to the deliverables required in the Federal Assistance Reporting Requirements Checklist, VTO will require recipients to participate in the EERE Annual Merit Review (AMR) in Washington, D.C.

Applications Discouraged

- Applications that are based on hypothetical concepts that are not supported by data from the existing team;
- Applications which do not meet the technical, cost, and manufacturability metrics above;
- Applicant teams which do not include advisory team members capable of moving the technology from laboratory scale validation, to processing validation, component level validation, and demonstrate the material in a traction motor.

Area of Interest 6: Cybersecurity for Smart and Secure Electric Vehicle Charging

Introduction

The rapid adoption of Electric Vehicles (EVs) and build-out of necessary charging infrastructure can benefit society by enhancing the resilience and efficiency of the electric grid. Electric vehicles can provide a wide range of grid services since the majority of the time EVs are parked and not charging, which offers much more flexibility in the timing and the power level of electricity use than a traditional load.

The Department of Energy (DOE) has funded significant efforts to ensure that the benefit of EVs to the grid is realized by developing tools and strategies for proper and effective Vehicle Grid Integration (VGI). While the benefits of VGI are significant, it introduces vulnerabilities and potential cybersecurity threats posed by the nature of EVs and charging infrastructure integrated with the grid. To address this issue, the DOE has funded EV charging cybersecurity research and development activities for more than a decade. While these activities have been very successful in addressing critical needs, the ever-changing threat landscape requires continued attention. Two needs have emerged as being critically important to address:

1. The rapidly increasing numbers of EVs in the US will soon lead to a new market for businesses to aggregate large numbers of EVs and bid grid services to the electricity sector. Ensuring aggregation is done in a cybersecure way is critical to the operations of both the transportation and electricity sectors.
2. There is a significant need for the development and deployment of tools to assess the cybersecurity posture and compliance with standards and protocols of EVs, electric vehicle supply equipment (EVSE), and charging systems.

Objective

The DOE's Vehicle Technologies Office (VTO) and the Office of Cybersecurity, Energy Security, and Emergency Response (CESER) are joining together to address these pressing cybersecurity needs through the two subtopics below:

6a- Enabling Wide-scale, Cybersecure EV/EVSE Aggregation for Grid Services

Introduction

To support the integration of electric vehicles (EVs) and their charging requirements with the electric grid, both government and the private sector have made significant investments in the development of smart charge management (SCM) systems and technologies for EV charging infrastructure. While the development of these prototype SCM technologies has largely proven successful, they have limited functionality and have targeted applications to a narrow set of stakeholders (e.g., utilities) within the EV charging ecosystem. To achieve the full potential of SCM and grid services within the context of other distributed energy resources (DERs) such as solar and behind-the-meter-storage, the roles and integration of all relevant stakeholders (e.g., utilities/distribution system operators [DSOs], independent system operators [ISOs], aggregators, charging network operators [CNOs], charge point operators [CPOs], and related suppliers) must be considered. The evolution and transition of DOE-supported technologies, as well as the development of new, innovative technologies and systems, are needed to enable and implement cybersecure SCM in real world DSO/ISO environments. Comprehensive, broadly applicable, and scalable SCM technology is a key enabler for the wide scale, aggregation of EVs needed to maximize the benefits of grid services and to reduce grid impacts.

Objective

The objective of this subtopic is to research, develop, and demonstrate systems, technologies, and tools necessary for the cybersecure aggregation of EVs and charging infrastructure to provide widescale, cybersecure grid services. Technology requirements should be considered for the installation and continued monitoring of cybersecure systems. Projects should assess cybersecurity vulnerabilities across current and future projected EV aggregation scenarios with regards to communications and power management, identify technology needs, and develop solutions. Comprehensive consideration should be given to vulnerabilities across the entire EV charging ecosystem from the EV/DER, EV/EVSE interface, EVSE itself, within the charging station, backend systems, and communication and control with aggregators and the grid. Cyber control and monitoring tools shall be developed and implemented to enable all relevant stakeholders to conduct cyber self-assessments.

General Requirements

Applications must:

1. Describe the technology requirements for installation and continued monitoring of cybersecure systems;
2. Describe the systems, technologies, and tools to be developed and the proposed advancements over state of the art;
3. Describe the plan to assess cybersecurity vulnerabilities across current and future projected EV aggregation scenarios with regards to communications and power management;
4. Describe the plan to identify technology needs and develop solutions based on the cybersecurity vulnerabilities, including vulnerabilities across the entire EV charging

- ecosystem from the EV/DER, EV/EVSE interface, EVSE itself, within the charging station, backend systems, and communication and control between aggregators and the grid;
5. Describe the cyber control and monitoring tools which will be developed;
 6. Describe how the tools will be implemented to provide all relevant stakeholders the ability to conduct cyber self-assessments;
 7. Describe the proposed advancements of the technology relative to currently available tools;
 8. Identify all team members and their role in the project;
 9. Describe the plan to conduct a demonstration validating the development and implementation of technologies and systems for cyber compliance and monitoring for representative EV aggregation scenarios.
 10. Proposals must describe the project outreach plan to communicate results, including lessons learned, best practices, cost and benefits, and case studies, to educate the broader EV charging community.

Teams are highly encouraged to include utilities, charging equipment manufacturers, and vehicle OEMs.

6b – Tools to Assess EV/EVSE/Charging System Cybersecurity Posture and Compliance with Standards and Protocols for Communications, Controls, and Monitoring

Introduction

Testing and evaluation of Electric Vehicle Supply Equipment (EVSE) by DOE national laboratories has clearly indicated a lack of compliance by many vendors with certified and/or regulated EV charging standards and protocols. In addition to creating cybersecurity vulnerabilities, this non-compliance greatly inhibits interoperability, supplier-managed smart charge management (SCM), and right-to-repair. Relevant standards and protocols to consider include, but are not necessarily limited to ISO 15118, ISO 15118-2, and ISO 15118-20; IEEE 1547; Open Charge Point Protocol (OCPP); IEEE 2030.5 and 2030.13; and Open Automated Demand Response (OpenADR).

Consideration should also be given to the awareness and adherence to NIST recommendations for installation and lifelong cybersecurity including 1) the NIST Framework for Improving Critical Infrastructure Cybersecurity, 2) Cybersecurity Framework Profile for Electric Vehicle Extreme Fast Charging (XFC) Infrastructure, and 3) NISTIR 7628 Rev 1: Guidelines for Smart Grid Cybersecurity.

Objective

The objective of this subtopic is to research, develop, and validate a suite of tools and associated procedures to comprehensively assess EV/EVSE/charging system compliance with relevant standards and protocols and cybersecurity posture.

Projects should define gaps in tool availability, identify the tool requirements, and develop the appropriate tools.

Tools developed under this sub-topic should:

- Emphasize testing and measurement of compliance with the cybersecurity aspects of relevant standards and protocols and enable cyber self-assessment by stakeholders;
- Span the EV charging ecosystem from the EV/DER, EV/EVSE interface, EVSE itself, within the charging station, backend systems, and communication and control with aggregators and the grid;
- Include those relevant to the EV/DER and EVSE, as well as station architectures, networks, Apps, telematics, and connection with aggregators and the grid, with additional consideration given to cybersecurity for internal/external data management and device cyber-physical security;
- Incorporate robust future proofing to enable adaptation to future evolutions in standards and protocol development.

General Requirements

Applications must:

1. Describe how tools will be implemented to assess EV/EVSE/Charging System Cybersecurity Posture and Compliance with standards and protocols;
2. Describe the plan for testing and evaluation of Electric Vehicle Supply Equipment (EVSE);
3. Describe the plan for adherence to NIST recommendations for installation and lifelong cybersecurity;
4. Describe the standards and protocols able to be tested by the developed tools and the extent to which they will be able to evaluate the standards and protocols;
5. Identify all team members and their role in the project;
6. Describe the virtual and/or real-life demonstration within the lab or network systems to validate applicability and functionality of tools developed;
7. Describe the plan for the demonstration to convincingly show the ability for stakeholders to accurately and conveniently test and measure cybersecurity compliance of EV/EVSE/charging systems with standards and protocols;
8. Describe how the tools emphasize testing and measurement of compliance with the cybersecurity aspects of relevant standards and protocols and enable cyber self-assessment by stakeholders;
9. Describe how the tools are relevant to the EV/DER and EVSE, as well as station architectures, networks, Apps, telematics, and connection with aggregators and the grid, with additional consideration given to cybersecurity for internal/external data management and device cyber-physical security;
10. Describe the approach for future proofing the tools to enable adaptation to future evolutions in standards and protocol development;
11. Describe how the tools span the EV charging ecosystem from the EV/DER, EV/EVSE interface, EVSE itself, within the charging station, backend systems, and communication and control with aggregators and the grid.

Teaming Arrangements

Teams are highly encouraged to include at least one entity knowledgeable in communications, controls, standards, and testing of EVs and EVSE as a team member.

As part of this whole of government approach, this FOA seeks to encourage the participation of underserved communities¹³ and underrepresented groups. As part of the application, applicants are required to describe how diversity, equity, and inclusion objectives will be incorporated in the project. Specifically, applicants are required to submit a Diversity, Equity, and Inclusion Plan that describes the actions the applicant will take to foster a welcoming and inclusive environment, support people from underrepresented groups in STEM, advance equity, and encourage the inclusion of individuals from these groups in the project; and the extent the project activities will be located in or benefit underserved communities. The plan should include at least one SMART (Specific, Measurable, Assignable, Realistic and Time-Related) milestone per budget period supported by metrics to measure the success of the proposed actions. This plan will be evaluated as part of the technical review process and incorporated into the award if selected.

Regardless of these arrangements, the entity that applied as the prime recipient for the project will remain the prime recipient for the project. See Section III.E.

III. Eligibility Information

To be considered for substantive evaluation, an applicant's submission must meet the criteria set forth below. If the application does not meet these eligibility requirements, it will be considered ineligible and removed from further evaluation.

The National Energy Technology Laboratory is ineligible to participate as a prime applicant or as a team member/sub-recipient on any application because of their role in developing the requirements for this announcement.

A. Eligible Applicants

i. Domestic Entities

The proposed prime recipient and subrecipient(s) must be domestic entities. The following types of domestic entities are eligible to participate as a prime recipient or subrecipient of this FOA:

1. Institutions of higher education;
2. For-profit entities;
3. Nonprofit entities; and
4. State and local governmental entities and federally recognized Indian Tribes (Indian Tribes).

To qualify as a domestic entity, the entity must be organized, chartered, or incorporated (or otherwise formed) under the laws of a particular state or

territory of the United States; have majority domestic ownership and control; and have a physical place of business in the United States.

DOE/NNSA FFRDCs are eligible to apply for funding as a subrecipient but are not eligible to apply as a prime recipient.

Non-DOE/NNSA FFRDCs are eligible to participate as a subrecipient but are not eligible to apply as a prime recipient.

Federal agencies and instrumentalities (other than DOE) are eligible to participate as a subrecipient but are not eligible to apply as a prime recipient.

Entities banned from doing business with the U.S. government such as entities debarred, suspended, or otherwise excluded from or ineligible for participating in federal programs are not eligible.

Nonprofit organizations described in Section 501(c)(4) of the Internal Revenue Code of 1986 that engaged in lobbying activities after December 31, 1995, are **not** eligible to apply for funding.

ii. Foreign Entities

In limited circumstances, EERE may approve a waiver to allow a foreign entity to participate as a prime recipient or subrecipient. A foreign entity may submit a Full Application to this FOA, but the Full Application must be accompanied by an explicit written waiver request. Likewise, if the applicant seeks to include a foreign entity as a subrecipient, the applicant must submit a separate explicit written waiver request in the Full Application for each proposed foreign subrecipient.

Appendix C lists the information that must be included in a foreign entity waiver request. The applicant does not have the right to appeal EERE's decision concerning a waiver request.

To help applicants calculate proper cost share amounts, EERE has included a cost share information sheet and sample cost share calculation as Appendices A and B to this FOA.

i. Legal Responsibility

Although the cost share requirement applies to the entire project, including work performed by members of the project team other than the prime recipient, the prime recipient is legally responsible for paying the entire cost share. If the funding agreement is terminated prior to the end of the project period, the prime recipient is required to contribute at least the cost share percentage of total expenditures incurred through the date of termination.

The prime recipient is solely responsible for managing cost share contributions by the project team and enforcing cost share obligation assumed by project team members in subawards or related agreements.

ii. Cost Share Allocation

Each project team is free to determine how best to allocate the cost share requirement among the team members. The amount contributed by individual project team members may vary, as long as the cost share requirement for the entire project is met.

iii. Cost Share Types and Allowability

Every cost share contribution must be allowable under the applicable federal cost principles, as described in Section IV.I.i. of the FOA. In addition, cost share must be verifiable upon submission of the Full Application. Cost share may be provided in the form of cash or cash equivalents, or in-kind contributions. Cost share must come from non-federal sources (unless otherwise allowed by law), such as project participants, state or local governments, or other third-party financing. Federal financing, such as DOE Loan Guarantee, cannot be leveraged by applicants to provide the required cost share or otherwise support the same scope that is proposed under a project.

Cost share may be provided by the prime recipient, subrecipients, or third parties (entities that do not have a role in performing the scope of work). Vendors/contractors may not provide cost share. Any partial donation of goods or services is considered a discount and is not allowable.

Cash contributions include but are not limited to personnel costs, fringe costs, supply and equipment costs, indirect costs, and other direct costs.

In-kind contributions are those where a value of the contribution can be readily determined, verified, and justified but where no actual cash is transacted in securing the good or service comprising the contribution. Allowable in-kind contributions include but are not limited to the donation of volunteer time or the donation of space or use of equipment.

Project teams may use funding or property received from state or local governments to meet the cost share requirement, so long as the federal government did not provide the funding to the state or local government.

The recipient may not use the following sources to meet its cost share obligations:

- Revenues or royalties from the prospective operation of an activity beyond the project period;
- Proceeds from the prospective sale of an asset of an activity;
- Federal funding or property (e.g., federal grants, equipment owned by the federal government); or
- Expenditures that were reimbursed under a separate federal program.

Project teams may not use the same cash or in-kind contributions to meet cost share requirements for more than one project or program.

Cost share contributions must be specified in the project budget, verifiable from the prime recipient's records, and necessary and reasonable for proper and efficient accomplishment of the project. As all sources of cost share are considered part of total project cost, the cost share dollars will be scrutinized under the same federal regulations as federal dollars to the project. Every cost share contribution must be reviewed and approved in advance by the Contracting Officer and incorporated into the project budget before the expenditures are incurred.

Applicants are encouraged to refer to 2 CFR 200.306 as amended by 2 CFR 910.130 for additional cost sharing requirements.

iv. Cost Share Contributions by FFRDCs

Because FFRDCs are funded by the federal government, costs incurred by FFRDCs generally may not be used to meet the cost share requirement. FFRDCs may

contribute cost share only if the contributions are paid directly from the contractor's Management Fee or another non-federal source.

v. Cost Share Verification

Applicants are required to provide written assurance of their proposed cost share contributions in their Full Applications.

Upon selection for award negotiations, applicants are required to provide additional information and documentation regarding their cost share contributions. Please refer to Appendix A of the FOA.

vi. Cost Share Payment

DOE requires prime recipients to contribute the cost share amount incrementally over the life of the award. Specifically, the prime recipient's cost share for each billing period must always reflect the overall cost share ratio negotiated by the parties (i.e., the total amount of cost sharing on each invoice when considered cumulatively with previous invoices must reflect, at a minimum, the cost sharing percentage negotiated). As FFRDC funding will be provided directly to the FFRDC(s) by DOE, prime recipients will be required to provide project cost share at a percentage commensurate with the FFRDC costs, on a budget period basis, resulting in a higher interim invoicing cost share ratio than the total award ratio.

In limited circumstances, and where it is in the government's interest, the Contracting Officer may approve a request by the prime recipient to meet its cost share requirements on a less frequent basis, such as monthly or quarterly. Regardless of the interval requested, the prime recipient must be up to date on cost share at each interval. Such requests must be sent to the Contracting Officer during award negotiations and include the following information: (1) a detailed justification for the request; (2) a proposed schedule of payments, including amounts and dates; (3) a written commitment to meet that schedule; and (4) such evidence as necessary to demonstrate that the prime recipient has complied with its cost share obligations to date. The Contracting Officer must approve all such requests before they go into effect.

Applicants are strongly encouraged to submit their Concept Papers and Full Applications at least 48 hours in advance of the submission deadline. Under normal conditions (i.e., at least 48 hours before the submission deadline), applicants should allow at least one hour to submit a Concept Paper or Full Application. Once the Concept Paper or Full Application is submitted in EERE eXCHANGE, applicants may revise or update that submission until the expiration of the applicable deadline. If changes are made to any of these documents, the applicant must resubmit the Concept Paper or Full Application before the applicable deadline. EERE will not extend the submission deadline for applicants that fail to submit required information by the applicable deadline due to server/connection congestion.

D. Responsiveness Criteria

All “Applications Specifically Not of Interest,” as described in Section I.C. of the FOA, are deemed nonresponsive and are not reviewed or considered.

E. Other Eligibility Requirements

i. Requirements for DOE/NNSA and Non-DOE/NNSA FFRDCs Included as a Subrecipient

DOE/NNSA and non-DOE/NNSA FFRDCs may be proposed as a subrecipient on another entity’s application subject to the following guidelines:

- a. Authorization for non-DOE/NNSA FFRDCs
The federal agency sponsoring the FFRDC must authorize in writing the use of the FFRDC on the proposed project and this authorization must be submitted with the application. The use of a FFRDC must be consistent with its authority under its award.
- b. Authorization for DOE/NNSA FFRDCs
The cognizant Contracting Officer for the FFRDC must authorize in writing the use of the FFRDC on the proposed project and this authorization must be submitted with the application. The following wording is acceptable for this authorization:

Authorization is granted for the Laboratory to participate in the proposed project. The work proposed for the Laboratory is

consistent with or complementary to the missions of the Laboratory and will not adversely impact execution of the DOE assigned programs at the Laboratory.

c. Funding, Cost Share, and Subaward with FFRDCs

The value of and funding for the FFRDC portion of the work will not normally be included in the award. DOE/NNSA FFRDCs participating as a subrecipient on a project will be funded directly through the DOE field work proposal (WP) process. Non-DOE/NNSA FFRDCs participating as a subrecipient will be funded through an interagency agreement with the sponsoring agency. Although the FFRDC portion of the work is excluded from the award, the applicant's cost share requirement will be based on the total cost of the project, including the applicant's, the subrecipient's, and the FFRDC's portions of the project.

Unless instructed otherwise by the DOE Contracting Officer for the DOE award, all FFRDCs are required to enter into a Cooperative Research and Development Agreement¹⁸ (CRADA) or, if the role of the DOE/NNSA FFRDC is limited to technical assistance and intellectual property is not anticipated to be generated from the DOE/NNSA FFRDC's work, a Technical Assistance Agreement (TAA), with at least the prime recipient before any project work begins. Any questions regarding the use of a CRADA or TAA should be directed to the cognizant DOE field intellectual property (IP) counsel.

The CRADA or TAA is used to ensure accountability for project work and provide the appropriate management of IP, e.g., data protection and background IP. The CRADA or TAA must be agreed upon by all parties and submitted to DOE or other sponsoring agency, when applicable, for approval, or submitted to DOE for notice under the Master Scope of Work process, when applicable, using any DOE or other sponsoring agency approved CRADA or TAA template without substantive changes by the time the award is made to the prime recipient.

The applicant should prepare the budgets using rates appropriate for funding the FFRDCs through subawards. The applicant's cost share requirement will be based on the total cost of the project, including the applicant's, the subrecipient's, and the FFRDC's portions of the project.

d. Responsibility

The prime recipient will be the responsible authority regarding the settlement and satisfaction of all contractual and administrative issues including but not limited to disputes and claims arising out of any agreement between the prime recipient and the FFRDC.

e. Limit on FFRDC Effort

The FFRDC effort, in aggregate, shall not exceed 25% of the total estimated cost of the project, including the applicant's and the FFRDC's portions of the effort.

F. Limitation on Number of Concept Papers and Full Applications Eligible for Review

An entity may submit more than one Concept Paper and Full Application to this FOA, provided that each application describes a unique, scientifically distinct project and an eligible Concept Paper was submitted for each Full Application.

G. Questions Regarding Eligibility

EERE will not make eligibility determinations for potential applicants prior to the date on which applications to this FOA must be submitted. The decision whether to apply in response to this FOA lies solely with the applicant.

IV. Application and Submission Information

A. Application Process

The application process includes multiple submission phases: Concept Paper and Full Application. **Only applicants who have submitted an eligible Concept Paper will be eligible to submit a Full Application.**

All submissions must conform to the form and content requirements described below, including maximum page lengths.

- Each must be submitted in Adobe PDF format unless stated otherwise;
- Each must be written in English;
- All pages must be formatted to fit on 8.5" x 11" paper with margins not less than one inch on every side. Use Calibri typeface, a black font color, and a font size of 12-point or larger (except in figures or tables, which may be 10-point font). A symbol font may be used to insert Greek letters or special characters, but the font size requirement still applies. References must be included as footnotes or endnotes in a font size of 10 or larger. Footnotes and endnotes are counted toward the maximum page requirement;

iv. Resumes

A resume provides information reviewers can use to evaluate an individual’s skills, experience, and potential for leadership within the scientific community. Applicants must submit a resume (limited to three pages) for each Principal Investigator and Senior/Key Personnel that includes the following:

1. Contact information;
2. Education and training: Provide name of institution, major/area, degree, and year for undergraduate, graduate, and postdoctoral training;
3. Research and professional experience: Beginning with the current position, list professional/academic positions in chronological order with a brief description. List all current academic, professional, or institutional appointments, foreign or domestic, at the applicant institution or elsewhere, whether or not remuneration is received, and, whether full-time, part-time, or voluntary;
4. Awards and honors;

5. A list of up to 10 publications most closely related to the proposed project. For each publication, identify the names of all authors (in the same sequence in which they appear in the publication), the article title, book or journal title, volume number, page numbers, year of publication, and website address if available electronically. Patents, copyrights, and software systems developed may be provided in addition to or substituted for publications. An abbreviated style such as the Physical Review Letters (PRL) convention for citations (list only the first author) may be used for publications with more than 10 authors;
6. Synergistic activities: List up to five professional and scholarly activities related to the proposed effort; and
7. There should be no lapses in time over the past 10 years or since age 18, whichever period is shorter.

As an alternative to a resume, it is acceptable to use the biographical sketch format approved by the National Science Foundation (NSF). The biographical sketch format may be generated by the Science Experts Network Curriculum Vita (SciENCv), a cooperative venture maintained at <https://www.ncbi.nlm.nih.gov/sciencv/>, also available at https://www.nsf.gov/bfa/dias/policy/researchprotection/commonform_biographicalsketch.pdf. The use of a format required by another agency is intended to reduce the administrative burden to researchers by promoting the use of common formats.

v. Letters of Commitment

Submit letters of commitment from all subrecipient and third-party cost share providers. The following information for each third party contributing to cost sharing should be identified: (1) the name of the organization; (2) the proposed dollar amount to be provided; and (3) the proposed cost sharing type (cash-or in-kind contributions). Each letter must not exceed one page.

limit the choice of reasonable alternatives prior to EERE completing the NEPA review process.

EERE does not guarantee or assume any obligation to reimburse pre-award costs incurred prior to receiving written authorization from the Contracting Officer. If the applicant elects to undertake activities that DOE determines may have an adverse effect on the environment or limit the choice of reasonable alternatives prior to receiving such written authorization from the Contracting Officer, the applicant is doing so at risk of not receiving federal funding for their project and such costs may not be recognized as allowable cost share. Nothing contained in the pre-award cost reimbursement regulations or any pre-award costs approval letter from the Contracting Officer overrides the requirement to obtain the written authorization from the Contracting Officer prior to taking any action that may have an adverse effect on the environment or limit the choice of reasonable alternatives. Likewise, if an application is selected for negotiation of award, and the prime recipient elects to undertake activities that are not authorized for federal funding by the Contracting Officer in advance of EERE completing a NEPA review, the prime recipient is doing so at risk of not receiving federal funding and such costs may not be recognized as allowable cost share.

iii. Performance of Work in the United States (Foreign Work Waiver)

1. Requirement

All work performed under EERE awards must be performed in the United States. The prime recipient must flow down this requirement to its subrecipients.

2. Failure to Comply

If the prime recipient fails to comply with the Performance of Work in the United States requirement, EERE may deny reimbursement for the work conducted outside the United States and such costs may not be recognized as allowable recipient cost share. The prime recipient is responsible should any work under this award be performed outside the United States, absent a waiver, regardless of whether the work is performed by the prime recipient, subrecipients, contractors or other project partners.

3. Waiver

To seek a foreign work waiver, the applicant must submit a written waiver request to EERE. [Appendix C lists the information that must be included in a request for a foreign work waiver.](#)

Save the waiver request(s) in a single PDF file. The applicant does not have the right to appeal EERE's decision concerning a waiver request.

iv. Construction

Recipients are required to obtain written authorization from the Contracting Officer before incurring any major construction costs.

v. Foreign Travel

If international travel is proposed for your project, please note that your organization must comply with the International Air Transportation Fair Competitive Practices Act of 1974 (49 USC 40118), commonly referred to as the "Fly America Act," and implementing regulations at 41 CFR 301-10.131 through 301-10.143. The law and regulations require air transport of people or property to, from, between, or within a country other than the United States, the cost of which is supported under this award, to be performed by or under a cost-sharing arrangement with a United States flag carrier, if service is available. Foreign travel costs are allowable only with the written prior approval of the Contracting Officer assigned to the award.

vi. Equipment and Supplies

To the greatest extent practicable, all equipment and products purchased with funds made available under this FOA should be American-made. This requirement does not apply to used or leased equipment.

vii. Build America Buy America Requirements for Infrastructure Projects

Pursuant to the Build America Buy America Act, subtitle IX of BIL (Buy America, or BABA), federally assisted projects that involve infrastructure work, undertaken by applicable recipient types, require that:

- All iron, steel, and manufactured products used in the infrastructure work are produced in the United States; and
- All construction materials used in the infrastructure work are manufactured in the United States.

Whether a given project must apply this requirement is project-specific and dependent on several factors, such as the recipient's entity type, whether the work involves "infrastructure," as defined in Section 70914 of the BIL, and whether the infrastructure in question is publicly owned or serves a public function.

Applicants are strongly encouraged to consult Appendix D of this FOA to determine whether their project may have to apply this requirement, both to make an early determination as to the need of a waiver, as well as to determine what impact, if any, this requirement may have on the proposed project's budget.

Please note that, based on implementation guidance from the Office of Management and Budget issued on April 18, 2022, the Buy America requirements of the BIL do not apply to DOE projects in which the prime recipient is a for-profit entity; the requirements only apply to projects whose prime recipient is a "non-Federal entity," e.g., a State, local government, Indian Tribe, Institution of Higher Education, or nonprofit organization. Subawards should conform to the terms of the prime award from which they flow; in other words, for-profit prime recipients are not required to flow down these Buy America requirements to subrecipients, even if those subrecipients are non-Federal entities as defined above. Conversely, prime recipients which are non-Federal entities must flow the Buy America requirements down to all subrecipients, even if those subrecipients are for-profit entities. Finally, for all applicants—both non-Federal entities and for-profit entities—DOE is including a Program Policy Factor that the Selection Official may consider in determining which Full Applications to select for award negotiations that considers whether the applicant has made a commitment to procure U.S. iron, steel, manufactured products, and construction materials in its project.

The DOE financial assistance agreement will require each recipient to: (1) fulfill the commitments made in its application regarding the procurement of U.S.-produced products and (2) fulfill the commitments made in its application regarding the procurement of other key component metals and domestically manufactured products that are deemed available in sufficient and reasonably available quantities or of a satisfactory quality at the time of award negotiation. Applicants may seek waivers of these requirements in very limited circumstances and for good cause shown. Further details on requesting a waiver can be found in Appendix D and the terms and conditions of an award.

Applicants are strongly encouraged to consult Appendix D for more information.

viii. Lobbying

Recipients and subrecipients may not use any federal funds to influence or attempt to influence, directly or indirectly, congressional action on any legislative or appropriation matters.

Recipients and subrecipients are required to complete and submit SF-LLL, "Disclosure of Lobbying Activities"

(<https://www.grants.gov/web/grants/forms/sf-424-individual-family.html>) to ensure that non-federal funds have not been paid and will not be paid to any person for influencing or attempting to influence any of the following in connection with the application:

- An officer or employee of any federal agency;
- A Member of Congress;
- An officer or employee of Congress; or
- An employee of a Member of Congress.

ix. Risk Assessment

Pursuant to 2 CFR 200.206, DOE will conduct an additional review of the risk posed by applications submitted under this FOA. Such risk assessment will consider:

1. Financial stability;
2. Quality of management systems and ability to meet the management standards prescribed in 2 CFR 200 as amended and adopted by 2 CFR 910;
3. History of performance;
4. Audit reports and findings; and
5. The applicant's ability to effectively implement statutory, regulatory, or other requirements imposed on non-federal entities.

DOE may make use of other publicly available information and the history of an applicant's performance under DOE or other federal agency awards.

Depending on the severity of the findings and whether the findings were resolved, DOE may elect not to fund the applicant.

In addition to this review, DOE must comply with the guidelines on government-wide suspension and debarment in 2 CFR 180 and must require non-federal entities to comply with these provisions. These provisions restrict federal awards, subawards and contracts with certain parties that are debarred, suspended, or otherwise excluded from or ineligible for participation in federal programs or activities.

Further, as DOE invests in critical infrastructure and funds critical and emerging technology areas, DOE also considers possible threats to United States research, technology, and economic security from undue foreign government influence when evaluating risk. If high risks are identified and cannot be sufficiently mitigated, DOE may elect to not fund the applicant.

x. Invoice Review and Approval

DOE employs a risk-based approach to determine the level of supporting documentation required for approving invoice payments. Recipients may be required to provide some or all of the following items with their requests for reimbursement:

- Summary of costs by cost categories;
- Timesheets or personnel hours report;
- Invoices/receipts for all travel, equipment, supplies, contractual, and other costs;
- UCC filing proof for equipment acquired with project funds by for-profit recipients and subrecipients;
- Explanation of cost share for invoicing period;
- Analogous information for some subrecipients; and
- Other items as required by DOE.

xi. Prohibition Related to Foreign Government-Sponsored Talent Recruitment Programs**a. Prohibition**

Persons participating in a *Foreign Government-Sponsored Talent Recruitment Program of a Foreign Country of Risk* are prohibited from participating in projects selected for federal funding under this FOA. Should an award result from this FOA, the recipient must exercise ongoing due diligence to reasonably ensure that no individuals participating on the DOE-funded project are participating in a *Foreign Government-Sponsored Talent Recruitment Program of a Foreign Country of Risk*. Consequences for violations of this prohibition will be determined according to applicable law, regulations, and policy. Further, the recipient must notify DOE within five (5) business days upon learning that an individual on the project team is or is believed to be participating in a foreign government talent recruitment program of a foreign country of risk. DOE may modify and add requirements related to this prohibition to the extent required by law.

b. Definitions

- 1. Foreign Government-Sponsored Talent Recruitment Program.** An effort directly or indirectly organized, managed, or funded by a foreign government, or a foreign government instrumentality or entity, to recruit science and technology professionals or students (regardless of citizenship or national origin, or whether having a full-time or part-time position). Some foreign government-sponsored talent recruitment programs operate with the intent to import or otherwise acquire from abroad, sometimes through illicit means, proprietary technology or

software, unpublished data and methods, and intellectual property to further the military modernization goals and/or economic goals of a foreign government. Many, but not all, programs aim to incentivize the targeted individual to relocate physically to the foreign state for the above purpose. Some programs allow for or encourage continued employment at United States research facilities or receipt of federal research funds while concurrently working at and/or receiving compensation from a foreign institution, and some direct participants not to disclose their participation to U.S. entities. Compensation could take many forms including cash, research funding, complimentary foreign travel, honorific titles, career advancement opportunities, promised future compensation, or other types of remuneration or consideration, including in-kind compensation.

2. **Foreign Country of Risk.** DOE has designated the following countries as foreign countries of risk: Iran, North Korea, Russia, and China. This list is subject to change.

xii. Affirmative Action and Pay Transparency Requirements

All applicants must comply with all applicable federal labor and employment laws, including but not limited to Title VII of the Civil Rights Act of 1964, the Fair Labor Standards Act, the Occupational Safety and Health Act, and the National Labor Relations Act, which protects employees' right to bargain collectively and engage in concerted activities for the purpose of workers' mutual aid or protection.

All federally assisted construction contracts exceeding \$10,000 annually will be subject to the requirements of Executive Order 11246:

- (1) Recipients, subrecipients, contractors, and subcontractors are prohibited from discriminating in employment decisions on the basis of race, color, religion, sex, sexual orientation, gender identity, or national origin.
- (2) Recipients and contractors are required to take affirmative action to ensure that equal opportunity is provided in all aspects of their employment. This includes flowing down the appropriate language to all subrecipients, contractors, and subcontractors.
- (3) Recipients, subrecipients, contractors, and subcontractors are prohibited from taking adverse employment actions against applicants and employees for asking about, discussing, or sharing information about their pay or, under certain circumstances, the pay of their co-workers.

DOL's Office of Federal Contractor Compliance Programs (OFCCP) uses a neutral process to schedule compliance evaluations. xiii. Foreign Collaboration Considerations

- b. Existing collaborations with foreign entities and governments. The recipient will be required to provide DOE with a written list of all existing foreign collaborations in which has entered in connection with its DOE-funded award scope.
- c. Description of collaborations that should be reported. In general, a collaboration will involve some provision of a thing of value to, or from, the recipient. A thing of value includes but may not be limited to all resources made available to, or from, the recipient in support of and/or related to the DOE award, regardless of whether or not they have monetary value. Things of value also may include in-kind contributions (such as office/laboratory space, data, equipment, supplies, employees, students). In-kind contributions not intended for direct use on the DOE award but resulting in provision of a thing of value from or to the DOE award must also be reported. Collaborations do not include routine workshops, conferences, use of the recipient's services and facilities by foreign investigators resulting from its standard published process for evaluating requests for access, or the routine use of foreign facilities by awardee staff in accordance with the recipient's standard policies and procedures.

V. Application Review Information

A. Technical Review Criteria

i. Concept Papers

Concept Papers are evaluated based on consideration the following factors. All sub-criteria are of equal weight.

Concept Paper Criterion: Overall FOA Responsiveness and Viability of the Project (Weight: 100%)

This criterion involves consideration of the following factors:

- The applicant clearly describes the proposed technology, how the technology is unique and innovative, and how the technology will advance the current state of the art;
- The applicant has identified risks and challenges of the technology, regulatory and financial aspects of the proposal including possible mitigation strategies, and has shown the impact that EERE funding and the proposed project would have on the relevant field and application;
- The applicant has the qualifications, experience, capabilities, and other resources necessary to complete the proposed project; and
- The proposed work, if successfully accomplished, would clearly meet the objectives as stated in the FOA.

ii. Full Applications

Applications will be evaluated against the technical review criteria shown below. All sub-criteria are of equal weight.

Criterion 1: Technical Merit, Innovation, and Impact (50%)

This criterion involves consideration of the following factors:

Technical Merit and Innovation

- Extent to which the proposed technology, process, or project is innovative or replicable;
- Degree to which the current state of the technology and the proposed advancement are clearly described;
- Extent to which the application specifically and convincingly demonstrates how the applicant will move the state of the art to the proposed advancement;
- Sufficiency of technical detail in the application to assess whether the proposed work is scientifically meritorious and revolutionary, including

relevant data, calculations, and discussion of prior work, with analyses that support the viability of the proposed work;

- Extent to which project has buy-in from needed stakeholders to ensure success;
- Degree to which key manufacturing and supply chain challenges are considered;
- Extent to which project has the potential to reduce emissions and provide clean energy acceleration benefits for a community or region; and

Impact of Technology Advancement

- Ability of the project to advance industry adoption;
- Extent to which the project supports the area of interest objectives and target specifications and metrics;
- Potential impact of the project on advancing the state of the art;

Project Management

- Adequacy of proposed project management systems including the ability to track scope, cost, and schedule progress and changes;
- Reasonableness of budget and spend plan as detailed in the budget justification workbook for proposed project and objectives;
- Adequacy, reasonableness, and soundness of the project schedule, as well as periodic Go/No-Go decisions prior to further funds disbursement, interim milestones, and metrics to track process;
- Adequacy, reasonableness, and soundness of the project schedule, as well as annual Go/No-Go decisions prior to a budget period continuation application, interim milestones, and metrics to track process.

Criterion 2: Project Research and Market Transformation Plan (25%)

This criterion involves consideration of the following factors:

Research Approach, Workplan, and SOPO

- Degree to which the approach and critical path have been clearly described and thoughtfully considered; and
- Degree to which the task descriptions are clear, detailed, timely, and reasonable, resulting in a high likelihood that the proposed Workplan and SOPO will succeed in meeting the project goals.

Identification of Technical Risks

- Discussion and demonstrated understanding of the key technical risk areas involved in the proposed work and the quality of the mitigation strategies to address them.

Baseline, Metrics, and Deliverables

- Level of clarity in the definition of the baseline, metrics, and milestones; and
- Relative to a clearly defined project baseline, the strength of the quantifiable metrics, milestones, and mid-point deliverables defined in the application, such that meaningful interim progress will be made.

Market Transformation Plan

- Identification of target market, competitors, and distribution channels for proposed technology along with known or perceived barriers to market penetration, including mitigation plan; and
- Comprehensiveness of market transformation plan including but not limited to product development and/or service plan, commercialization timeline, financing, product marketing, legal/regulatory considerations including intellectual property, infrastructure requirements and product distribution.

Criterion 3: Team and Resources (15%)

This criterion involves consideration of the following factors:

- Capability of the Principal Investigator(s) and the proposed team to address all aspects of the proposed work with a high probability of success. The qualifications, relevant expertise, and time commitment of the individuals on the team;
- Diversity of expertise and perspectives of the team and the inclusion of industry partners that will amplify impact;
- Sufficiency of the facilities to support the work;
- Level of participation by project participants as evidenced by letter(s) of commitment and how well they are integrated into the Workplan; and
- Reasonableness of the budget and spend plan for the proposed project and objectives.

Criterion 4: Diversity, Equity, and Inclusion (10%)

This criterion involves consideration of the following factors:

- The quality and manner in which the measures incorporate diversity, equity and inclusion goals in the project; and
- Extent to which the project benefits underserved communities.

B. Standards for Application Evaluation

Applications that are determined to be eligible will be evaluated in accordance with this FOA, by the standards set forth in EERE's Notice of Objective Merit Review Procedure (76 Fed. Reg. 17846, March 31, 2011) and the guidance provided in the "DOE Merit Review Guide for Financial Assistance," effective September 2020, which is available at: <https://energy.gov/management/downloads/merit-review-guide-financial-assistance-and-unsolicited-proposals-current>.

C. Other Selection Factors

i. Program Policy Factors

In addition to the above criteria, the Selection Official may consider the following program policy factors in determining which Full Applications to select for award negotiations:

- The degree to which the proposed project exhibits technological diversity when compared to the existing DOE project portfolio and other projects selected from the subject FOA;
- The degree to which the proposed project, including proposed cost share, optimizes the use of available EERE funding to achieve programmatic objectives;
- The level of industry involvement and demonstrated ability to accelerate commercialization and overcome key market barriers;
- The degree to which the proposed project will accelerate transformational technological advances in areas that industry by itself is not likely to undertake because of technical and financial uncertainty;
- The degree to which the proposed project, or group of projects, represent a desired geographic distribution (considering past awards and current applications);
- The degree to which the proposed project incorporates applicant or team members from Minority Serving Institutions (e.g., Historically Black Colleges and Universities (HBCUs)/Other Minority Institutions (OMIs)); and partnerships with Minority Business Enterprises, minority-owned businesses, woman-owned businesses, veteran-owned businesses, or Indian Tribes; and
- The degree to which the proposed project will employ procurement of U.S. iron, steel, manufactured products, and construction materials;
- The degree to which the proposed project contributes to the diversity of organizations and organization types and sizes selected from the subject FOA when compared to the existing DOE project portfolio;
- The degree to which the proposed project has broad public support from the communities most directly impacted by the project;
- The degree to which the proposed project avoids duplication/overlap with other publicly or privately funded work;
- The degree to which the proposed project supports complementary efforts or projects, which, when taken together, will best achieve the research goals and objectives;
- The degree to which the proposed project enables new and expanding market segments;

- The degree to which the project’s solution or strategy will maximize deployment or replication;
 - The degree to which the project promotes increased coordination with nongovernmental entities for demonstration of technologies and research applications to facilitate technology transfer.

D. Evaluation and Selection Process

i. Overview

The evaluation process consists of multiple phases; each includes an initial eligibility review and a thorough technical review. Rigorous technical reviews of eligible submissions are conducted by reviewers that are experts in the subject matter of the FOA. Ultimately, the Selection Official considers the recommendations of the reviewers, along with other considerations such as program policy factors, in determining which applications to select.

ii. Pre-Selection Clarification

EERE may determine that pre-selection clarifications are necessary from one or more applicants. Pre-selection clarifications are distinct from and less formal than pre-selection interviews. These pre-selection clarifications will solely be for the purposes of clarifying the application. The pre-selection clarifications may occur before, during or after the merit review evaluation process. Information provided by an applicant that is not necessary to address the pre-selection clarification question will not be reviewed or considered. Typically, a pre-selection clarification will be carried out through either written responses to EERE’s written clarification questions or video or conference calls with EERE representatives.

The information provided by applicants to EERE through pre-selection clarifications is incorporated in their applications and contributes to the merit review evaluation and EERE’s selection decisions. If EERE contacts an applicant for pre-selection clarification purposes, it does not signify that the applicant has been selected for negotiation of award or that the applicant is among the top ranked applications.

EERE will not reimburse applicants for expenses relating to the pre-selection clarifications, nor will these costs be eligible for reimbursement as pre-award costs.

iii. Recipient Responsibility and Qualifications

DOE, prior to making a federal award with a total amount of federal share greater than the simplified acquisition threshold, is required to review and

consider any responsibility and qualification information about the applicant that is in the entity information domain in [SAM.gov](https://sam.gov) (see 41 U.S.C. 2313).

The applicant, at its option, may review information in the entity information domain in [SAM.gov](https://sam.gov) and comment on any information about itself that a federal awarding agency previously entered and is currently in the entity information domain in [SAM.gov](https://sam.gov).

DOE will consider any written comments by the applicant, in addition to the other information in the entity information domain in [SAM.gov](https://sam.gov), in making a judgment about the applicant's integrity, business ethics, and record of performance under federal awards when completing the review of risk posed by applicants as described in 2 CFR 200.206.

iv. Selection

The Selection Official may consider the technical merit, the Federal Consensus Board's recommendations, program policy factors, and the amount of funds available in arriving at selections for this FOA.

E. Anticipated Notice of Selection and Award Negotiation Dates

EERE anticipates notifying applicants selected for negotiation of award and negotiating awards by the dates provided on the cover page of this FOA.

VI. Award Administration Information

A. Award Notices

i. Ineligible Submissions

Ineligible Concept Papers and Full Applications will not be further reviewed or considered for award. The Contracting Officer will send a notification letter by email to the technical and administrative points of contact designated by the applicant in EERE eXCHANGE. The notification letter will state the basis upon which the Concept Paper or the Full Application is ineligible and not considered for further review.

ii. Concept Paper Notifications

EERE will notify applicants of its determination to encourage or discourage the submission of a Full Application. EERE will post these notifications to EERE eXCHANGE. EERE may include general comments provided from reviewers on an applicant's Concept Paper in the encourage/discourage notifications.

Applicants may submit a Full Application even if they receive a notification discouraging them from doing so. By discouraging the submission of a Full Application, EERE intends to convey its lack of programmatic interest in the proposed project. Such assessments do not necessarily reflect judgments on the merits of the proposed project. The purpose of the Concept Paper phase is to save applicants the considerable time and expense of preparing a Full Application that is unlikely to be selected for award negotiations.

A notification encouraging the submission of a Full Application does not authorize the applicant to commence performance of the project.

iii. Full Application Notifications

EERE will notify applicants of its determination via a notification letter by email to the technical and administrative points of contact designated by the applicant in EERE eXCHANGE. The notification letter will inform the applicant whether or not its Full Application was selected for award negotiations. Alternatively, EERE may notify one or more applicants that a final selection determination on particular Full Applications will be made at a later date, subject to the availability of funds or other factors.

iv. Applicants Selected for Award Negotiations

Successful applicants will receive written notification that they have been selected for award negotiations. Receipt of a notification letter selecting a Full Application for award negotiations does not authorize the applicant to commence performance of the project. If an application is selected for award negotiations, it is not a commitment by EERE to issue an award nor is it a guarantee of federal government funding. Applicants do not receive an award unless and until award negotiations are complete and the Contracting Officer executes the funding agreement, accessible by the prime recipient in FedConnect.

The award negotiation process will take approximately 60 days. Applicants must designate a primary and a backup point-of-contact in EERE eXCHANGE with whom EERE will communicate to conduct award negotiations. The applicant must be responsive during award negotiations (i.e., provide requested documentation) and meet the negotiation deadlines. If the applicant fails to do so or if award negotiations are otherwise unsuccessful, EERE will cancel the award negotiations and rescind the Selection. v. Alternate Selection Determinations

In some instances, an applicant may receive a notification that its application was not selected for award and EERE designated the application to be an alternate. As an alternate, EERE may consider the Full Application for federal funding in the future. A notification letter stating the Full Application is designated as an alternate does not authorize the applicant to commence performance of the project. EERE may ultimately determine to select or not select the Full Application for award negotiations.

vi. Unsuccessful Applicants

EERE shall promptly notify in writing each applicant whose application has not been selected for award or whose application cannot be funded because of the unavailability of appropriated funds.

ii. Award Administrative Requirements

vii. Flood Resilience

The base floodplain long used for planning has been the 100-year floodplain, which has a 1% chance of flooding in any given year. As directed by Executive Order 13690, Establishing a Federal Flood Risk Management Standard and a Process for Further Soliciting and Considering Stakeholder Input (2015), federal agencies, including DOE, must continue to avoid development in a floodplain to the extent possible. ix. Statement of Federal Stewardship

xiii. Reporting

A Go/No-Go Review is a risk management tool and a project management best practice to ensure that, for the current phase or period of performance, technical success is definitively achieved and potential for success in future phases or periods of performance is evaluated, prior to beginning the execution of future phases. At the Go/No-Go decision points, EERE will evaluate project performance, project schedule adherence, meeting milestone objectives, compliance with reporting requirements, and overall contribution to the program goals and objectives. Federal funding beyond the Go/No-Go decision point (continuation funding) is contingent upon (1) availability of federal funds appropriated by Congress for the purpose of this program; (2) the availability of future-year budget authority; (3) recipient's technical progress compared to the Milestone Summary Table stated in Attachment 1 of the award; (4) recipient's submittal of required reports; (5) recipient's compliance with the terms and conditions of the award; (6) EERE's Go/No-Go decision; (7) the recipient's submission of a continuation application;²¹ and (8) written approval of the continuation application by the Contracting Officer.

As a result of the Go/No-Go Review, DOE may, at its discretion, authorize the following actions: (1) continue to fund the project, contingent upon the availability of funds appropriated by Congress for the purpose of this program and the availability of future-year budget authority; (2) recommend redirection of work under the project; (3) place a hold on federal funding for the project, pending further supporting data or funding; or (4) discontinue funding the project because of insufficient progress, change in strategic direction, or lack of funding.

The Go/No-Go decision is distinct from a non-compliance determination. In the event a recipient fails to comply with the requirements of an award, EERE may take appropriate action, including but not limited to, redirecting, suspending, or terminating the award.

and they shall provide notice that the recipient's title to all equipment (not real property) purchased with federal funds under the financial assistance agreement is conditional pursuant to the terms of this section, and that the government retains an undivided reversionary interest in the equipment. The UCC financing statement(s) must be filed before the Contracting Officer may reimburse the recipient for the federal share of the equipment unless otherwise provided for in the relevant financial assistance agreement. The recipient shall further make any amendments to the financing statements or additional recordings, including appropriate continuation statements, as necessary or as the Contracting Officer may direct.

xvii. Real Property and Equipment

Real property and equipment purchased with project funds (federal share and recipient cost share) are subject to the requirements at 2 CFR 200.310, 200.311, 200.313, and 200.316 (non-federal entities, except for-profit entities) and 2 CFR 910.360 (for-profit entities).

For projects selected for awards under this FOA, the recipients may (1) take disposition action on the real property and equipment; or (2) continue to use the real property and equipment after the conclusion of the award period of performance with Contracting Officer approval. The recipient's written request for Continued Use must identify the property and include: a summary of how the property will be used (must align with the authorized project purposes); a proposed use period, (e.g., perpetuity, until fully depreciated, or a calendar date when the recipient expects to submit disposition instructions); acknowledgement that the recipient shall not sell or encumber the property or permit any encumbrance without prior written DOE approval; current fair market value of the property; and an estimated useful life or depreciation schedule for equipment.

A primary objective of DOE's multi-billion-dollar research, development and demonstration investments is to cultivate new research and development ecosystems, manufacturing capabilities, and supply chains for and by United States industry and labor. Therefore, in exchange for receiving taxpayer dollars to support an applicant's project, the applicant and any subrecipient and contractor must agree to a U.S. Competitiveness provision requiring that any products embodying any subject invention or produced through the use of any subject invention will be manufactured substantially in the United States unless the recipient can show to the satisfaction of DOE that it is not commercially feasible. Provision in order to change the scope of the requirements or to provide more specifics on the application of the requirements for a particular technology. As another example, the entity may request that the U.S. Competitiveness Provision be waived in lieu of a net benefits statement or United States manufacturing plan. The statement or plan would contain specific and enforceable commitments that would be beneficial to the United States economy and competitiveness. Examples of such commitments could include manufacturing specific products in the United States, making a specific investment in a new or existing United States manufacturing facility, keeping certain activities based in the United States or supporting a certain number of jobs in the United States related to the technology. DOE may, in its sole discretion, determine that the proposed modification or waiver promotes commercialization and provides substantial United States economic benefits, and grant the request. If granted, DOE will modify the award terms and conditions for the requesting entity accordingly.

recipient must include all financial conflicts of interest (FCOI) (i.e., managed and unmanaged/ unmanageable) in its initial and ongoing FCOI reports.

It is understood that non-federal entities and individuals receiving DOE financial assistance awards will need sufficient time to come into full compliance with DOE's interim COI Policy. To provide some flexibility, DOE allows for a staggered implementation. Specifically, prior to award, applicants selected for award negotiations must: ensure all Investigators complete their significant financial disclosures; review the disclosures; determine whether a FCOI exists; develop and implement a management plan for FCOIs; and provide DOE with an initial FCOI report that includes all FCOIs (i.e., managed and unmanaged/ unmanageable). Recipients will have 180 days from the date of the award to come into full compliance with the other requirements set forth in DOE's interim COI Policy. B. Government Right to Reject or Negotiate

EERE reserves the right, without qualification, to reject any or all applications received in response to this FOA and to select any application, in whole or in part, as a basis for negotiation and/or award.

C. Commitment of Public Funds

The Contracting Officer is the only individual who can make awards or commit the government to the expenditure of public funds. A commitment by anyone other than the Contracting Officer, either express or implied, is invalid.

D. Treatment of Application Information

Applicants should not include trade secrets or business-sensitive, proprietary, or otherwise confidential information in their application unless such information is necessary to convey an understanding of the proposed project or to comply with a requirement in the FOA. Applicants are advised to not include any critically sensitive proprietary detail.

If an application includes trade secrets or business-sensitive, proprietary, or otherwise confidential information, it is furnished to the federal government in confidence with the understanding that the information shall be used or disclosed only for evaluation of the application. Such information will be withheld from public disclosure to the extent permitted by law, including the Freedom of Information Act. Without assuming any liability for inadvertent disclosure, EERE will seek to limit disclosure of such information to its employees and to outside reviewers when necessary for merit review of the application or as otherwise authorized by law. This restriction does not limit the federal government's right to use the information if it is obtained from another source.

If an applicant chooses to submit trade secrets or business-sensitive, proprietary, or otherwise confidential information, the applicant must provide **two copies** of the submission (e.g., Concept Paper, Full Application). The first copy should be marked "non-confidential," with the information believed to be confidential deleted. The second copy should be marked "confidential" and must clearly and conspicuously identify the trade secrets or business-sensitive, proprietary, or otherwise confidential information and must be marked as described below. Such information shall be used or disclosed only for evaluation purposes or in accordance with a financial assistance agreement between the submitter and the government. The government may use or disclose any information that is not appropriately marked or otherwise restricted, regardless of source. [End of Notice]

In addition, (1) the header and footer of every page that contains trade secrets or business-sensitive, proprietary, or otherwise confidential information must be marked as follows: “Contains Trade Secrets or Business-Sensitive, Proprietary, or Otherwise Confidential Information Exempt from Public Disclosure,” and (2) every line or paragraph containing such information must be clearly marked with double brackets or highlighting. DOE will make its own determination about the confidential status of the information and treat it according to its determination.

E. Evaluation and Administration by Non-Federal Personnel

In conducting the merit review evaluation, the Go/No-Go Reviews, and Peer Reviews, the government may seek the advice of qualified non-federal personnel as reviewers. The government may also use non-federal personnel to conduct routine, nondiscretionary administrative activities, including EERE contractors. The applicant, by submitting its application, consents to the use of non-federal reviewers/administrators. Non-federal reviewers must sign conflict of interest (COI) and non-disclosure acknowledgements (NDA) prior to reviewing an application. H. Requirement for Full and Complete Disclosure

Applicants are required to make a full and complete disclosure of all information requested. Any failure to make a full and complete disclosure of the requested information may result in:

- The termination of award negotiations;
- The modification, suspension, and/or termination of a funding agreement;
- The initiation of debarment proceedings, debarment, and/or a declaration of ineligibility for receipt of federal contracts, subcontracts, and financial assistance and benefits; and
- Civil and/or criminal penalties.

I. Retention of Submissions

EERE expects to retain copies of all Full Applications and other submissions. No submissions will be returned. By applying to EERE for funding, applicants consent to EERE's retention of their submissions.

J. Title to Subject Inventions

Ownership of subject inventions is governed pursuant to the authorities listed below:

- Domestic Small Businesses, Educational Institutions, and Nonprofits: Under the Bayh-Dole Act (35 U.S.C. § 200 et seq.), domestic small businesses, educational institutions, and nonprofits may elect to retain title to their subject inventions;
- All other parties: The federal Non-Nuclear Energy Act of 1974, 42 U.S.C. § 5908, provides that the government obtains title to new inventions unless a waiver is granted (see below);
- Class Patent Waiver: DOE has issued a class waiver that applies to this FOA. Under this class waiver, domestic large businesses may elect title to their subject inventions similar to the right provided to the domestic small businesses, educational institutions, and nonprofits by law. To avail itself of the class waiver, a domestic large business must agree that any products embodying or produced through the use of a subject invention first created or reduced to practice under this program will be substantially manufactured in the United States.
- Advance and Identified Waivers: Applicants not covered by a Class Patent Waiver or the Bayh-Dole Act may request a patent waiver that will cover subject inventions that may be invented under the award, in advance of or within 30 days after the effective date of the award. Even if an advance waiver is not requested or the request is denied, the recipient will have a continuing right under the award to request a waiver for identified inventions, i.e., individual subject inventions that are disclosed to EERE within the timeframes set forth in

the award's intellectual property terms and conditions. Any patent waiver that may be granted is subject to certain terms and conditions in 10 CFR 784.

- DEC: On June 07, 2021, DOE approved a Determination of Exceptional Circumstances (DEC) under the Bayh-Dole Act to further promote domestic manufacture of DOE science and energy technologies. In accordance with this DEC, all awards, including sub-awards, under this FOA shall include the U.S. Competitiveness Provision in accordance with Section VI.B.xxi. Pursuant to 37 CFR § 401.4, any nonprofit organization or small business firm as defined by 35 U.S.C. 201 affected by any DEC has the right to appeal it by providing written notice to DOE within 30 working days from the time it receives a copy of the determination.
- DOE may issue and publish further DEC's on the website above prior to the issuance of awards under this FOA. DOE may require additional submissions or requirements as authorized by any applicable DEC.

K. Government Rights in Subject Inventions

Where prime recipients, subrecipients, and contractors retain title to subject inventions, the U.S. government retains certain rights.

1. Government Use License

The U.S. government retains a nonexclusive, nontransferable, irrevocable, paid-up license to practice or have practiced for or on behalf of the United States any subject invention throughout the world. This license extends to government contractors.

2. March-In Rights

The U.S. government retains march-in rights with respect to all subject inventions. Through "march-in rights," the government may require a prime recipient or subrecipient who has elected to retain title to a subject invention (or their assignees or exclusive licensees), to grant a license for use of the invention to a third party. In addition, the government may grant licenses for use of the subject invention when a prime recipient, subrecipient, or their assignees and exclusive licensees refuse to do so.

DOE may exercise its march-in rights only if it determines that such action is necessary under any of the four following conditions:

- The owner or licensee has not taken or is not expected to take effective steps to achieve practical application of the invention within a reasonable time;
- The owner or licensee has not taken action to alleviate health or safety needs in a reasonably satisfied manner;

- The owner has not met public use requirements specified by federal statutes in a reasonably satisfied manner; or
 - The United States manufacturing requirement has not been met.

Any determination that march-in rights are warranted must follow a fact-finding process in which the recipient has certain rights to present evidence and witnesses, confront witnesses and appear with counsel and appeal any adverse decision. To date, DOE has never exercised its march-in rights to any subject inventions.

L. Rights in Technical Data

Data rights differ based on whether data is first produced under an award or instead was developed at private expense outside the award.

“Limited Rights Data”: The U.S. government will not normally require delivery of confidential or trade secret-type technical data developed solely at private expense prior to issuance of an award, except as necessary to monitor technical progress and evaluate the potential of proposed technologies to reach specific technical and cost metrics.

Government Rights in Technical Data Produced Under Awards: The U.S. government normally retains unlimited rights in technical data produced under government financial assistance awards, including the right to distribute to the public. However, pursuant to special statutory authority, certain categories of data generated under EERE awards under this FOA may be protected from public disclosure for up to five years after the data is generated (“Protected Data”). For awards permitting Protected Data, the protected data must be marked as set forth in the award’s intellectual property terms and conditions and a listing of unlimited rights data (i.e., non-protected data) must be inserted into the data clause in the award. In addition, invention disclosures may be protected from public disclosure for a reasonable time in order to allow for filing a patent application.

M. Copyright

The prime recipient and subrecipients may assert copyright in copyrightable works, such as software, first produced under the award without EERE approval. When copyright is asserted, the government retains a paid-up nonexclusive, irrevocable worldwide license to reproduce, prepare derivative works, distribute copies to the public, and to perform publicly and display publicly the copyrighted work. This license extends to contractors and others doing work on behalf of the government.

N. Export Control

The United States government regulates the transfer of information, commodities, technology, and software considered to be strategically important to the United States to protect national security, foreign policy, and economic interests without imposing undue regulatory burdens on legitimate international trade. There is a network of federal agencies and regulations that govern exports that are collectively referred to as “Export Controls.” All recipients and subrecipients are responsible for ensuring compliance with all applicable United States Export Control laws and regulations relating to any work performed under a resulting award.

The recipient must immediately report to DOE any export control violations related to the project funded under the DOE award, at the recipient or subrecipient level, and provide the corrective action(s) to prevent future violations.

O. Prohibition on Certain Telecommunications and Video Surveillance Services or Equipment

As set forth in 2 CFR 200.216, recipients and subrecipients are prohibited from obligating or expending project funds (federal funds and recipient cost share) to procure or obtain; extend or renew a contract to procure or obtain; or enter into a contract (or extend or renew a contract) to procure or obtain equipment, services, or systems that use *covered telecommunications equipment or services* as a substantial or essential component of any system, or as critical technology as part of any system. As described in Section 889 of Public Law 115-232, *covered telecommunications equipment* is telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation (or any subsidiary or affiliate of such entities).

See Public Law 115-232, Section 889, 2 CFR 200.216, and 2 CFR 200.471 for additional information.

P. Personally Identifiable Information (PII)

All information provided by the applicant must to the greatest extent possible exclude PII. The term “PII” refers to information which can be used to distinguish or trace an individual's identity, such as their name, social security number, biometric records, alone, or when combined with other personal or identifying information which is linked or linkable to a specific individual, such as date and place of birth, mother’s maiden name. (See OMB Memorandum M-17-12 dated January 3, 2017)

By way of example, applicants must screen resumes to ensure that they do not contain PII such as personal addresses, personal landline/cell phone numbers, and personal emails. **Under no circumstances should Social Security Numbers (SSNs) be included in the application.** Federal agencies are prohibited from the collecting,

using, and displaying unnecessary SSNs. (See, the Federal Information Security Modernization Act of 2014 (Pub. L. No. 113-283, Dec 18, 2014; 44 U.S.C. § 3551).

Q. Annual Independent Audits

If a for-profit entity is a prime recipient and has expended \$750,000 or more of DOE awards during the entity's fiscal year, an annual compliance audit performed by an independent auditor is required. For additional information, please refer to 2 CFR 910.501 and Subpart F.

If an educational institution, non-profit organization, or state/local government is a prime recipient or subrecipient and has expended \$750,000 or more of federal awards during the non-federal entity's fiscal year, a Single or Program-Specific Audit is required. For additional information, please refer to 2 CFR 200.501 and Subpart F.

Applicants and subrecipients (if applicable) should propose sufficient costs in the project budget to cover the costs associated with the audit. EERE will share in the cost of the audit at its applicable cost share ratio.

APPENDIX A – COST SHARE INFORMATION

Cost Sharing or Cost Matching

The terms “cost sharing” and “cost matching” are often used synonymously. Even the DOE Financial Assistance Regulations, 2 CFR 200.306, use both terms in the titles specific to regulations applicable to cost sharing. EERE almost always uses “cost sharing,” as it conveys the concept that non-federal share is calculated as a percentage of the Total Project Cost. An exception is the State Energy Program Regulation, 10 CFR 420.12, State Matching Contribution. Here “cost matching” for the non-federal share is calculated as a percentage of the federal funds only, rather than the Total Project Cost.

How Cost Sharing Is Calculated

As stated above, cost sharing is calculated as a percentage of the Total Project Cost. FFRDC costs must be included in Total Project Costs. The following is an example of how to calculate cost sharing amounts for a project with \$1,000,000 in federal funds with a minimum 20% non-federal cost sharing requirement:

- Formula: Federal share (\$) divided by federal share (%) = Total Project Cost
Example: \$1,000,000 divided by 80% = \$1,250,000
- Formula: Total Project Cost (\$) minus federal share (\$) = Non-federal share (\$)
Example: \$1,250,000 minus \$1,000,000 = \$250,000
- Formula: Non-federal share (\$) divided by Total Project Cost (\$) = Non-federal share (%)
Example: \$250,000 divided by \$1,250,000 = 20%

What Qualifies for Cost Sharing

While it is not possible to explain what specifically qualifies for cost sharing in one or two sentences, in general, if a cost is allowable under the cost principles applicable to the organization incurring the cost and is eligible for reimbursement under an EERE grant or cooperative agreement, it is allowable as cost share. Conversely, if the cost is not allowable under the cost principles and not eligible for reimbursement, it is not allowable as cost share. In addition, costs may not be counted as cost share if they are paid by the federal government under another award unless authorized by federal statute to be used for cost sharing.

The rules associated with what is allowable as cost share are specific to the type of organization that is receiving funds under the grant or cooperative agreement, though are generally the same for all types of entities. The specific rules applicable to:

- FAR Part 31 for For-Profit entities, (48 CFR Part 31); and
- 2 CFR Part 200 Subpart E - Cost Principles for all other non-federal entities.

In addition to the above regulations, other factors may also come into play such as timing of donations and length of the project period. For example, the value of 10 years of donated maintenance on a project that has a project period of five years would not be fully allowable as cost share. Only the value for the five years of donated maintenance that corresponds to the project period is allowable and may be counted as cost share.

Additionally, EERE generally does not allow pre-award costs for either cost share or reimbursement when these costs precede the signing of the appropriation bill that funds the award. In the case of a competitive award, EERE generally does not allow pre-award costs prior to the signing of the Selection Statement by the EERE Selection Official.

General Cost Sharing Rules on a DOE Award

- 1. Cash Cost Share** encompasses all contributions to the project made by the recipient or subrecipient(s), for costs incurred and paid for during the project. This includes when an organization pays for personnel, supplies, equipment for their own company with organizational resources. If the cost of the item or service is reimbursed, it is cash cost share. All cost share items must be necessary to the performance of the project.
- 2. In-Kind Cost Share** encompasses all contributions to the project made by the recipient or subrecipient(s) that do not involve a payment or reimbursement and represent donated items or services. In-Kind cost share items include volunteer personnel hours, donated existing equipment, and donated existing supplies. The cash value and calculations thereof for all In-Kind cost share items must be justified and explained in the Cost Share section of the project Budget Justification. All cost share items must be necessary to the performance of the project. Consult your DOE contact if you have questions before filling out the In-Kind cost share section of the Budget Justification.
- 3. Funds from other federal sources** may **not** be counted as cost share. This prohibition includes FFRDC subrecipients. Non-federal sources include any source not originally derived from federal funds. Cost sharing commitment letters from subrecipients must be provided with the original application.
- 4. Fee or profit**, including foregone fee or profit, are not allowable as project costs (including cost share) under any resulting award. The project may only incur those costs that are allowable and allocable to the project (including cost share) as determined in accordance with the applicable cost principles prescribed in FAR Part 31 for For-Profit entities and 2 CFR Part 200 Subpart E - Cost Principles for all other non-federal entities.

DOE Financial Assistance Rules 2 CFR Part 200 as amended by 2 CFR Part 910

As stated above, the rules associated with what is allowable cost share are generally the same for all types of organizations. Following are the rules found to be common, but again, the specifics are contained in the regulations and cost principles specific to the type of entity:

(A) Acceptable contributions. All contributions, including cash contributions and third-party in-kind contributions, must be accepted as part of the prime recipient's cost sharing if such contributions meet all of the following criteria:

- (1)** They are verifiable from the recipient's records.
- (2)** They are not included as contributions for any other federally assisted project or program.
- (3)** They are necessary and reasonable for the proper and efficient accomplishment of project or program objectives.
- (4)** They are allowable under the cost principles applicable to the type of entity incurring the cost as follows:
 - a.** For-profit organizations. Allowability of costs incurred by for-profit organizations and those nonprofit organizations listed in Attachment C to OMB Circular A-122 is determined in accordance with the for-profit cost principles in 48 CFR Part 31 in the FAR, except that patent prosecution costs are not allowable unless specifically authorized in the award document. (v) Commercial Organizations. FAR Subpart 31.2—Contracts with Commercial Organizations; and
 - b.** Other types of organizations. For all other non-federal entities, allowability of costs is determined in accordance with 2 CFR Part 200 Subpart E.
- (5)** They are not paid by the federal government under another award unless authorized by federal statute to be used for cost sharing or matching.
- (6)** They are provided for in the approved budget.

(B) Valuing and documenting contributions

- (1)** Valuing recipient's property or services of recipient's employees. Values are established in accordance with the applicable cost principles, which mean that amounts chargeable to the project are determined on the basis of costs incurred. For real property or equipment used on the project, the cost principles authorize depreciation or use charges. The full value of the item may be applied when the item will be consumed in the performance of the award or fully depreciated by the end of

the award. In cases where the full value of a donated capital asset is to be applied as cost sharing or matching, that full value must be the lesser or the following:

- a. The certified value of the remaining life of the property recorded in the recipient's accounting records at the time of donation; or
 - b. The current fair market value. If there is sufficient justification, the Contracting Officer may approve the use of the current fair market value of the donated property, even if it exceeds the certified value at the time of donation to the project. The Contracting Officer may accept the use of any reasonable basis for determining the fair market value of the property.
- (2)** Valuing services of others' employees. If an employer other than the recipient furnishes the services of an employee, those services are valued at the employee's regular rate of pay, provided these services are for the same skill level for which the employee is normally paid.
- (3)** Valuing volunteer services. Volunteer services furnished by professional and technical personnel, consultants, and other skilled and unskilled labor may be counted as cost sharing or matching if the service is an integral and necessary part of an approved project or program. Rates for volunteer services must be consistent with those paid for similar work in the recipient's organization. In those markets in which the required skills are not found in the recipient organization, rates must be consistent with those paid for similar work in the labor market in which the recipient competes for the kind of services involved. In either case, paid fringe benefits that are reasonable, allowable, and allocable may be included in the valuation.
- (4)** Valuing property donated by third parties.
 - a. Donated supplies may include such items as office supplies or laboratory supplies. Value assessed to donated supplies included in the cost sharing or matching share must be reasonable and must not exceed the fair market value of the property at the time of the donation.
 - b. Normally only depreciation or use charges for equipment and buildings may be applied. However, the fair rental charges for land and the full value of equipment or other capital assets may be allowed, when they will be consumed in the performance of the award or fully depreciated by the end of the award, provided that the Contracting Officer has approved the charges. When use charges are applied, values must be determined in accordance with the usual accounting policies of the recipient, with the following qualifications:
 - i. The value of donated space must not exceed the fair rental value of comparable space as established by an independent appraisal of

comparable space and facilities in a privately-owned building in the same locality.

- ii. The value of loaned equipment must not exceed its fair rental value.

(5) Documentation. The following requirements pertain to the recipient's supporting records for in-kind contributions from third parties:

- a. Volunteer services must be documented and, to the extent feasible, supported by the same methods used by the recipient for its own employees.
- b. The basis for determining the valuation for personal services and property must be documented.

APPENDIX B – SAMPLE COST SHARE CALCULATION FOR BLENDED COST SHARE PERCENTAGE

The following example shows the math for calculating required cost share for a project with \$2 million in federal funds with four tasks requiring different non-federal cost share percentages:

Task	Proposed Federal Share	Federal Share %	Recipient Share %
Task 1 (R&D)	\$1,000,000	80%	20%
Task 2 (R&D)	\$500,000	80%	20%
Task 3 (Demonstration)	\$400,000	50%	50%
Task 4 (Outreach)	\$100,000	100%	0%

Federal share (\$) divided by federal share (%) = Task Cost

Each task must be calculated individually as follows:

Task 1

\$1,000,000 divided by 80% = \$1,250,000 (Task 1 Cost)

Task 1 Cost minus federal share = non-federal share

\$1,250,000 - \$1,000,000 = \$250,000 (non-federal share)

Task 2

\$500,000 divided 80% = \$625,000 (Task 2 Cost)

Task 2 Cost minus federal share = non-federal share

\$625,000 - \$500,000 = \$125,000 (non-federal share)

Task 3

\$400,000 / 50% = \$800,000 (Task 3 Cost)

Task 3 Cost minus federal share = non-federal share

\$800,000 - \$400,000 = \$400,000 (non-federal share)

Task 4

Federal share = \$100,000

Non-federal cost share is not mandated for outreach = \$0 (non-federal share)

APPENDIX C – WAIVER REQUESTS FOR: 1. FOREIGN ENTITY PARTICIPATION; AND 2. FOREIGN WORK

1. Waiver for Foreign Entity Participation

Many of the technology areas DOE funds fall in the category of critical and emerging technologies (CETs). CETs are a subset of advanced technologies that are potentially significant to United States national and economic security.²³ For projects selected under this FOA, all recipients and subrecipients must be organized, chartered, or incorporated (or otherwise formed) under the laws of a state or territory of the United States; have majority domestic ownership and control; and have a physical location for business operations in the United States. To request a waiver of this requirement, an applicant must submit an explicit waiver request in the Full Application.

Waiver Criteria

Foreign entities seeking to participate in a project funded under this FOA must demonstrate to the satisfaction of DOE that:

- a. Its participation is in the best interest of the United States industry and United States economic development;
- b. The project team has appropriate measures in place to control sensitive information and protect against unauthorized transfer of scientific and technical information;
- c. Adequate protocols exist between the United States subsidiary and its foreign parent organization to comply with export control laws and any obligations to protect proprietary information from the foreign parent organization;
- d. The work is conducted within the United States and the entity acknowledges and demonstrates that it has the intent and ability to comply with the United States Competitiveness Provision (see Section VI.B.xxi.); and
- e. The foreign entity will satisfy other conditions that may be deemed necessary by DOE to protect United States government interests.

Content for Waiver Request

A Foreign Entity waiver request must include the following:

- a. Information about the entity: name, point of contact, and proposed type of involvement in the project;
- b. Country of incorporation, the extent of the ownership/level control by foreign entities, whether the entity is state owned or controlled, a summary of the ownership breakdown of the foreign entity, and the percentage of

-
- ownership/control by foreign entities, foreign shareholders, foreign state or foreign individuals;
- c. The rationale for proposing a foreign entity participate (must address criteria above);
 - d. A description of the project's anticipated contributions to the United States economy;
 - How the project will benefit the United States, including manufacturing, contributions to employment in the United States and growth in new markets and jobs in the United States;
 - How the project will promote manufacturing of products and/or services in the United States;
 - e. A description of how the foreign entity's participation is essential to the project;
 - f. A description of the likelihood of Intellectual Property (IP) being created from the work and the treatment of any such IP; and
 - g. Countries where the work will be performed (Note: if any work is proposed to be conducted outside the United States, the applicant must also complete a separate request foreign work waiver.)

DOE may also require:

- A risk assessment with respect to IP and data protection protocols that includes the export control risk based on the data protection protocols, the technology being developed, and the foreign entity and country. These submissions could be prepared by the project lead (if not the prime recipient), but the prime recipient must make a representation to DOE as to whether it believes the data protection protocols are adequate and make a representation of the risk assessment – high, medium, or low risk of data leakage to a foreign entity.
- Additional language be added to any agreement or subagreement to protect IP, mitigate risk, or other related purposes.

DOE may require additional information before considering the waiver request.

DOE's decision concerning a waiver request is not appealable.

2. Performance of Work in the United States (Foreign Work Waiver Request)

As set forth in Section IV.I.iii., all work funded under this FOA must be performed in the United States. To seek a waiver of the Performance of Work in the United States requirement, the applicant must submit an explicit waiver request in the Full Application. A separate waiver request must be submitted for each entity proposing performance of work outside of the United States.

Overall, a waiver request must demonstrate to the satisfaction of DOE that it would further the purposes of this FOA and is otherwise in the economic interests of the

United States to perform work outside of the United States. A request for a foreign work waiver must include the following:

1. The rationale for performing the work outside the United States (“foreign work”);
2. A description of the work proposed to be performed outside the United States;
3. An explanation as to how the foreign work is essential to the project;
4. A description of the anticipated benefits to be realized by the proposed foreign work and the anticipated contributions to the U.S. economy;
5. The associated benefits to be realized and the contribution to the project from the foreign work;
6. How the foreign work will benefit the United States, including manufacturing, contributions to employment in the United States and growth in new markets and jobs in the United States;
7. How the foreign work will promote manufacturing of products and/or services in the United States;
8. A description of the likelihood of IP being created from the foreign work and the treatment of any such IP;
9. The total estimated cost (DOE and recipient cost share) of the proposed foreign work;
10. The countries in which the foreign work is proposed to be performed; and
11. The name of the entity that would perform the foreign work.

DOE may require additional information before considering the waiver request.

DOE’s decision concerning a waiver request is not appealable.

APPENDIX D – REQUIRED USE OF AMERICAN IRON, STEEL, MANUFACTURED PRODUCTS, AND CONSTRUCTION MATERIALS BUY AMERICA REQUIREMENTS FOR INFRASTRUCTURE PROJECTS

A. Definitions

For purposes of the Buy America requirements, based both on the statute and OMB Guidance Document dated April 18, 2022, the following definitions apply:

Construction materials includes an article, material, or supply—other than an item of primarily iron or steel; a manufactured product; cement and cementitious materials; aggregates such as stone, sand, or gravel; or aggregate binding agents or additives²⁴—that is or consists primarily of:

- Non-ferrous metals;
- Plastic and polymer-based products (including polyvinylchloride, composite building materials, and polymers used in fiber optic cables);
- Glass (including optic glass);
- Lumber; or
- Drywall.

Infrastructure includes, at a minimum, the structures, facilities, and equipment for, in the United States, roads, highways, and bridges; public transportation; dams, ports, harbors, and other maritime facilities; intercity passenger and freight railroads; freight and intermodal facilities; airports; water systems, including drinking water and wastewater systems; electrical transmission facilities and systems; utilities; broadband infrastructure; and buildings and real property. Infrastructure includes facilities that generate, transport, and distribute energy.

Moreover, according to the OMB guidance document:

When determining if a program has infrastructure expenditures, Federal agencies should interpret the term “infrastructure” broadly and consider the definition provided above as illustrative and not exhaustive. When determining if a particular construction project of a type not listed in the definition above constitutes “infrastructure,” agencies should consider whether the project will serve a public function, including whether the project is publicly owned and operated, privately operated on behalf of the public, or is a place of public accommodation, as opposed to a project that is privately owned and not open to the public. Projects with the former qualities have greater indicia of infrastructure, while projects with the latter quality have fewer. Projects consisting solely of the

purchase, construction, or improvement of a private home for personal use, for example, would not constitute an infrastructure project.

The Agency, not the applicant, will have the final say as to whether a given project includes infrastructure, as defined herein. Accordingly, in cases where the “public” nature of the infrastructure is unclear but the other relevant criteria are met, DOE strongly recommends that applicants complete their full application with the assumption that Buy America requirements will apply to the proposed project.

Project means the construction, alteration, maintenance, or repair of infrastructure in the United States.

B. Buy America Requirements for Infrastructure Projects (“Buy America” requirements)

In accordance with Section 70914 of the BIL, none of the project funds (includes federal share and recipient cost share) may be used for a project for infrastructure unless:

- (1) all iron and steel used in the project are produced in the United States--this means all manufacturing processes, from the initial melting stage through the application of coatings, occurred in the United States;
- (2) all manufactured products used in the project are produced in the United States—this means the manufactured product was manufactured in the United States; and the cost of the components of the manufactured product that are mined, produced, or manufactured in the United States is greater than 55 percent of the total cost of all components of the manufactured product, unless another standard for determining the minimum amount of domestic content of the manufactured product has been established under applicable law or regulation; and
- (3) all construction materials²⁵ are produced in the United States—this means that all manufacturing processes for the construction material occurred in the United States.

The Buy America requirements only apply to articles, materials, and supplies that are consumed in, incorporated into, or affixed to an infrastructure project. As such, it does not apply to tools, equipment, and supplies, such as temporary scaffolding, brought to the construction site and removed at or before the completion of the infrastructure project. Nor does the Buy America requirements apply to equipment and furnishings, such as movable chairs, desks, and portable computer equipment, that are used at or within the finished infrastructure project, but are not an integral part of the structure or permanently affixed to the infrastructure project.

These requirements must flow down to all sub-awards, all contracts, subcontracts, and purchase orders for work performed under the proposed project, except where the prime recipient is a for-profit entity. Based on guidance from the Office of Management and Budget (OMB), the Buy America requirements of the BIL do not apply to DOE projects in which the prime recipient is a for-profit entity; the requirements only apply to projects whose prime recipient is a State, local government, Indian Tribe, Institution of Higher Education, or non-profit organization.

For additional information related to the application and implementation of these Buy America requirements, please see OMB Memorandum M-22-11, issued April 18, 2022:

Note that for all applicants—both non-Federal entities and for-profit entities—DOE is including a Program Policy Factor that the Selection Official may consider in determining which Full Applications to select for award negotiations that considers whether the applicant has made a commitment to procure U.S. iron, steel, manufactured products, and construction materials in its project.

C. Waivers

The DOE financial assistance agreement will require each recipient: (1) to fulfill the commitments made in its application regarding the procurement of U.S.-produced products and (2) to fulfill the commitments made in its application regarding the procurement of other key component metals and domestically manufactured products that are deemed available in sufficient and reasonably available quantities or of a satisfactory quality at the time of award negotiation.

In limited circumstances, DOE may waive the application of the Buy America requirements where DOE determines that:

- (1) Applying the Buy America requirements would be inconsistent with the public interest;
- (2) The types of iron, steel, manufactured products, or construction materials are not produced in the United States in sufficient and reasonably available quantities or of a satisfactory quality; or
- (3) The inclusion of iron, steel, manufactured products, or construction materials produced in the United States will increase the cost of the overall project by more than 25%.

If an applicant or recipient is seeking a waiver of the Buy America requirements, it may submit a waiver request after it has been notified of its selection for award negotiations. A waiver request must include:

- A detailed justification for the use of “non-domestic” iron, steel, manufactured products, or construction materials to include an explanation as to how the non-domestic item(s) is essential to the project;
 - A certification that the applicant or recipient made a good faith effort to solicit bids for domestic products supported by terms included in requests for proposals, contracts, and nonproprietary communications with potential suppliers;
 - Applicant/Recipient name and Unique Entity Identifier (UEI)
 - Total estimated project cost, DOE and cost-share amounts;
 - Project description and location (to the extent known);
 - List and description of iron or steel item(s), manufactured goods, and construction material(s) the applicant or recipient seeks to waive from Domestic Content Procurement Preference requirement, including name, cost, country(ies) of origin (if known), and relevant PSC and NAICS code for each;
 - Waiver justification including due diligence performed (e.g., market research, industry outreach) by the applicant or recipient; and
 - Anticipated impact if no waiver is issued

DOE may require additional information before considering the waiver request.

Waiver requests are subject to public comment periods of no less than 15 days and must be reviewed by the Made in America Office. There may be instances where an award qualifies, in whole or in part, for an existing waiver described at [DOE Buy America Requirement Waiver Requests](#).

DOE’s decision concerning a waiver request is not appealable.
