2023 Schedule

Wednesday, January 18, 2023

Departure from several Iowa locations in the afternoon. Travel will continue overnight on the bus.

Thursday, January 19, 2023

Arrival in Washington D.C. in the afternoon; free time and worship opportunities.

Friday, January 20, 2023

Youth rally, worship opportunities and March for Life events in the morning; March for Life midday; free time in Washington D.C.

Saturday, January 21, 2023

Free day to explore D.C.; departure for Iowa in the evening; travel continues overnight on the bus.

Sunday, January 22, 2023

Arrival in Iowa locations in the late afternoon/early evening.

Cost - \$400 per participant
