Eligible students must have a minimum 2.5 GPA and be in good academic standing, as well as take and pass the attached Quiz about Freemasonry in the history of the United States and today.

### **Applicable Majors**

All fields of study

Freemasonry has played an important role in the United States since before the American Revolution and has influenced the structure of American government, civil rights, benevolent organizations, and much more. This scholarship program was created to raise awareness of the role of Freemasonry historically and of the range of Masonic organizations existing in the greater Washington, D.C. metro area. It also offers the opportunity to provide up a local graduating senior with assistance to pursue additional education.

### **How to Apply**

The applicant should print the attached forms, complete the applicant information, follow the Rules for the Scholarship Program, and successfully complete the Class of 2018-2019 Louis Goaziou Lodge #1953 Freemasonry Scholarship Quiz ("Quiz"). If the applicant is less than eighteen years of age, his/her parent or legal guardian must sign the application. If over eighteen years of age, his/her parent, legal guardian or guidance counselor must confirm this. An applicant's guidance counselor must complete a certification section. The applicant is invited to pay special attention to Rules 2, 3, and 4 below when applying for the scholarship.

### **How the Award is Made**

All properly submitted applications with qualifying scores on the Quiz are eligible for a random drawing for Louis Goaziou Lodge #1953 Class of 2018-2019 Scholarship Progran

this scholarship. The scholarship winner will be randomly selected at our April, 2019 Meeting. The selected applicant will be notified and their name will be announced on or around April 30, 2019.

### Rules for the Scholarship Program

- 1. The Louis Goaziou Lodge #1953 Scholarship is open to all high school seniors (graduating in the 2018-2019 academic year) currently enrolled in a Washington, D.C. or surrounding metro area high school; who are accepted at an accredited U.S. college for the 2019 2020 school year or other educational program. The student must have a minimum 2.5 GPA, be in good academic standing, and exhibit behavior that permits them to attend school events such as a prom and graduation.
- 2. A graduating senior wishing to apply must complete the Application for the Class of 2018-2019 Scholarship Form (pages 7-9) which includes the Quiz Answer Sheet. Applications require an original signature of the applicant and, if under the age of eighteen (18), the signature of their parent or guardian or, if eighteen (18) or older, the signature of parent, guardian or school counselor confirming they are eighteen (18) or older. Only one application per student shall be submitted.
- 3. The ten (10) question Quiz must be completed solely by the applicant. The applicant is free to find the answers either in this announcement or through any Internet sources included (some research likely will be required). Not all sources may agree, so be sure that you read this announcement and use the provided information in your best judgement. A passing grade of at least eighty percent (80%) on the Quiz qualifies the applicant for the scholarship drawing.
- 4. An applicant's guidance counselor must certify the application as indicated. The application and completed Quiz must be mailed, with a postmark no later than March 29, 2019 and received by April 3, 2019 to: Louis Goaziou #1953 Scholarship

- 5. All properly submitted applications with qualifying Quiz scores will be accepted by the Lodge for a drawing. The scholarship winners will be randomly drawn during our April, 2019 Meeting; notified by mail or phone; and, the scholarship winner's name will be announced on or about April 30, 2019.
- 6. The one (1) \$500 scholarship monies shall be used solely for books, tuition, room and board, or other college or education related expenses.
- 7. Louis Goaziou Lodge #1953 reserves the right to withhold scholarship monies pending verification of rules compliance by scholarship applicant and acceptance of scholarship applicant at an accredited college or university or other educational program.
- 8. No prizes will be substituted nor any other prize offered in lieu of the established scholarship award.
- 9. It is the Lodge's intention is to award this scholarship; however, if any unforeseen event precludes this award, this application process shall not result in a commitment to fund the award until the scholarship winner is formally notified and commits to use for valid expenses for books, tuition, room and board, or other college or education related expenses are identified for payment.
- 10. This application and scholarship award process does not constitute a contract between the applicant, or any other party, and the Louis Goaziou Lodge #1953, or any other representative or portion of The International Order of Freemasonry for Men and Women, Le Droit Humain, American Federation. Upon signing and submitting the application, the applicant and, if under eighteen (18) his/her parents/guardians agree that these rules and application shall be administered, interpreted, graded and adjudicated exclusively by the Lodge and its officers, with no right of appeal to any other entity or authority.

### Freemasonry Quiz Background

#### WHAT IS FREEMASONRY?

Freemasonry is an initiatic fraternal organization. A fraternal organization is a type of social organization whose members freely associate for a mutually beneficial purpose such as for social, professional or honorary principles. While fraternal organizations date back to ancient Greece and the mystery schools, they were in their 'golden age' in the United States from the 1870s to the 1920s. At the turn of the 20<sup>th</sup> century in the United States, one in five men belonged to one or more fraternal societies. Today, we have fraternities and sororities in college, as well as fraternal organizations like the Elks, Owls, Fraternal Order of Police, Freemasonry and many more. An initiatory organization is one with a formal rite of passage marking entrance or acceptance into a group or society. These exist today in religion (baptism, Bar Mitzvah, etc.) as well as in fraternal organizations.

The earliest mention of Freemasonry that is generally agreed on is the Regius Poem (circa 1425). However, many consider its beginning to be 1717, when the first formal governing organization was formed in the U.K. Originally, it was defined as "a system of morality, veiled in allegory (or a story) and illustrated by symbols." Freemasonry continues to be a course of moral instruction which uses both allegories and symbols to teach its lessons. While most Freemasons in the United States are men, women have been involved in affiliated organizations since at least 1850 (Eastern Star) and in other Masonic organizations with lodges that are mixed (men and women) or women only (sometimes referred to as feminine). Today there are organizations for boys and girls, as well as many charitable and other Masonic organizations.

#### WHAT ROLE DID FREEMASONRY HAVE IN COLONIAL TIMES AND THE AMERICAN REVOLUTION?

Freemasonry was popular in colonial America. During the late 1700s, it was one of the organizations most responsible for spreading the ideals of the Enlightenment: the dignity of man and the liberty of the individual, the right of all persons to worship as they choose, the formation of democratic governments, and the importance of public education. In Maryland, the first lodge was established in 1770, and the Maryland Grand Lodge formed after the Revolution in 1787. Black free men formed a lodge in Massachusetts in 1775, what later would become known as Prince Hall Freemasonry. Freemasons fought on both sides during the American Revolution, as depicted at the Friend to Friend Masonic Memorial in Gettysburg, PA. After the Revolution in Maryland, the first lodge of black masons was established in Baltimore on February 2, 1825.

### WHAT ROLE HAS FREEMASONRY HAD IN THE DOCUMENTS AND INSTITUTIONS OF AMERICAN GOVERNMENT?

In the Mitch Horowitz article in US News titled, "Masons and the Making of America", it stated, "Freemasonry's real impact on America is richer and more significant than anything that entertainment or speculation would hold. As a radical thought movement that emerged from the Reformation, Freemasonry was the first widespread and well-connected organization to espouse religious toleration and liberty — principles that the fraternity helped spread through the American colonies." Freemasons were active in the creation of this country with at least eight (8) of the 56 signers of the Declaration of Independence being Freemasons, thirteen (13) out of the 39 signers of the Constitution were Freemasons, and at least fourteen (14) of our Presidents, including George Washington, Teddy Roosevelt, Franklin Delano Roosevelt (FDR), and Harry Truman were Freemasons. There is still research going on to determine how much influence Freemasonry has had on the documents and institutions of American government.

### WHAT ROLE HAS FREEMASONRY HAD IN MODERN TIMES?

Freemasonry continues to play a key role in personal growth and development, broadening one's experience and contacts, and in the development of society. It supports a moral and ethical approach to life – including thoughtfulness for others, kindness in the community, honesty in all matters, courtesy in society and fairness in all things. There are charitable organizations that are inspired by Masonic values such as the Scottish Rite Speech and Language Center, the Shriners Hospital for Children, and efforts such as the Maryland Masonic Child ID Program (MD CHIP) as a few examples. Freemasonry is open in general to all men and women regardless of race, color, religion, or social or economic standing. In the male-only lodges, only males are admitted; other lodges are open to both men and women, or to women alone. Lodges may admit people with or without religious beliefs, e.g., agnostics or atheists.

## WHAT TYPES OF ORGANIZATIONS ARE PART OF FREEMASONRY TODAY IN THIS AREA OF THE USA?

There are many organizations existing today including numerous male-only lodges that are part of the Grand Lodges of Washington, D.C., Maryland and Virginia, their counterpart Prince Hall Grand Lodges, as well a number of other male, mixed (men and women together as in this sponsoring lodge) and feminine lodges; the House of the Temple in Washington, D.C. and other Scottish Rite buildings; the George Washington National Masonic Memorial is in Alexandria, Virginia. Appendant organizations for men, women, and youth include Eastern Star, Order of DeMolay, Job's Daughters, Amaranth and others.

### WHAT ABOUT LOUIS GOAZIOU LODGE #1953, THE SPONSOR OF THIS SCHOLARSHIP?

Louis Goaziou Lodge #1953 belongs to the International Order of Freemasonry for Men and Women, Le Droit Humain, American Federation, and is in the Washington, D.C. area. Le Droit Humain originated from the first mixed (men and women together) lodge formed in France April 4, 1893. The first initiation of men and women together in the United States was on October 18, 1903 and a lodge was established by François Louis Goaziou on October 25, 1903 in Charleroi, PA. Beyond the lodges in the United States, The International Order of Freemasonry for Men and Women, Le Droit Humain, has lodges in more than 70 countries throughout the world.

### DO ALL LODGES ALLOW WOMEN AND THOSE WITH A VARIETY OF BELIEFS ENTER FREEMASONRY?

No. On April 4, 1893, Georges Martin, a well-known Mason, and Maria Deraismes, the first female Freemason invited and initiated in 1893, created the first co-masonic (mixed) lodge. Out of this came the birth of the International Order of Freemasonry for Men and Women. It was built out of a marvelous dream to unite humanity despite all the barriers, ethnic groups, geopolitics, religion, culture, and gender.
