(Captain's Message continued.)

This month, I wanted to talk about our aging population. Here in the Ingleside, one of the many calls for service we respond to are families who call to report a missing person. In many of the cases, we encounter an elderly parent or grandparent with dementia. I want to share some thoughts with you to help prevent them from getting lost. If you know you have a family member that is showing signs of dementia, do not ignore it, and plan around it. Consider the following things to help locate a family members who may go missing, as these are things that will help the police locate a missing family member.

- If they have gone missing before, where were they found?
- Do they know how to take the bus, or drive?
- Do they take or need medication, and when? Can it be life threatening if they do not take it soon?
- Do you have a recent photo of them? If digital, you can email it to the officer.
- Be prepared to provide a description. One thing to consider is taking a daily picture of them to memorialize what they are wearing. It is so helpful when looking for missing persons to have an updated picture and description. Having a current photograph can be super helpful if we ever go to the media for assistance.
- Consider devices such as "Air Tags" that can provide tracking. Be creative in ways to incorporate and secure these items into their clothing, including their shoes. Another item that can be tracked are "Air Pods."
- Incorporate contact information, like an iron-on name tag, into their clothing.

Remember that there is no time requirement that must pass before you report someone missing. Please do not hesitate to contact the police for assistance in locating someone if you are concerned.

In closing, we just wanted to let everyone know that we'll be hosting our next community meeting on Tuesday, June 20th. The meeting will be held in-person at Ingleside Station.

06-13-23 / 04:55 p.m. / Shoplifting Arrests

on the 3398 Block of Mission St.

Officers Devine, Miller, Zandanel, Hidalgo, Orlando, Lama, Fyles, and Green worked with Sergeant Guerrero and Sergeant Hoang on an operation to address burglary, fencing, and organized retail crime in the neighborhood. This day's operation was conducted at the Walgreens store located at 3398 Mission Street. As has been reported many times, and as many community members are aware, retail stores throughout the city have seen a large number of theft and robbery incidents related to ongoing shoplifting/retail theft, and this location is one of many victimized by such crimes.

On this day's operation, officers worked cooperatively with the store's staff, and security, who were monitoring theft-related activity inside the store. Over the course of just under three hours, the officers and store personnel worked together to arrest six individuals on separate shoplifting cases. In each instance, each of the six suspects stole an array of items from the store and proceeded to walk out of the store without making any attempt to pay for any of the items. The suspects were each detained without incident, and all the stolen merchandise was recovered. All told, the operation resulted in six individual incident reports, with six suspects arrested for a variety of charges, including shoplifting and burglary, as well as outstanding warrants.

Thanks to their combined efforts, Sergeant Guerrero, his team, and store personnel were able to pro-actively address the concerns expressed by this retail outlet, the community, and SFPD officers. Report numbers 230407686, 230407733, 230407818, 230407846, 230407965, and 230408060

Monday, June 19th, 2023

01:09 a.m. Mission St. / Ney St.

Stolen Vehicle

Officers Fyles and Hurtado were on patrol passing the intersection of Mission and Ney Street when they noticed a U-Haul truck parked inside the gas station with an occupant seated inside. Officer Hurtado conducted a computer inquiry on the Arizona license plate, which showed it to be listed as a stolen vehicle. The officers quickly notified dispatch and requested additional units to the scene. Officer Fyles and Hurtado positioned their patrol car behind the stolen van in an attempt to affect a high-risk felony traffic stop. As soon as their backup arrived, the officers ordered the suspect out of the van and took him into custody without incident. The suspect was later charged with possession of a stolen vehicle. Officer Hurtado also found out through a computer check that the suspect was also listed as sex offender out of Texas and was out of compliance for not registering in California within five days of his arrival from that state. Sunday, June 18th, 2023

03:03 a.m. Holly Park Cir / Murray St. Discharging of a Firearm

Officers Lama and Sanchez were sent to a ShotSpotter activation near Holly Park Circle and Murray Street. The officers canvassed the area and located six spent shell casings on the street indicating a firearm had been discharged. The officers did not find any victims, witnesses, or suspects. The officer proceeded to collect all six casings as evidence. Report Number: 230419067

08:41 a.m. 3300 Blk. of Mission St. Shoplifting

Officer Espinoza was on patrol conducting passing calls along the 3300 block of Mission Street, due to the numerous shoplifting incidents that have been occurring, mainly at the Safeway and Walgreens stores. While in the area, Officer Espinoza heard dispatch broadcast a shoplifting call that was taking place at the Walgreens store. Dispatch also provided a description of the suspect that was involved. Officer Espinoza rushed over and saw the suspect in question cradling a large number of products in her arms. Officer Espinoza approached the suspect in attempt to take her into custody, but her accomplice, wedged herself in between preventing him from apprehending her. Being outnumbered, Officer Espinoza called for backup. Once Officers Lim and Mora arrived, they were able to take both suspects into custody. The merchandise was recovered and given back to the store. Several employees told the officer that one of the suspects grabbed items off the shelves while the other acted as a lookout. They both walked out of the store when they were confronted by the police. Both suspects were charged accordingly. Report Number: 230419437

03:48 p.m. Ney St. / Craut St.

Officers Hoang, Orlando, and several Ingleside units responded to a possible D.U.I call at the intersection of Ney and Craut Street. The officers were provided with the driver's description and the car that he was in. When the officers arrived, they located the car, which was stopped in a lane of traffic. The officer approached the vehicle and saw the driver seated in the driver's seat. The officers made themselves known as police officers and requested the driver to step out of the car. The driver exhibited delayed responses and would continuously look around without saying anything. After several attempts, the officers had to physically remove the driver from the vehicle. During the investigation, Officer Hoang noticed the driver to have slurred speech and was unsteady on his feet. A field sobriety test was done at the scene, but the driver failed every test. At the conclusion of the investigation, the driver was ultimately charged with driving under the influence. Report Number: 230418081

04:56 p.m. 100 Blk. of Valley St.

Officers Estrada and Lau were sent to the 100 block of Valley Street to investigate a theft. The officers first spoke to a neighbor, who said she saw an unknown subject walk up to her neighbor's porch and took a package that had been delivered earlier in the day. At the time of the incident, the witness was able to take a picture of the suspect and the license plate of the vehicle he was in before he fled the scene. The officer then spoke to the owner of the package and said that his wife had ordered two blue and white hooded sweatshirts with the words "Mad happy" embroidered on the front. The officers then conducted a computer inquiry on the suspect's vehicle and discovered he lived in the area. The officers went to the suspect's home and located the vehicle parked in the driveway. Inside the vehicle, the officers saw the stolen hooded sweatshirts resting on the backseat. The officers then rand the doorbell and contacted the suspect. The officers immediately detained the suspect without incident. At the conclusion of the investigation, the officers returned the stolen items and proceeded to cite and release the suspect for the theft. Report Number: 230418354

05:30 a.m. Unit Blk. of Coleridge St.

Officer Espinoza responded to the unit block of Coleridge Street to investigate a residential burglary. Upon arrival, the victim/homeowner told Officer Espinoza that his neighbor notified him that his garage door was open. The victim immediately went to his garage and saw that one of the windowpanes on the garage door had been damaged as well. He then looked around and noticed that his bicycle had been stolen. He also found a metal rod with a bent tip that had been left behind by the unknown suspect(s). Officer Espinoza determined that the suspect(s) broke the windowpane and used the metal rod to disengage the emergency release cord on the automatic door opener to get inside. Officers Archilla, Seavey, Anderson, and Sgt. Lau responded to the area of Sunnydale and Bayshore Boulevard regarding a robbery that just occurred. Officer Archilla spoke to the victim, who said she was riding on the Muni bus looking at her phone as the bus continued its route. When the bus came to a stop at the intersection, an unknown suspect reached over her shoulder and snatched her phone out of her hand. The incident happened so fast that the victim could not provide any further details or suspect description. The officers searched the surrounding area and were able to locate the victim's phone. It appeared the phone had been discarded by the suspect. The phone was eventually returned to the victim. Officer Lim responded to the unit block of Lisbon Street regarding a strong-arm robbery call. Several Ingleside units also responded and began canvassing the area. Medics were already on scene and treating the victim for the injuries she sustained during the incident. The victim said she was walking along Avalon Avenue while talking on her cell phone. She then noticed a subject walking towards her but was not concerned and continued on her way. Without warning, the subject proceeded to snatch her phone out of her hand and also grabbed her purse that she had slung across her body. The suspect then ran off with the victim's items and jumped into a get away car that was waiting mid-block. The victim ran after the suspect and tried to get her property back but was dragged by the car as she tried to open the car door. Officers Vernengo and Yap responded to an audible alarm call at a liquor store located along the 5000 block of Mission Street. When they arrived, the officers could see that the store's front window had been shattered. Unknown if any suspects were inside, the officer requested additional assistance. Officers Bell, Parker, Lazano, and Tatlow soon arrived and assisted in searching the premise. The officers did not find anyone inside but noticed that the business had been burglarized. A witness approached the officers and told them that he was driving along mission Street when he noticed a car double parked next to the liquor store and two subjects actively trying the break the front window. The witness said he kept driving and was afraid to stop. The witness provided a description of the vehicle used in the burglary. The owner arrived a short time later and informed the officers that a large amount of liquor and cigarettes had been stolen. Report Number: 230408747

04:22 a.m. 500 Blk. of Precita Ave.

Officers Zhao and Abea were dispatched to the 500 block of Precita Avenue regarding a burglary in progress. While en-route to the scene, dispatch advised the officers that the 911 caller heard someone breaking into the liquor store and that a truck was double parked in front. As the officers arrived on scene, they saw two subjects coming out of the store. One subject immediately began to run away on foot. The other subject jumped into the truck and fled. Officer Zhao gave chase and attempted to capture the suspect that was fleeing on foot. During the chase the suspect jumped over several fences but was eventually apprehended with the help of additional Ingleside Officers. The store's owner arrived and informed the officers that his cash register containing some cash had been stolen. Also, some burglary tools had been left behind at the scene, which were later seized as evidence. The suspect was eventually charged with burglary, conspiracy, resisting, possession of burglary tools as well as an outstanding warrant for his arrest. Report Number: 230408816

San Francisco Pride is one of the largest Pride celebrations in the world and one of San Francisco's most popular and well-attended events. With large crowds expected, including guests from around the world, providing safety with respect for all is our number one priority.

"The City and County of San Francisco has long been and continues to be a safe haven and a beacon of hope for members of the LGBTQ Community", said Police Chief William Scott. "Throughout PRIDE month, The San Francisco Police Department is working closely with event organizers and our partner law enforcement agencies to ensure that the LGBTQ community can celebrate a safe and joyful PRIDE."

Our department will be staffed to handle all calls for service citywide, and to provide adequate public safety staffing at Pride events throughout Pride Month. Our officers will be vigilant for unlawful or unsafe activity and will respond as appropriate. As with any large event, there are always safety concerns. Safety is everyone's responsibility, including participants, organizers, security staff and law enforcement.

Pride participants can help avoid becoming a victim of a crime by keeping in mind the following safety tips:

• Pride is about community. Look out for each other and report any suspicious persons or activity to event staff or a police officer. A good adage is, "If you see something, say something." In an emergency, call 9-1-1. To provide an anonymous tip, call the SFPD Anonymous Tip Line at (415) 575-4444.

• Stay informed of emergencies or significant events by signing up for emergency text message alerts by texting the word PRIDESF to 888-777. AlertSF allows us to notify you of emergencies in San Francisco.

• Keep your friends close and your drinks closer. Don't accept drinks from strangers. Drink responsibly and don't drink and drive- always use a designated driver.

• If you drive to the festivities, remember to "Park Smart!" Take your valuables with you, don't leave them inside your car.

• Maintain possession of your cell phone, wallet, and other valuables.

SFPD Makes Arrest in Central District Shooting

The incident resulted in several injuries, including two juveniles and the suspect being shot multiple times.

San Francisco, CA – On Sunday, June 18, 2023, at approximately 7:12 P.M., San Francisco Police officers from Southern and Central Stations responded to multiple locations in the Southern and Central Police Districts for a report of a shooting that resulted in multiple vehicle collisions. Officers found three crime scenes at the following locations: Beach and Stockton Streets, The Embarcadero and Kearny Street, and The Embarcadero and Howard Street.

SFPD officers responded to the area of Beach and Stockton Streets when they received several reports that the occupants of a white sedan and the occupants of a black SUV were exchanging gunfire as they were traveling eastbound on Beach Street. The suspects continued to exchange gunfire as they drove through several city streets.

Two uninvolved victim vehicles were struck by gunfire in the area of Beach and Stockton Streets. A 48-year-old male victim inside one of the vehicles sustained non-life-threatening injuries when he was struck by broken glass that was shattered as a result of the gunfire. A 34-year-old female victim inside another one of the vehicles sustained non-life-threatening injuries when she was struck by bullet fragments and broken glass. Both victims were transported to a local hospital for treatment.

The vehicles continued to drive south on The Embarcadero. In the intersection of The Embarcadero and Kearny Street, the white sedan struck a 10-year-old female victim, and the black SUV struck a 16-year-old victim, both of whom were crossing The Embarcadero. The 10-year-old victim was transported to a local hospital with non-life-threatening injuries. The 16-year-old was treated at the scene for non-life-threatening injuries.

Both suspect vehicles continued south on The Embarcadero. At the intersection of The Embarcadero and Howard Street, the black SUV collided with a fixed object and came to a rest. The white sedan fled the scene. Officers detained the two occupants of the black SUV. The occupants were a 28-year-old female, and 23-year-old Lee Haywood of Pittsburg, CA. Haywood and the female were both struck by gunfire during the incident, and both were transported to a local hospital for treatment. Haywood is currently being treated for life-threatening injuries. The female was treated and later released for non-life-threatening injuries.

During the subsequent investigation officers located a semi-automatic firearm and several spent shell casings inside the black SUV. Investigators developed information to place Haywood under arrest in connection with the incident. Haywood was later booked and charged with negligent discharge of a firearm (246.3(a) PC), wanted felon in possession of a firearm (29800(a)(3) PC), carrying a loaded firearm in a vehicle (25850(a) PC), carrying a concealed firearm in a vehicle (25400(a)(1) PC), and carrying a concealed firearm (25400(a)(2) PC). Haywood was also booked on an outstanding warrant out of Antioch.

While one arrest has been made, this remains an open and active investigation. Anyone with information is asked to call the SFPD Tip Line at 1-415-575-4444 or Text a Tip to TIP411 and begin the text message with SFPD. You may remain anonymous.

The coach wanted to share his experience of being a victim of an auto burglary in San Francisco, where the suspects stole a player's bag, containing insulin and medical equipment. SFPD officers quickly made an arrest, reunited the player with his property, and helped clean up the shattered glass of the vehicle that was broken into.

Chief Scott-

I am a high school baseball coach for the East High School Baseball Team in Rochester, NY. We are an inner-city school and our Varsity baseball team has 16 players most of which are Latino with a few black players and one white player. We were blessed by a partnership with United Airlines to fly to the Bay Area on April 18-22. While in the Bay Area we toured the athletic campus at Cal-Berkeley, watched a Div I game, went to the Oakland Coliseum for an As game, played a high school game vs Berkeley HS, toured the Golden Gate Park, went to the Muir Woods, stopped at Fisherman's Wharf, and then concluded the trip by watching a Giants game at Oracle Field.

On Friday, April 21 we dropped our players and coaches off at Fisherman's Wharf and I parked our 15-passenger van on the street. We were parked for less than 40 minutes. When we returned we were greeted by two of your officers who asked if the van belonged to me. We were victims of a smash-and-grab. Officer Hector Roderte and Officer Dave Colclough identified themselves as San Francisco Police Department even though they were in civilian clothes. They shared that they were on detail in an unmarked car for smash-and-grabs and saw our van getting burglarized. They arrested three individuals and were hopeful that anything we lost could be recovered.

We found out that they only stole one bag but it was the bag of one of my players who was just diagnosed with Type-1 diabetes. All of his insulin and other medical equipment was inside the bag. The officers indicated that we would need to identify the bag at the substation which was 20-25 minutes away. As the head coach I had a range of emotions occurring and I shared that "this was going to ruin our night" as the Giants game was scheduled to start in about 1.5 hours. The officers saw our team (kids of color) and responded with "We are not going to let this ruin your night." They immediately asked for the victim to describe his bag then called their partner that was transporting about 7-8 bags (all recovered from the suspects vehicle.) Their partner identified the bag. The officers with us asked their partner to turn around and bring the bag back to the scene.

In the meantime, Officers Roderte and Colclough advised us how to clean up the mess and secure our window. They helped us locate a broom, cardboard, and duct tape. They immediately filled out a police report for us to give to the rental car company. Within 20 minutes, my players recovered all their items, our window was secured, and we were on our way to the Giants game. We got to the game on time. The players on my team commented in the van, "We have never seen police officers like them." They made such a POSITIVE IMPRESSION on my players. 911 Call Regarding an Aggravated Assault Leads to a Richmond District Officer Involved Shooting

On SAN FRANCISCO (JUNE 22, 2023) – On Thursday, June 22, 2023, at approximately 2:39 a.m., San Francisco police officers from Richmond Station were dispatched to a residence on the 700 block of 31st Avenue for a report of an aggravated assault in progress. An officer arrived on scene and made contact with an 84-year-old male victim in the doorway of the home. During the interaction, the 37-year-old suspect, who was armed with a knife, advanced toward the officer and the victim from inside the home and an officer involved shooting occurred. Additional officers arrived on scene and began rendering aid to the suspect and summoned medical personnel to the scene.

The victim told officers that the suspect had assaulted a 76-year-old female victim inside the home. Officers entered the home and discovered the female victim deceased. A dog was also found deceased inside the home. Medics transported the suspect to a local hospital where he was later pronounced deceased. The male victim was transported to a local hospital and treated for non-life-threatening injuries.

This incident is being investigated by the San Francisco District Attorney's Office; the San Francisco Police Department Investigative Services Division (ISD); the SFPD Internal Affairs Division (IAD); the Department of Police Accountability (DPA); and the Office of the Chief Medical Examiner (OCME).

Additional information will be released as it becomes available. As part of SFPD's commitment to transparency and accountability, a town hall meeting regarding this officer-involved shooting will be held within ten days.



Crime Prevention and Safety

In reviewing our incident reports, we see opportunities to reach out to our community members and provide you with information related to crime prevention and safety tips.

We encourage you to take some time to look through the following pages, in hope that this information will help us all play a part in making our community safer, and prevent someone from being the victim of a crime.

We also encourage you to contact San Francisco Safe at 415-553-1984 or www.sfsafe.org for more crime prevention tips.

Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crimerelated incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

The following are some examples of Suspicious Activity that are "In progress" crimes, which demand an immediate call to 9-1-1:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.





Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- <u>Homeless Outreach and Outreach to Drug Users</u>: Ingleside Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- <u>Foot Patrols</u>: Ingleside Station has foot beat officers assigned to the Geneva, Leland and Cortland corridors.
- <u>Monthly Police Community Relations Meetings</u>: Community Meetings are held continuously. Station personnel also attend meetings with merchant groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Ingleside Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.



Residential Burglary Prevention

Our homes are a place of comfort, refuge, and security for ourselves, family, and friends. Unfortunately, residential burglaries are a far-too-common occurrence nationwide, and can be a traumatic experience for those victimized under these circumstances. Burglaries can occur any time of the day, in any neighborhood, but you can never be too careful when it comes to securing your home and taking simple measures to help reduce the chance of falling victim to a home burglary. Here are some tips we'd like to share with you on this important topic.

- Start with a security survey. If you can identify any vulnerable entry points, chances are good that a burglar can too. Never leave keys in "hidden" places. Burglars know all the likely places to look. When moving into a new home, or if you lose your keys, have all the locks changed.
- Secure your entry points with strong doors and windows. Reinforce these entry points with dead bolts, quality keyed locks, and secure door and window frames. Make sure your door hinges are on the inside. Door gates and window bars can also help prevent ready access to the most common points of entry.
- Keep your outside doors, gates, and garage doors closed and locked at all times, especially when away from home, and before going to bed. Always secure any door that leads from the garage into the interior of the home. Also, never leave a garage door opener visible in a vehicle, as this is a ready method of entry into the garage and home.
- Keep trees and shrubs pruned so as to not provide hiding places or concealment for burglars. Try not to cover windows, doorways, or other points of entry with overgrown trees and shrubs. Don't leave ladders, tools, trash cans, or anything that could be used to gain entry to your home readily accessible to suspects.
- Never underestimate the benefits of exterior lighting, motion activated/sensitive lights, and security cameras. They not only help prevent burglaries, but are instrumental in helping to collect valuable evidence. Consider a home alarm system, and if you have one, use it! Activate your system as needed to provide alerts of any unlawful entry.
- Leave valuables out of sight, be it out in front of your home, in an open garage, or visible through windows. Consider using window coverings on entry doors, windows, and garage doors to help prevent ready view into the interior of your home. Make your home look occupied. Use automatic timers on lights, and consider leaving a T.V. or radio on.
- Don't allow mail, flyers, newspapers, garbage/recycling bins, and package deliveries to build up
 in front of your home. If need be, ask a trusted neighbor to collect these items. If you plan to
 be away, don't needlessly share vacation plans on social media or in general.
- Be a good and aware neighbor. You are the eyes and ears of your neighborhood, and an
 important part of our community policing efforts. Communicate with your neighbors and share
 information, either through a neighborhood watch program or online group. You know your
 neighborhood best, so look out for one another, and if anything appears suspicious, don't
 hesitate to call the police immediately.
- If you return home to find your home broken into, don't go inside, don't touch anything, and call the police immediately.

Stay safe, aware, and informed!

Preventing "Keyless" Auto Break-ins & Thefts

Nationwide, auto break-ins and auto thefts continue to be a common occurrence due to the opportunistic nature of the crime, the speed at which the incident can occur, and the potential for rewards. As motorists and passengers, we've all had to become proactive in preventing this type of crime by adopting basic measures, such as securing all vehicle doors and windows, keeping all valuables and other property out of view, not leaving a vehicle running and unattended, and using steering wheel locking devices, alarms, ignition locking devices, etc.

As vehicle technology has advanced (remote entry/unlocking/starting, keyless fobs, vehicle ignitions, etc.), so have the methods used by thieves to enter vehicles to take property, or the vehicle itself. Law enforcement agencies have seen a rise in "keyless" auto break-ins and auto thefts, involving the use of electronic devices designed for the purpose of defeating wireless unlocking technology. As these types of incidents become more common, we all need to do our part to help prevent these crimes.

How does it work? In short, auto thieves are using a variety of electronic devices to intercept radio signals transmitted through key fobs and remotes. These signals include "rolling codes" which change with each press of a button, and "fixed pin codes" commonly used in older technology, such as garage door openers. Many of these devices are small, easily concealable in a pocket, and can be used to exploit signals from key fobs and remotes in order to easily unlock vehicle doors, start the vehicle ignition, and open electronic garage doors, without damage or use of force. Of further concern, is the hacking of mobile apps that allow a driver to unlock car doors through the aid of their phone.

So, how can you best prevent keyless car theft? Here are some basic habits you can practice to keep from becoming a victim:

- After locking your doors remotely, check for alarm indicator lights to be illuminated, and check
 to see that your car doors are locked.
- Consider storing keys and key fobs that transmit wireless signals in a small signal-blocking
 protective pouch. These pouches are available online and in stores, and work like the protective
 pouches and wallets that store passports, credit cards, and other forms of indicia that utilize
 radio signal technology.
- Some key fobs can be turned off. Find out if yours can, and do so when you're away from your vehicle, or at home.
- Use technology to your advantage! Tracking devices are available which can help to monitor activity with your vehicle, and track it if stolen. Also, update any software installed on your vehicle.
- Consider placing lighting and security cameras in front of your home which not only serve as a
 deterrent to home burglaries, but are also positioned so as to make your vehicle readily visible
 and less attractive to thieves.

Keep in mind that a thief's first instinct is to get away as soon as they've committed a crime, so calling in as soon as you observe suspicious activity will provide officers with added valuable time to respond. This not only helps to prevent crime, but increases the likelihood of making an arrest, and making your neighborhood safer from criminal activity.

Stay vigilant, and safe!

What is a Robberry

Robbery is the felonious taking of personal property in the possession of another, from his/her person or imme-diate presence, and against his will, accomplished by of force or fear (section 211 California Penal means (Code.)

Robbers and thieves are targeting people that are on their iPhone or iPad as they exit the public transportation. Try to avoid displaying or using them in public. To maximize your personal safety, take time to plan and prepare at home to for your safety before leaving. Your worth it!

Here are a few tips you can follow to make yourself safer

- Digital music players and cell phones are a common target of thieves and robbers. Wearing headphones and ear buds greatly reduce your ability to hear and distracts you from potential dangers.
- . Limit your valuables by carrying only what you need.
- When on the street, be ALERT and AWARE at all times. Keep "GOOD EYE" contact with the people around you.
- Walk with confidence and purpose. Most victims are targeted because they appear not to be paying atten-tion to their surroundings.
- A handbag or book bag with a strap should not be worn across the body. It should be carried under that arm and released if grabbed.
- If taking public transportation, have your money or your Fast Pass ready in hand. Do not fumble with your wallet; you might draw attention to a pickpock-
- While on public transportation (MUNI Bus) be aware that most robberies occur when the bus stops and happens to the people that are seated by the back doors.
- Trust your instincts! If you feel uncomfortable of threatened by another person(s), seek help immedi-ately. A whistle is a great. device to have when you need to call attention to yourself.





As vehicle break-ins continue to be problematic in San Francisco, SAFE's role in the community is more important than ever. Your role is critical, too. You may be able to minimize the chance of a vehicle break-in, theft or carjacking. Don't become a victim! Use common sense. It's your best defense.

6 Theft and Break-in Safety Tips When Your Car Is Parked



- 1 Trunk: Never leave valuables in your car unattended. If necessary, place valuables in your trunk before you park.
- O Car Lock: Always lock your vehicle, close windows/sunroof completely, and take the keys.
- Glove Box: Remove all papers with your personal information from your vehicle including mail, bills, checkbook, etc. Keep your vehicle title (pink slip) safe at home.
- Street Light: Park in a well-lit area that's busy with foot traffic and/or has a parking attendant. Note where you parked.
- Car Key: Never keep a spare key in or on your vehicle. Give parking attendant only your car key. Keep your other keys with you.
- Garage Door Opener: When parking outside your home, never leave your garage door opener in your vehicle.

Cars are less likely to be broken into when they appear empty never leave valuables in your vehicle.

If You Become a Victim of Vehicle Theft or Break-In

The best way to prevent vehicle theft or break-in is to always lock doors, close windows/sunroof, and never leave valuables in your car. If a theft or break-in occurs, report immediately to the police. Provide detailed information that can help identify your vehicle or stolen items:

- License plate number and VIN number
 Any identifying features that make your vehicle distinctive (stickers, window decals, dents, etc.)
- Any special items of value (phone, radio, GPS, CD player, tire brand and size)

Avoid carjacking by staying alert when you stop. If carjacked, do not resist. Give up your car and go to a safe place to dial 9-1-1.

PREVENT GARAGE DOOR BREAK-INS

Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.



ALWAYS CLOSE YOUR GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and vou'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.

REINFORCE THE GLASS ON THE GARAGE DOOR

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.

INSTALL AN INTERIOR MANUAL GARAGE DOOR LOCK

When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.

INSTALL SURVEILLANCE CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.

HAVE A QUALITY, FUNCTIONING GARAGE DOOR

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.

INSTALL MOTION-SENSITIVE LIGHTS

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



DON'T LEAVE GARAGE DOOR REMOTE IN YOUR CAR

A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a keychain.



RELEASE CORD

Tying your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



INSTALL INTERIOR MAIL SLOT HOOD COVER

If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.

WON'T BE HOME?

Use the "*Hold Package*" option at USPS.com to have packages held at location post office for pick up. You can also arrange for neighborhoods to pick up any packages that might be delivered.

USE SPECIAL SERVICES

Use USPS special services like Signature Confirmation or Registered Mail to add a layer of security.

CUSTOMIZE DELIVERIES

Customize deliveries by adding specific delivery instructions using USPS.com and your tracking number. You can also schedule packages to arrive when you are home or reroute packages.

DELIVER TO SECURE LOCATIONS Send packages to secure locations such as

USE MODERN ALTERNATIVES

like smart lockers, lockboxes, cameras,

motion detection lighting, alarms like

Take advantage of contemporary options

Package Guard, and services like Doorman.

Amazon Lockers, FedEx and UPS locations, P.O. Boxes, and local post office.

REQUEST NONDESCRIPT

When completing your online order, opt for packaging that conceals the item or select the 'gift' option to ensure package arrives in a plain box especially when ordering from a high-end store.

NETWORK WITH NEIGHBORS

Neighborhood groups on social media or community apps can provide a system for reporting suspicious activity. This is also a good way to keep your deliveries and neighborhood secure.

Keep the porch area clear and visible. The more likely a would-be thief is to be seen, the more likely they are to choose another target.

SHARING THE ROAD WITH CYCLISTS

When it comes to safely sharing the road with cyclists, it's paramount for drivers to learn how to coexist.

Share the Road

When out and about, drivers need to be evermindful of sharing the road with cyclists.

Follow the 3 Foot Rule

Maintain a distance of 36 inches from cyclists whenever passing them. If possible, keep an even wider berth if there's bad weather or if in a higher speed limit zone.

Be Cautious with Kids

Kids can be unpredictable since their motor skills and decision-making faculties aren't fully developed. Be on alert when driving near schools and residential areas.

⊖ Stay Off the Horn

Sudden hoking might startle a cyclist and can cause them to swerve into traffic or off the road.

Mind Your Blind Spots

Drivers should double-check their mirrors when changing lanes, making turns, and especially before opening their car door after parking.

Be Patient

Don't tailgate a cyclist. When you need to pass one, patiently wait until it's safe to do so.

If you haven't done so already, register your bike at nonprofit bike registry, bikeindex.org. If you are already registered, take action to flag your bike as stolen.



What to Do During an Emergency

How to Call 911 in an Emergency

- Remain Calm and Dial 911 Immediately
 - WHEN to Dial 911
 - · If a crime is posing an immediate threat to you or others
 - · If there is a medical emergency
 - · If the incident is in progress
 - · If the incident just occurred and you know where the suspect is
- ☑ State the following information:
 - WHERE the incident is happening and WHAT is occurring,
 - for example: "I'm at 1234 Market Street and I've just been robbed"
 - · Tell the operator if you are in immediate danger or are being threatened
 - · Be brief, clear and accurate
- As long as it is safe, stay on the line and answer the operator's questions
- Describe each suspect separately from head to toe (see more information on the back of this card)

How you can file a complaint:

The San Francisco Police Department is committed to ensuring that all of our officers and civilian staff provide unbiased, quality service to our City's diverse communities. Toward that goal, the SFPD and the City of San Francisco provide several ways to file a complaint.

The Department of Police Accountability is charged with impartially investigating complaints against SFPD officers and making policy recommendations regarding police practices. You can also call the DPA at <u>1-415-241-7711</u> (the TTY line is <u>1-415-241-7770</u>) or visit the Department of Police Accountability website to file a complaint at <u>https://sfgov.org/dpa/</u>.

The DPA is located at 1 South Van Ness, 8th Floor, San Francisco, CA 94103

You may also contact a department supervisor at any SFPD police station. <u>Each station</u> is open 24 hours a day. SFPD personnel are required to receive complaints courteously and to assist you with filing them.

Please be aware that:

- The <u>San Francisco Police Commission</u> investigates all complaints forwarded by the DPA and makes recommendations for discipline by the Chief of Police.

Rights and Responsibilities under California Whistleblower Laws (Re-issue DB 19-068)

A "whistleblower" is an employee who reports a violation of the law by their employer. California's Whistleblower Law (California Labor Code section 1102.5, et seq.) prohibits employers from preventing an employee from disclosing violations of a state or federal statute, or a violation or noncompliance with a local, state, or federal rule or regulation to a government or law enforcement agency. The law also prohibits retaliation against an employee who makes a disclosure. A violation is punishable as a misdemeanor.

A "whistleblower" can also be an employee who refuses to participate in an activity that would result in a violation of a state or federal statute, or a violation of or noncompliance with a local, state, or federal rule or regulation. The law prohibits an employer from retaliating against any employee for refusing to participate in such activity.

The law extends protections to employees who reported a violation of a state or federal statute, or a violation of or noncompliance with a state or federal rule or regulation, or who exercised these rights during a former employment.

The law prohibits an employer from retaliating against an employee for exercising any of these rights, including those provided under existing law. It also provides an additional civil penalty for violations, and establishes the evidentiary burdens of the parties participating in a civil action or administrative hearing involving an alleged violation.

The law also established a "Whistleblower Hotline" within the California Attorney General's Office. The hotline number is 1-800-952-5665. Calls made to the hotline will be reviewed and forwarded to the appropriate government authority for review and possible investigation.
