## City of Oswego Business Revival and Innovation Grant Program

In April 2021, Mayor Billy Barlow and the Oswego Common Council made available \$150,000 in funding for small businesses in the City of Oswego who can demonstrate prolonged financial challenges due to the COVID-19 pandemic. The restaurant, entertainment and retail industries were greatly impacted due to mandated closures and the corresponding reduced economic activity. The City of Oswego immediately made available no-interest loans, small grants, and other helpful resources; however, some businesses are still struggling and, in some cases, have not yet been able to re-open. The Revival and Innovation Grant program will make available funding opportunities for businesses looking to reopen, expand or re-locate post-pandemic. The City of Oswego's Revival and Innovation Grant funded by the American Rescue Plan, will provide direct financial assistance to businesses still unable to fully recover from COVID-19.

To be eligible to apply for the Oswego COVID-19 Revival re-opening grant, a business must:

- Own property or maintain a leased building in the City of Oswego
- Demonstrate a loss of revenue due to COVID-19
- Explain impact of pandemic related economic restrictions, closures
- Provide general summary of organization finances
- Clearly explain use of proposed funding
- Be in the midst of a reopening, re-location and/or expansion project of an existing business
- Present full business plan, a budget and timeline for review

\*\*\*Grant awards are competitive. Eligibility does not guarantee an award.

Applications are due by May 7th, 2021 at 5:00pm to the City of Oswego Office of Economic Development located at 44 East Bridge Street.
