SUBJECT: International Area National Vice President Special Election (term November 2023 – August 2024)

FMCA recently elected Paul Mitchell to the office of National Senior Vice President. This election left the National Vice President's position vacant in the International Area. A special election is being held to fill the vacancy in the office for the unexpired term **only**. In accordance with FMCA's Bylaws and Policies and Procedures, the National Directors representing the chapters in the area will nominate and elect by mail ballot their National Area Vice President. In a normal election, each of the National Area Vice Presidents shall be elected for a two-year term. This particular election will determine the National Area Vice President to fulfill the current term, which expires at FMCA's International Convention in Redmond, Oregon, on August 17, 2024. If you are interested in running for the full term, there is a separate nomination form that will be mailed in January for the full term. Please note the following procedures:

- ◆ Nominations are to be made on the enclosed form and received in the national office no later than **September 27, 2023**.
- ◆ On **October 4, 2023**, you will be sent a mail ballot listing all candidates for your area together with a return envelope, to be returned to FMCA's certified public accountants' office, postmarked no later than **November 3, 2023**. If you will be traveling during that time and you will not be able to receive the ballot at your address on file, please contact the Chapter Services Department at the national office, or e-mail chapters@fmca.com, to have the ballot sent to an alternate address.
- ◆ Each Chapter National Director and incumbent National Area Vice President has one vote in his or her area.
- ◆ The tabulation of the ballots will be done by FMCA's certified public accountants' office on **November 13, 2023**, and you will be notified of the election results.
