The bridge overlooks a beautiful historic parabolic bridge and a great set of rapids. The trip continues through a pine canopy where you will likely see local wildlife. Although breathtakingly beautiful, if you are not a fan of heights, this may not be the activity for you. Rail bikes are pedal-powered carts with four steel wheels, disc brakes, and pedals for each seat, that ride on refurbished railroad tracks. Pedaling is relatively easy. One person in each cart will also operate a hand brake to ensure a safe speed and prevent bumping into carts in front.

Follow the story of 1760 as British and American Provincial soldiers make one last push into the heart of French Canada and immerse yourself in a place where history was made! Built by the French military between 1755 and 1759, the force that controlled Fort Ticonderoga controlled a strategic north-south waterway in both the Seven Years War and the American Revolutionary War. The 564-acre Carillon battlefield surrounds the fort, which overlooks Lake Champlain. Today, the site includes the completely restored fort and barracks, beautiful, themed gardens, museums, an education center, and re-enactments. A costumed guide will conduct a 30-minute walking tour of the fort with time to explore on your own.
