

Funding will decrease with the new changes

steady funding for the arts at least at the level as in the past.
organization(s) to continue the work that RACC has been doing beyond grant administration

Lack of funding

RFPs, especially compared to RACC's application processes, are so unintuitive and complex for an independent artist to tackle. They frequently require institutional backup re: operations or legality, and advantage established or wealthy artists over marginalized ones. It's disappointing to hear that arts and culture contracts are moving towards a process that better serves construction firms and contractors.

Confusion about where to seek funds during the transition period

Lack of a common "north star" for the arts community.

I fear that The deep relationships that RAAC has developed over many years with artists and companies and the larger community will be lost and I don't have confidence that a government entity can do what they do.

Adequate funding for our most important arts organizations.

Concern that the city won't consider equity a priority.

What worries me about the steering committee & the breakdown of the RACC contract is that there will be great effort to "make something better" but we will just be going through a large process that brings us back to the same square one.

Additionally, who will be running all the programs that RACC had through the city?

Will those be lost? Will this new entity or group of admin connected to arts funding be executing the same kinds of programs? How will the funding & programs be different or same?

Live Nation and other huge corporations entering our market and using unfair market practices that ruin the local independent music and arts scene.

The city's announcement worries me.
There has been no public forum for questions. Who will take on which of the roles RACC currently take on moving ahead. Who maintains the public art for example. So much uncertainty and for what reason? Will the designated Arts Funding be the same? More? Less? Once budgeted for the arts what will protect it for being reallocated if it stays in the City of Portland's general fund?

That politics and personalities are turning people away from the struggle the arts are facing rather than drawing them in to support arts at this critical time.

Lack of public accountability for precious public arts dollars, and a lack of assurance to the public that they are being spent wisely.

I don't understand whether this plan is advisory or if the City of Portland has already agreed to implement the plan that comes out of this process.

People love the arts but think it should be free. It can't be free without more public investment.

Why does Portland spend such an outsized percentage of the regional arts dollars compared to local counties and cities?

That Washington and Clackamas County get the support and services they need when RACC will be severely limited in how much ground they can cover (and Mult. Co. outside of Portland).

That the city of Portland will not be able to deliver the level of services to artists and organizations that we are used to.

We will set up a more competitive dynamic between the counties which will not foster coalition and partnership thinking

Who is paying for this plan?

Who gets to be on the new committee or entity that is designating these new ways of releasing funding? How can we trust the city not to dismantle great programs for artists? There's a lot of sadness over the RACC situation and a lot of grief with city politics. That's a tall order and requires lots of faith from artists and admin... to be able to execute something good. Something that meets so many artist and nonprofit needs. Worried about the city having the ability to do that.

Artist/Makers are not being used to revive or activate our cities in this region, and Multnomah County will get the bulk- and mismanage any funds they do control. PDX is going through a huge gov't transition that will last longer than July 2024, so who will be managing these RFPs, and get \$\$ and resources to the regional creatives?

Arts venues - there simply are not enough performance spaces. Particularly small and mid-sized. Will Keller remodel or reconstruction take up all the resources and focus?

That the community will hear and focus on the drama and not the art. That it hurts the reputation of artists and art orgs in our community.

City and local governments here still see the arts as a nicety, and not as critical business sector.

How will the city of Portland develop the necessary infrastructure and staff to support the arts and culture in our city?
RACC has spent decades developing policies, platforms and staff to serve the cities arts needs. How will the city replace all that in less than a year

That there will be a lot of "casualties" ie. arts orgs who are unable to hold out long enough to survive all these changes.

Funding getting cut - esp for individual artists, performance and rehearsal venues shutting down, ongoing isolation and lack of mentorship for creatives. I am also concerned about ideological divides, censorship, and polarization taking root in arts, cultural, and grant-giving organizations. Another worry is the effects of AI on creative spheres, intellectual property, and artists getting compensated fairly for their work.

We need regional arts funding. But any regional funding should be accountable to the public and elected officials. Not an ideological approach.

That portland still doesnt enhance its strengths as an art hub and tends not to give useful support to high level cultural production. It seems allergic to ambition and innovation on the support level.

funding being swallowed up by Multnomah at the expense of Washington and Clackamas

How will the cities and counties in the tricounty area work together to create a plan that makes sense for all involved and not just Portland?

That BIPOC artists and community will be less supported.

We need a non divisive environment which promotes diverse views and equity.

So many arts organizations, particularly performing arts, are still very much struggling to recover from covid. The city and counties and state need to SHOW their investments and commitments to the arts with large, unrestricted funding opportunities so that each org can make the choices that is most needed for their survival.

I worry that communities do not see equal benefit for arts work.

Portland will be so focused on housing that they will build cheap and fast, and will influence affordable arts spaces.

more transparency

Transparency? or at least more inquiry and dialogue into how dollars are being spent and distributed.

As an artist my opportunity is only limited by my own resources in many ways. I see many peers struggling with basic needs and cannot help. There are very few openings that are inclusive and welcoming.

Opportunity to be more transparent and create easier to access pathways for support.

Potential short term increase in arts funding as City attempts to sell the transition as a net benefit (though I am not optimistic)

I have long been frustrated with how RACC has operated, so there is an opportunity to do it better this time. We need to make sure we have more transparency with the new organization

Opportunity for the city to do the right thing.

The arts are Portland's best recovery mechanism as the recent struggles have left us. Artists spin straw into gold but they are treated as castoffs.... highlight those who kick ***. The office space real estate crisis presents real opportunities for smart landlords to offer artists affordable flex space

These changes could mean new and different artists/organizations will receive funding.

I hope the city takes the need for transparency and community participation seriously so that moving forward we can have more confidence that tax dollars are going to artists/orgs instead of admin.

An aggressive plan for arts funding that engages all city departments and uses the subject area specialists you have in this city.

Offer empty office space and empty public buildings at below market rates to the artists and musicians

Advocacy

Building stronger and better coalitions.

There's an opportunity to shift, update, and evolve the Portland area arts culture and how it's seen beyond the tri-county area

Take a stand for public support of arts and culture. Rebrand the Arts Tax and try again. Look at places like Denver.

If the whole tri-county area says that designed arts funding should be increased, including residents outside Multnoman County that is a chance to try to get Washington and Clackamas counties to increase their arts funding. Historically Multnomah County and City of Portland have made up about 70% of the arts funding in the metro area. If residents of all counties value it this info might help lead to more arts funding regionally if someone in leadership could use the info effectively.



What opportunities do you see now?

Fix the allergy to ambition at the funding and attention level from civic organs.

zero faith in this reorganization; I see opportunities being shut down, bureaucracy metastacizing; arts, artists, and our communities losing Creatives are excellent opportunity finders/problem-solvers. The city could benefit!

Greater public awareness about the critical lack of funding many arts orgs are facing

Portland could use a better image right now - so center the arts again!

Is there anything else that you feel the steering committee needs to know?

I don't have understanding of what they think they already know.

RACC was instrumental to building my arts career, and I will miss them

Where are the large philanthropic foundations in this plan? OCF and Meyer do very little arts funding relative to the amount of \$\$ they sit on. Where are they in elevating this conversation?

There's not enough information about what the city plans to do after the race contract is up — while I understand that they may not know exactly, they need to have more public facing information that is *concrete* that people can understand in a timeline that makes sense to anyone. I don't feel like we have that. I don't feel that anyone has high faith in the government however localized it is to execute anything in the arts that helps the arts...

Please build a plan that proposes something sustainable, and remains relevant long after it's printed. We need to build infrastructure that supports music and the arts for a long time. That means strategic vision for what success looks like, and accountability to prove to the public that we're on our way, and where our dollars are being spent so we can justify asking for more money.

More public engagement in arts commissions.

how are other communities creating new ways to highlight and support the arts

...that it's time to try a more aggressive, hard nosed approach when negotiating with elected leaders: we've been playroom by commissioner Maps and others who were eager to get musicians' votes only to betray us once in office

we don't gather on a consistent basis as a community to talk about arts issues, that is important, and it should be welcoming to more voices at the table

I hope the committee takes a regional approach to the recommendation - Clackamas, Multnomah, and Washington Counties - the region is not defined by the decisions of the City of Portland.

Empty storefronts have been made accessible for arts groups during the pandemic. These are great opportunities and should be further explored as providing permanent spaces for art exhibitions.

There has been little notice of the Waterfront Blues Festival as the largest, most heavily attended art even in the area. Build on and around it, extend other arts from its nucleus. Use existing viable structure for building further. We don't have to start from ground level on everything.

Artist and the arts community need TLC-like RACC has been demonstrating. All boats do not rise when more money flow to the largest arts organizations, which Ryan said at his art talk. Trickle down doesn't work.

RACC's dissolution/re-org should be factored into the conversation, but not eclipse other important topics that concern communities, artists, and non-profits, like venues, audience development, diverse voices and accessibility.

We (artists and arts orgs) need SO much more money flowing in to the system to make sure we can make being an artist an affordable option in this region while

keeping access affordable for patrons/community. Too many artists can't afford to live in the city anymore. We need a 30% increase in funding just to keep up with the inflation and rise in housing costs over the last several years.

Is film considered art or business? I produce film and events, and finding funding for these are tricky without a fiscal sponsor.

It would help to work with an accessibility consultant to plan access in advance and ensure everyone can access the information and spaces and participate actively. Ensuring "back end" operations are accessible also to open up leadership and employment opportunities for Deaf and Disabled art workers who have traditionally not had access to participate in these roles.

The RACC changes don't change the mission or need for a regional plan. Where the findings were leading you is still valid. RACC/City engagement might add additional information but the buzz of that change does not change the work we need out of the steering committee

Transparency matters. Are funds going to admin (and admin employees) or organizations? To individuals or supportive entities?

Fund venues! And subsidize rental rates for smaller artists/orgs so that diverse performers can get onto the best stages in the city!

Be bold in designing the plan.

I would like there to be a focus on funding those organizations who produce work created by local arts maker and employ artists who actually live in our communities. For example, if a theatre doesn't actually produce any work by the local playwright community, should the community actually be funding them? The same goes for a dance organization that is not producing work created by local choreographers and music organizations that are not producing work created by local musicians.

Pay artists!

housing is a massive issue, never forget this

One thing that should align all arts people is need for more money! We should focus on that AND work on a governance structure that does not devolve to social grievance.

All views, old and new, should be embraced in new plan. Expand the money pie, and the landscape will perhaps not be so tribal and divisive.

Fund arts education so that schools can help cultivate the next generation of creatives who make this region such an awesome place.

Trust artists to tell you what is needed here. What they need to thrive. When they thrive, so does a region. All boats rise. Give them permanent housing, possibly to ownership, places to be entrepreneurs. Their products have a slower manufacturing process, so there is an opportunity to use them to teach and educate and entertain as they make in full view. We need to truly TRULY invest in giving them our destination places. I know of models and I am working with Eco Dev folks to work towards this

This group will only be successful if it focuses on one, max two tightly defined asks from our elected leaders

I think you know that the arts community in general has zero faith in the government.

Take a serious assessment of who and what organizations have been funded in the past and look for possible holes. This could provide opportunities for targeted outreach.

Unless key city and county leaders are vested in the arts, view arts and culture as a critical component of our economic competitiveness, and are willing to fund them significantly, the plan will be just that another of many cultural plans that never come to fruition.

City has already made a decision while you are still doing analysis, hard to see how two entities are going to be able to work together or influence each other

Many of us do not live in Portland. The years of Portland being the center of the arts universe has and is changing. Many studios, schools, artists and communities are out in the counties now. Many of us are gravitating towards our county and local resources.

There definitely needs to be more funding for the arts across the board, especially for reimagining and rebuilding our downtown areas. And we also need better outreach for all the arts opportunities, events, calls, grants, etc. as well as promoting all the incredible work that is being made here.

The focus has mostly been on the Artists, which is good, but there are many arts professionals in our city and region. The organizations and businesses that support the arts and artists also need support to allow for access and advancement for arts professionals and artists alike. Most artists can't live off a few grants, then need galleries to show them and sell their work and arts organizations to commission new works. Its a whole ecosystem that needs supporting.

Can't really answer this question because I don't know what you know or don't know. I just know that the focus needs to be on the artists that create, not the politicians or RACC or whatever organization it ends up being. Whomever it is should be here just to serve the creation of art. Period

Potent art makes everyone a little uncomfortable but that's good. Stop picking that which looks like report fodder. I want granular and difficult details... not ... oh weve appeased this segment by using the most general catchphrase. Ask art to challenge and rally the civic body. Choose thoughtful agitators... Call it "Good Trouble"

without a centralized arts journal, how will anything be publicized so audiences can find the art?

Concern that this new plan is supposed to be region-wide but the city's announcement undermines that broader overview. Also worried that city funding will only benefit downtown interests.

A real focus on bringing young people into the world of the arts. More and more, they are focused on online offerings at the expense of local live art.

Portland has paid the overwhelming majority of the public arts funding in the last two decades, more than all other sources combined, which means Portland money is being spent in other communities. We need consistent support from other players.

tired of seeing many plans and conversations full of great ideas that never get enacted

We all what to know where we can find all this info at the end of the process. When and where will the full report be released? Have the City leaders (current commissioners) agree to review the report?

Include Codes of Conduct for art and media makers that require protocols for safety, consent, and intimacy, whether they are Union or Non-Union

If regional support for the arts tripled this year, it probably wouldn't be enough to stem the tide of program cancellations and company closures. Our ideas need to get dramatically more ambitious if we are going to secure the arts sector.

I really want to see accountability and follow-through on this plan. Who will hold the new entity accountable?

Not sure about "Trickle down"...but if the symphony goes under, then a whole community of musicians that play in smaller orgs will go away

We have so many creatives in this city. The fashion community is not always recognized as artists, and that is only one example. We can think out of the box to further economic development, coupled with the arts to create jobs that engage passion, and also can create revenue.

Poverty is a hard fact in our region, and perhaps, we can engage diverse individuals when we throw open the door to wide ranging artistic creativity.
