
- \$7 MILLION TO SCHOOL DISTRICTS FOR K-5 ART TEACHERS
- \$2.8 MILLION FOR GRANTS TO ARTISTS AND ORGANIZATIONS
- \$200,000 FOR ARTS EDUCATION COORDINATION

GENERAL FUND

- \$2.5 MILLION FOR PROGRAM MANAGEMENT AND ADMIN
- \$1.7 MILLION for GRANTS TO ARTISTS AND ORGANIZATIONS
- \$500,000 FOR STRATEGIC INITATIVES AND OTHER PROJECTS

HOW THE CITY IS REORGANIZING THE ARTS SERVICE DELIVERY MODEL

Bringing Some Services In-House

The City can deliver some services more effectively and efficiently.

- Example: in FY23-24 we brought "Arts Education Coordination" services in-house.
- For consideration in FY24-25: Bring "General Operating Support" grants administration in-house.

Issuing Request for Proposals (RFPs)

Issue RFPs for other arts services currently provided by RACC.


- For consideration in FY24-25: An RFP for a "small grants" program (\$1-5K grants) for artists and arts organizations; multiple RFPs for various public art functions, including collections management and maintenance.
- More arts service needs may be identified in our cultural plan, coming in 2024.
- RACC may apply and be awarded these contracts.

Limiting Administration Expenses

Limit amount our service providers can spend on program management and administration expenses.

Standard administrative fee is 20%.
