



# The tuition assistance application process is open now! Apply by April 18, 2023.

#### What tuition assistance is available?

- Catholic Tuition Organization (CTO): Provides tuition assistance based on household financial need using income guidelines and family size. This is the same program available at the parochial grade schools.
- **Diocesan Tuition Assistance (DTA)**: Established through the Ignite Campaign, DTA uses the same application process as CTO with expanded income guidelines
- Dowling Catholic: Provides tuition assistance to families with a demonstrated household financial need. DCHS uses the same application as CTO and DTA. Families may qualify for assistance from all programs depending on calculated financial need. <u>Click here</u> for eligibility guidelines.

## How is tuition assistance impacted by the new ESA program?

The process and timeframe for the distribution of <u>ESA funds</u> is still being determined, therefore it is imperative that families proceed with the tuition assistance process. Receiving tuition assistance does not affect ESA eligibility and can only help a family's financial situation.

### How do I apply for tuition assistance?

Complete *one* online application *per household* to apply for all programs. To complete the application, you must have a copy of your completed 2022 Federal Tax Return. If you are not required to file a federal tax return, please contact the DCHS Business Office at 515-222-1050 for instructions.

- Complete the **online application** at <u>www.fairapp.com</u> (available in English and Spanish). You will need a valid email address and a VISA or MasterCard to pay the \$29 fee.
- Click the "Parent Login" link and read the information page
  - New Users: click "create new login"
  - Returning Users: use email and password from last year
- Click "Create a New Application" and enter School Code: 450 | School Password: 450ddm
  - o Click the instructions link on the left you can print for reference
  - List all dependents, including those in college, grade school, public school or not yet in school. List grade, school name and school ID # for each dependent as of the <u>2023-2024</u> school year. Use **School ID #451** for DCHS students.
  - Verify the application for accuracy and pay the \$29 fee
  - You will receive confirmation instructions and an email explaining how to submit your required documentation to FAIR

#### **Important Dates**

- April 18, 2023 Application due date. If you miss this 1<sup>st</sup> deadline, CTO awards may be less depending on available funds.
- June 2023 DCHS plans to communicate the CTO/DTA/DCHS awards the first week of June for applications received by FAIR with all required documentation and the application fee by the April 18th deadline.
- August 31, 2023 Any applications received after April 18th but before July 31st will be considered late and processed in mid-August. Awards for late applications will be communicated by August 31<sup>st</sup> after school starts.
