## **Virginia 2021 Poll Findings**


Schoen Cooperman Research conducted 600 interviews statewide with likely November 2021 voters in Virginia between August 19 to 29, 2021. We also completed additional interviews in the areas of <u>Outer NOVA</u>, <u>Hampton Roads Suburbs</u>, and the <u>Richmond Suburbs</u> to achieve 300 total interviews in each region.

The poll assessed multiple issues that have been debated in advance of the November 2021 election, especially gun violence prevention. To summarize, our poll found that:


Table 1. Summary of Findings						
1)	Gun violence prevention continues to be a top concern for voters both as an issue in general and in terms of candidates' positions					
2)	➤ A substantial majority of voters (78%) believe Virginia's gun laws should be stricter or kept as they are now					
3)	> The increase in violent crime has made voters more concerned about gun violence and more supportive of stronger gun laws.					
4)	➤ There is broad support for specific, individual gun safety policies in Virginia and approximately one-half of voters have become more supportive of specific policies since before the pandemic.					
5)	<ul> <li>After testing a series of statements on Virginia Republicans' positions, we found that their opposition to common sense gun safety laws, positions on healthcare, and ties to Trump are among the most convincing reasons to vote against them.</li> <li>Information on Republican positions also make voters more likely to say that McAuliffe is better suited than Youngkin to address key public safety and gun issues.</li> </ul>					

## **Importance of Gun Safety to Voters**


Gun violence prevention continues to be a top concern for voters in Virginia with a total of 81% saying the issue is important and 56% saying it is very important.



Further, the issue of gun violence prevention is also important to voters in each of the suburban areas polled, especially in Hampton Roads.



A candidate's position on guns is also very important for voters in deciding who to vote for in the House of Delegates. Over 8-in-10 voters indicate that a candidate's position on guns is important in deciding who to vote for in the races for the House of Delegates. 5% are not sure.




Generally speaking, more than three-quarters of all likely voters also believe Virginia's gun laws should be stricter or kept as they are now, with only 14% saying that gun laws should be made less strict.

Further, the increase in violent crime has made voters more concerned about gun violence and more supportive of stronger gun laws.

Among the 88% of voters who believe violent crime is increasing in Virginia, 51% say the increase in violent crime has made them more supportive of strengthening gun safety laws.



We also tested voter support for specific gun safety policies and whether voters have become more supportive of the policy since before the coronavirus pandemic.

We find that there is indeed broad support for each gun safety policy tested and approximately one-half of voters have become more supportive of each policy since before the pandemic.

## **Statement Testing Findings**

After testing a battery of statements on Virginia Republicans' positions, we found that their positions on healthcare, opposition to common sense gun safety laws, ties to Donald Trump, and are equally damaging and the most convincing reasons to vote against them in the November 2021 elections for Governor and House of Delegates.

Further, these statements were more convincing reasons to vote against Republicans than information about the Republican response to COVID, the economy, and the environment.

Both before and after respondents received the statements about Republicans positions, we asked them whether McAuliffe or Youngkin would do a better job addressing specific public safety issues.

We found that after respondents received this information about Republicans positions, voters indicated that they trust McAuliffe over Youngkin to handle key public safety issues by greater margins.

In the table below, the blue values represent the percentage of voters that believe McAuliffe would do a better job addressing the issue and the red values represent the percentage of voters that believe Youngkin would do a better job addressing the issue.
