

# **CONSULTATION NOTE**

Relating to the draft Public Compliance Communication No. 12A (PCC 12A) on the guidance on outsourcing of compliance activities to third-parties

21 July 2020

## INTRODUCTION

 The Financial Intelligence Centre (FIC) has issued Draft Public Compliance Communication 12A (Draft PCC 12A) for consideration by all accountable institutions in terms of 42B of the Financial Intelligence Centre Act, 2001 (Act 38 of 200) (FIC Act).

## BACKGROUND

- Public Compliance Communication 12 (PCC 12) on outsourcing of compliance activities was issued in January 2012. That PCC 12 is now updated in order to align with the provisions which came into effect when the FIC Act was amended in October 2017.
- 3. The proposed updates to PCC 12 include the addition of the FIC's view on the outsourcing of risk management, scrutinising of client information, registration with the FIC, quality assurance and supervision issues. Amendments to PCC 12 are noted on the appointment of a compliance function and an elaboration on the outsourcing of regulatory reporting to the FIC.
- 4. When reviewing the draft PCC12A, it must be noted that accountable institutions cannot outsource their FIC Act obligations. However, accountable institutions may seek assistance from a third-party provider in fulfilling their obligations in terms of the FIC Act. This is applicable to all obligations, including the understanding of money laundering and terrorist financing risks.
- The Prudential Authority of the South African Reserve Bank and the Financial Services Conduct Authority have been consulted in the drafting of draft PCC 12A. Aspects arising from common inspection findings were included in the updates to this PCC.
