3. **SB1637** **EDUCATION: Allows IEP testing accommodations to be used for TCAP or EOC.** Allows testing accommodations in a student's individualized education program (IEP) to be used when taking Tennessee comprehensive assessment program (TCAP) or end-of-course (EOC) exams. Broadly captioned. **Amendment Summary:** Senate amendment 1 (013873) deletes all language after the enacting clause. 1. **HB2062** **EDUCATION: Hiring of police, public safety, and security officers by public institutions of higher education.** Gives power to the governing boards of public institutions of higher education to help decide a suitable number of police officers, public safety officers, and security officers to be employed by institutions, schools, and boards. 6. **SB741** **PUBLIC EMPLOYEES: Provision of childcare for state employees.** Authorizes state agencies to provide childcare services for state employees, with the department of human services tasked to approve, administer, and coordinate such services. Requires cost of childcare services be offset by fees, requires providers be selected by competitive contract. **Fiscal Note:** (Dated March 20, 2019) Other Fiscal Impact Passage of the this legislation will result in a significant increase in state expenditures to approve, administer and operate child care programs for state employees, and a significant increase in state revenue from fees charged to employees using the child care services. 1. **HB1687** **EDUCATION: Academic standards for science and social studies for students in kindergarten through grade two.** Requires the state board of education to eliminate all academic standards for science and social studies for students in kindergarten through grade two. Students in seventh grade meeting the required benchmark for advanced mathematics courses must be enrolled in high school level courses and no LEA may remove a student from an advanced mathematics course unless the parent or guardian requests in writing for the student's removal. By October 1 of each year starting with 2021, the department of education is required to submit a report to the education committees in the house of representatives and senate, which must include the number of eligible students, courses offered, and feedback regarding the implementation of these requirements. 1. **HB1975** **EDUCATION: Automatic revocation of the license of a licensed teacher or administrator.** Adds offenses to the list of offenses for which, upon conviction, the state board of education shall automatically revoke a teacher's or administrator's license, including arson or aggravated arson, proving a handgun to juveniles, and child abuse, child neglect or child endangerment. **Fiscal Note:** (Dated February 7, 2020) NOT SIGNIFICANT **Senate Status:** 02/10/20 - Referred to Senate Education Committee. **House Status:** 02/13/20 - Set for House Education K-12 Subcommittee 02/18/20. 2. **HB19** **EDUCATION: Persons eligible to serve on a local board of education.** Specifies that a person who is a relative of an LEA's director of schools, a member of the LEA's central office staff, or a member of the LEA's board of education is cannot serve as a member of the LEA's board of education. 3. **HB1691** **EDUCATION: Age requirements for students entering kindergarten.** Changes the date in which a child entering kindergarten must be five years of age on or before August 15 each school year to on or before June 1 each school year. Changes the date from September 30 to July 31 in which a child may be permitted to enter kindergarten if the director of schools, along with the parents of the child, find through evaluation and testing that the child is sufficiently mature emotionally and academically. **Fiscal Note:** (Dated February 7, 2020) Other Fiscal Impact The proposed legislation may impact student enrollment in kindergarten classrooms throughout the state, which may shift the amount of funds generated by the Basic Education Program (BEP) from FY22-23 to FY23-24. Actual expenditures will decrease in FY21-22 due to decreased enrollment; these expenditures will shift to FY22-23. Due to multiple unknown factors the precise impact to state and local expenditures cannot reasonably be determined. **Senate Status:** 01/23/20 - Referred to Senate Education Committee. **House Status:** 02/13/20 - Set for House Education Committee 02/19/20. 3. **HB1671** **EDUCATION: Student attendance in an alternative school or alternative program.** Allows a director of schools or the director's designee to determine whether a suspended or expelled student in grades seven through 12 should be required to attend alternative school or an alternative program based on certain conditions. Also allows a director of schools or the director's designee to remove a student from alternative school or an alternative program if the student has violated the rules of the alternative school or alternative program or the student is not benefiting from the placement. Permits the director of schools or the director's designee to enforce the suspension or expulsion of a student who transfers into the LEA under suspension or expulsion from another LEA. **Amendment Summary:** Senate Education Committee amendment 1, House Education Committee amendment 1 (013703) Deletes and replaces language in the original bill such that the only substantive changes are to: 1) require a minimum suspension of more than 10 days before attendance in an alternative school or alternative program is mandatory for students in grades 7-12; and 2) authorize a director of schools, or director's designee, to assign a student who has been expelled for committing a zero tolerance offense to an alternative school or program and require the determination to be made on a case-by-case basis. **Fiscal Note:** (Dated January 23, 2020) NOT SIGNIFICANT **Senate Status:** 02/12/20 - Senate Education Committee recommended with amendment 1 (013703). 6. **HB1559 EDUCATION: Public school instruction on events of September 11, 2001.** Requires each LEA and public charter school to provide age-appropriate instruction to public school students in kindergarten through grade 12 on the events of September 11, 2001, annually on September 11. Requires the department of education to each LEA and public charter school with a variety of age-appropriate and grade-appropriate internet resources and materials that may be used to educate K-12 public school students about the events of September 11, 2001. **Fiscal Note:** (Dated January 10, 2020) NOT SIGNIFICANT **Senate Status:** 01/22/20 - Referred to Senate Education Committee. **House Status:** 02/13/20 - Set for House Education Committee 02/19/20.

7. **HB1561 EDUCATION: Submission of high school transcripts for admission to institutions of higher education.** Prohibits a public institution of higher education from requiring a student to submit a high school transcript or GED certificate as part of the institution's admission process if the student has completed an associate degree at a regionally accredited institution of higher education. **Fiscal Note:** (Dated December 17, 2019) NOT SIGNIFICANT **Senate Status:** 02/12/20 - Senate Education Committee recommended.
