Hurricane Elsa

Dear Mr. President:

Under the provisions of Section 501 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C §§5121-5207 (the "Stafford Act"), as implemented by 44 C.F.R. §206.35, I request that you declare an emergency for the State of Florida in anticipation of Tropical Storm Elsa. This request is timely under 44 CFR §206.35(a). I submit this request in expectation of the impacts of Tropical Storm Elsa, which as of the most recent National Weather Service forecast includes potential impacts to the entire Florida Keys and portions of the Florida Peninsula as early as Monday. This request is in anticipation of the continued response, rescue, and recovery efforts necessary to save lives and to protect public health and safety.

Based upon current forecasts and modeling, I request an Emergency Declaration for Charlotte, Citrus, Collier, DeSoto, Hardee, Hernando, Hillsborough, Lee, Levy, Manatee, Miami-Dade, Monroe, Pasco, Pinellas, and Sarasota Counties in the State of Florida. Specifically, I am requesting Public Assistance Category B (Emergency Protective Measures), limited to direct Federal assistance and reimbursement for mass care including evacuation and sheltering support that are beyond the capability of State and affected tribal and/or local governments.

At 8:30 AM EDT on July 2, 2021, the National Hurricane Center reported that Tropical Storm Elsa had strengthened into a Category 1 Hurricane and was located 40 miles west of Barbados. As of 11:00 AM EDT on July 3, 2021, the National Hurricane Center reported Elsa slightly decreased in strength and was redesignated into a tropical storm, but could restrengthen once in the Gulf of Mexico to near hurricane strength before making landfall along the Florida Gulf Coast on Tuesday. Tropical Storm Elsa poses a risk of dangerous storm surge, heavy rainfall, flash flooding, strong winds, hazardous seas, and the potential for isolated tornadic activity for much of Florida's Peninsula, Florida Keys and portions of the Florida Panhandle.

The current forecast from the National Hurricane Center indicates that Tropical Storm Elsa will pass very near or over the Florida Keys overnight on July 5th and will impact the Florida peninsula on July 6th. Tropical Storm and Storm Surge Watches are anticipated to be issued from the National Hurricane Center for portions of South Florida on Saturday, July 3rd. A storm of this size and strength has the potential to produce tropical storm force winds and hurricane force gusts along the entire Florida Keys, portions of Southeast Florida, the West Coast of Florida, and portions of Northeast Florida and the Big Bend. Tropical storm force winds or similar gusts could also affect ongoing rescue and recovery efforts at the Surfside Building Collapse as early as Sunday evening.

Additionally, a storm of this magnitude on the forecast track, utilizing SLOSH directional modeling, could produce storm surge heights up to 3-6 feet above ground level along the West Coast of Florida and associated bays and islands, and 1-3 feet along the Florida Keys. Furthermore, 1-3 feet of storm surge is possible along Northeast Florida, including the St. Johns River, as the storm approaches Northeast Florida. Rainfall amounts of 2-4 inches, with isolated amounts of up to 6 inches, are forecast from the National Weather Service for much of the Florida Peninsula and Big Bend over the next 7 days. Rainfall amounts over the past 2 weeks have been above normal for this time of year across the majority of the state, particularly North and Central Florida. Due to the saturation level of the ground, a tropical system affecting this region of Florida could quickly create urban and riverine flooding conditions and cause trees to become more susceptible to downing from gusty winds.

This event comes at a time when life-saving resources and teams from all parts of Florida, to include the first time in history that all 8 of Florida's Urban Search and Rescue Teams have been deployed outside of hurricane response efforts. Additionally, assets from other states and the federal level are still actively responding to the Surfside Building Collapse (EM 3560-FL). At the time of this request, the incident period for EM 3560-FL is ongoing, with a total of 22 fatalities and 122 individuals who are still unaccounted for. The unknown needs for Tropical Storm Elsa exacerbate an already complex situation regarding response operations for the State and local jurisdictions.

The preparation for Tropical Storm Elsa and the response to the Surfside Building Collapse comes on the heels of the COVID-19 pandemic, as well as five consecutive hurricane seasons in which the State has been impacted by multiple billion-dollar events. Every jurisdiction in the State of Florida has responded to and is currently recovering from at least three federally declared events in the past five years, with most actively recovering from four events.

In the 2017 hurricane season, the State of Florida received a Major Disaster Declaration for Hurricane Irma (DR 4337-FL), followed by Hurricane Nate (EM 3395-FL) shortly thereafter. Hurricane Irma was a category four hurricane that affected the entire State and resulted in the inclusion of all 67 counties in the Disaster Declaration. Following the Hurricane Nate declaration, Florida entered into a Host-State Agreement with FEMA to provide services to Hurricane Maria survivors from Puerto Rico. FEMA has since obligated over \$2.5 billion in eligible costs to jurisdictions to recover from Hurricane Irma; however, significant costs remain unobligated, to

include emergency work. Specifically, Miami-Dade applicants, to include the Town of Surfside, represent over \$431 million of this total amount in financial damages.

In the historic 2018 hurricane season, the Florida Panhandle and Big Bend Area received a Major Disaster Declaration for Hurricane Michael (DR 4399-FL), a category five hurricane. State agencies expended over \$140.9 million in support of local jurisdictions and individual survivors. The FEMA Joint Field Office estimates that it will obligate over \$3.2 billion for this event, but only \$1.81 billion has been obligated thus far. In 2019, the State was declared for Hurricane Dorian (DR 4468-FL). While costs are still being formulated, the State estimates that the total obligated costs will be over \$181.3 million, with only \$61.3 million being obligated thus far.

For the COVID-19 (DR 4486-FL), statewide Public Assistance costs are approximately \$3.6 billion, of which includes over \$577 million for Miami-Dade County applicants, to include the Town of Surfside. The State had preliminarily estimated the total costs would be approximately \$1.4 billion. The current amount has far exceeded these original anticipated figures.

A Major Disaster, DR 4564-FL, was declared because of Hurricane Sally while still responding to the pandemic. While still in the project development phase of this event, it is anticipated that obligations of eligible work will exceed \$184 million.

On July 3, 2021, I issued Executive Order No. 21-150 which directed the State Coordinating Officer to execute the State's Comprehensive Emergency Management Plan in support of the Order in accordance with Section 501 of the Stafford Act.

Emergency protective measures required because of this event will require extraordinary efforts of state and local government for the continued response, rescue, and recovery efforts necessary to save lives and to protect public health and safety. The threat posed by Tropical Storm Elsa requires that timely precautions are taken to protect the communities, critical infrastructure, and general welfare of Florida

I have designated Kevin Guthrie, Director of the Florida Division of Emergency Management, as the State Coordinating Officer for this emergency. He is authorized to provide any further information, assurances, requests, or justification on my behalf, as well as designate additional Deputy State Coordinating Officers as necessary.
