Executive Summary:

The U.S. Nuclear Regulatory Commission (NRC) is an independent agency, established by the Atomic Energy Act of 1954, as amended, tasked with licensing, and regulating the Nation's civilian use of byproduct, source, and special nuclear material to ensure adequate protection of public health and safety, to promote the common defense and security, and to protect the environment.

Type of Award:

It is anticipated that this NOFO will result in the award of multiple grants.

Funds Available and Anticipated Number or Awards:

The total amount of funding available for the following programs is \$10,000,000.00: scholarships, fellowships, distinguished faculty advancement grants, and trade school and community college scholarships. The number of awards will depend on the number, duration, costs, and merit of the applications received.

Budget and Project Period:

Scholarships: This is a three- (3) year program. Scholarship funds may be requested for up to \$200,000.00 total costs (direct costs and facilities and administrative costs) for the project

period. A scholarship student may not receive more than \$20,000.00 over the 3-year period of the grant.

Fellowships: This is a four- (4) year program. Fellowship funds may be requested for up to \$400,000.00 total costs (direct costs and facilities and administrative costs) for the project period. A post graduate student may not receive funding more than \$50,000.00 per year or exceed \$200,000.00 over a 4-year period.

Distinguished Faculty Advancement Program: This is a four- (4) year program. Distinguished Faculty Advancement funds may be requested for up to \$600,000 total costs (direct costs and facilities and administrative costs) for the project period, provided that an additional \$100,000 is fully matchedby the recipient. Other direct costs include but are not limited to course development, equipment, stipends, participation in professional society meetings, and preparation of papers, travel, and associated expenses. The base award is up to \$500,000. However, the NRC may increase the award amount to the extent that a portion of the award is matched dollar for dollar by the recipient. **Note: No cost extensions will not be allowed under the Distinguished Faculty Advancement Program.**

Trade School and Community College Scholarships: This is a two- (2) year program. Trade School and Community College funds may be requested for up to \$150,000.00 total costs (direct costs and associated facilities and administrative costs) for the project period. A scholarship student may not receive more than \$5,000.00 per year or exceed \$10,000.00 over a 2-year period.

Eligible Institutions:

See <u>Section III, 1.</u> for eligible institutions. Please note, in the context of this document, the term "institution" is used synonymously with the term "recipient;" however, in the case of a teaming arrangement or consortium, only the lead university is the recipient.

Recipient Commitment and Responsibilities

The recipient must demonstrate a commitment to the purposes of this NOFO. The PI and the recipient institution are expected to have or to develop an administrative structure that enables faculty, academic administrators, and others involved in the project to interact productively and provide mentoring during the award period. Recipient institutions will provide support to the participants (individuals) who receive scholarships, fellowships, distinguished faculty advancement grants, and trade schools and community college scholarships. The recipient institution receiving the NRC grant is responsible for all support provided under the grant. For scholarships, fellowships and trade and community college scholarships the recipient institution must clearly describe the student support structure, outline plans to manage the program, provide a description of its selection criteria and process, provide a copy of course listings, and agree to provide the NRC with a list of students. Recipient institutions must agree to provide to provide to provide to provide to maintain contact information for the subrecipients.

Eligible Principal Investigators (PIs):

Individuals with the skills, knowledge, and resources necessary to conduct the proposed project are invited to work with their institution to develop an application. The PI (who may not also be the subrecipient) will be solely responsible for planning, directing, and executing the proposed project. The PI's role is not purely administrative, and the PI for the recipient institution must play an integral role in the performance of the proposed work.

Number of Applications:

An institution may submit only <u>one</u> application in response to this announcement for each of the Scholarship, Fellowship, Distinguished Faculty Advancement, and Trade School and Community College Scholarship grant programs. If applying for more than one program, the institution must submit separate applications.

NOTE:

- Trade Schools may only apply to the Trade School and Community College Scholarship Grant program. Trade Schools and Community Colleges are not eligible for Fellowships, or Distinguished Faculty Advancement grants.
- Community Colleges that offer a 4-year degree in nuclear science, engineering, health physics, and related disciplines may apply for Scholarships. Community Colleges may also apply to the Trade School and Community College Scholarship Grant Program.

Section I. Funding Opportunity Description

1. Program Objectives

The program provides funding for students and early career (untenured) faculty to support nuclear science, engineering, technology, and related disciplines. The objective is to develop a workforce capable of supporting the design, construction, operation, and regulation of nuclear facilities as well as the safe handling of nuclear materials.

New this year, proposals will be considered under this announcement for projects that would foster the development of innovative community engagement strategies, including incorporation of principles of equity and environmental justice.

Scholarships

The primary objective is to support scholarships for nuclear science, engineering, health physics, and related disciplines to develop a workforce capable of supporting the design, construction, operation, and regulation of nuclear facilities as well as the safe handling of nuclear materials. Related disciplines supported by this funding are intended to benefit the nuclear safety and security sector broadly.

Fellowships

The primary objective is to support fellowships for nuclear science, engineering, technology, health physics, and related disciplines to develop a workforce capable of supporting the design, construction, operation, and regulation of nuclear facilities as well as the safe handling of nuclear materials. Related disciplines supported by this funding are intended to benefit the nuclear sector broadly.

Distinguished Faculty Advancement Grants

The program provides funding to support faculty advancement in nuclear science, engineering, technology, health physics, nuclear fusion (fusion energy research) and related disciplines to develop a workforce capable of supporting the design, construction, operation, and regulation of nuclear facilities as well as the safe handling of nuclear materials. The objectives are to attract and retain highly qualified individuals <u>early</u> in their academic teaching careers (once the individuals hold a tenure-track position but have not yet obtained tenured). The program provides support to enable newer pre-tenured faculty to enhance their careers as professors and researchers in the university department where they are employed.

Trade School and Community College Scholarships

The primary objective is to support scholarships for nuclear science, engineering, technology, health physics, and related disciplines to develop a workforce capable of supporting the design, construction, operation, and regulation of nuclear facilities as well as the safe handling of nuclear materials.

Section II. Award Information

1. Cost Sharing or Matching

Cost sharing or matching is not required. However, institutions are encouraged to cost share or match NRC funding (non-Federal funds) to enhance the benefits of the NRC grant. For purposes of this announcement, cost sharing or matching means additional contributions (either financial or in-kind) that enhance the overall goals of the scholarship, fellowship, distinguished faculty advancement, and trade school and community college grant programs. Cost sharing or matching may be used to build infrastructure in nuclear and related disciplines and may include a variety of areas ranging from support of students to facility improvements or expansion. A written agreement or letter, within the last 12 months, with acost sharing or matching commitment is required at the time the application is submitted. See <u>2 CFR 200.306</u> for additional information.

If providing cost sharing or matching funds, institutions must include the type and value of support and describe how the contribution will enhance the program. *Academic year faculty release time is not a valid "in- kind" cost share/matching contribution.

2. Service Agreements

Service agreements must be signed by the student (including contact information), institution coordinator, and countersigned by the NRC Program Manager, **prior** to the student receiving financial support. Only students currently enrolled are eligible for financial support. If an institution disburses NRC grant funds without prior approval from the NRC of the service agreement, the **institution will be required to** repay those funds to the NRC, and the grant may be terminated. The recipient institution must facilitate the distribution of the service agreement to the students and submission of the signed copies to the NRC Program Manager. The recipient institution should carefully explain the terms of the service agreement to each student prior to receipt of funding. If a recipient institution becomes aware that a student will leave the institution before graduation or is in violation of the service agreement, then the institution for each student at the time of the application, during the full term of the scholarship, and for at least six (6) months after each student's graduation.

NRC requires scholarship, fellowship, and trade school and community college scholarship grant students receiving funds under the NRC Scholarship, Fellowship, and Trade School and Community College Scholarship grant program serve six (6) months in nuclear-related employment for each full or partial year of academic support. A full year of academic support would include two full semesters and consecutive summer sessions (August to July). The employment may be with NRC, other Federal agencies, State agencies, Department of Energy laboratories, nuclear-related industry, or academia in the students' sponsored fields of study. The service obligation begins after the student has completed their degree program and graduated. Recipients cannot impose additional requirements to scholarship, fellowship, and trade school and community college scholarship students beyond the NRC Service Agreement. See Attachment 1 (Service Agreement).

Students have up to 6 months after graduation to secure nuclear related employment. If a student does not obtain nuclear related employment in the 6 months' timeframe, the student can request a waiver, or the NRC will seek repayment of funds.

Failure to complete service for any reason is a breach of the NRC Service Agreement. The NRC will work with students to assist them, to the extent possible, to avoid a breach and fulfill the service obligation. A recipient should immediately contact the NRC if a situation arises in which a student is potentially unable to fulfill his/her service obligation. Individuals who breach their NRC Service Agreement contract are subject to monetary damages as follows:

(1) Failure to complete degree program – Institutions that support students who are dismissed from school for academic or disciplinary reasons or who voluntarily terminate the degree program before graduation from the institution for which the support was awarded will be in breach of the service agreement and will be liable to the NRC for all funds received by the student.

(2) Students who for any reason fail to comply with the terms and conditions of deferring or postponing the service obligation for nuclear related employment or who for any reason fail to begin or complete their service obligation after completion of degree program, will be in breach of their service obligation contract and will be liable to the NRCfor repayment for all NRC funds paid to them on their behalf.

At this time, the amount owed to the NRC is a valid debt of the Federal government subject to all laws and provisions governing the administration of the debt. In accordance with Federal regulations, if payment is not received by the NRC within 30 days from notification of indebtedness, the debt becomes past due and will be subject to interest, penalties, and administrative charges incurred by the Federal government to service the debt. After 120 days of being past due, the debt will be referred to the Department of the Treasury for collection.

An installment repayment agreement may be requested by the debtor if a single lump sum payment is not possible. An installment repayment agreement can be up to 3 years in length and will include all applicable interest, penalties, and administrative charges incurredby the Federal government to service the debt. Failure by the debtor to meet the terms and conditions of the installment agreement will result in the debt being referred to the Department of the Treasury for collection and subject to the various collection actions administered by the Department of the Treasury.

The debtor may submit a request for an installment repayment agreement to the NRC Officeof the Chief Financial Officer at (301) 415-7554 or by email at <u>Fees.Resource@nrc.gov</u>. The request should include a justification to establish an installment agreement to repay the debt.

If a waiver is submitted by a student, the NRC may waive, in whole or in part, the service obligation, upon determining that compliance by the student is impractical. Waiver requests must be submitted in writing and must include the reason that the waiver is being sought and 6 examples of documentation (rejection notices and/or application submissions) showing that the student attempted to secure nuclear related employment but was unable to do so. The NRC will allow documentation to be submitted reflecting dates that are within 6 months prior to the student's graduation date and 6 months after the student's graduation date - for a total of 1 year. If the documentation is not within this year- the documentation will not be accepted. Each of the 6 documents must relate to a different position for which the student applied. If the requested waiver is denied, a written request for payment may be issued to the student by the NRC under the provisions found in 10 CFR 15.21. The NRCs determination on a waiver request is final and not appealable.

Section III. Eligibility Information

1. Eligible Institutions

The NRC is fully committed to broadening the inclusion and contribution of communities that have been historically underserved. Eligible minority serving institutions (MSIs, Historically Black Colleges and Universities (HBCUs), or institutions located in overburdened and underserved communities are highly encouraged to apply to this NOFO.

Institutional representatives may submit an application(s) if the institution is a regionally accredited U.S. public or private institution of higher education, as defined in <u>Section 102 of the Higher Education Act of 1965 (20 USC 1002)</u>. Affiliates that manage externally funded programs for Institutions of Higher Education are eligible to submit applications for this NOFO on behalf of the institution; however, award funds are only provided to the institution's project.

- Public/State Controlled Institutions of Higher Education
- Private Institutions of Higher Education
- Hispanic-Serving Institutions (HSIs)
- Historically Black Colleges and Universities (HBCUs)
- Predominantly Black Institutions. (PBIs)
- Tribal Controlled Colleges and Universities (TCUs)
- Native American Non-Tribal Institutions (NANTI)
- Alaskan Native or Native Hawaiian-Serving Institutions (ANNHIs)
- Asian American Pacific Islander Institutions (AANAPISIs)

Institutional representatives may submit an application(s) if the institution is a regionally accredited U.S. public or private institution of higher education, as defined in <u>Section 102 of the Higher Education Act of 1965 (20 USC 1002)</u>. Affiliates that manage externally funded programs for Institutions of Higher Education are eligible to submit applications for this NOFO on behalf of the institution; however, award funds are only provided to the institution's project.

Non-domestic (non-U.S.) Entities (Foreign Institutions) are not eligible to apply.

Under this announcement, Federal agencies, national laboratories, and federally funded research and development centers are <u>not eligible</u> to participate in these Federal assistance grants (regardless of whether such entities wish to receive Federal funds or offer "in kind" services).

Under this announcement, entities other than qualified educational institutions (including individuals, NRC licensees, applicants for NRC licenses, and other non-institutional entities) are <u>not eligible</u> to participate in these Federal assistance grants (regardless of such entities wish to receive Federal funds or offer "in kind" services).

Applicants partnering with entities other than U.S. institutions of higher education will be deemed unresponsive and ineligible for consideration and the application will not be reviewed.

2. Eligibility Requirements 2.A. Eligible Scholarship Students

The Scholarship Program provides funding to 4-year colleges and universities to award scholarships to individuals pursuing nuclear science, engineering, health physics, and other disciplines that may be beneficial in developing and maintaining a nuclear workforce. Students must be enrolled in an undergraduate bachelor's degree program offered by an accredited institution of higher education in the United States. Institutions receiving NRC grants must implement procedures to monitor the academic progress of the scholarship students. The NRC will allow students of sophomore status to be considered for support after successfully completing year one of the degree program and adhering to the below criteria (i.e., 3.0 GPA, etc.).

Student applicants must meet the following criteria to receive a scholarship:

- 1. Have at the time of application and maintain a 3.0 GPA (on a 4.0 scale) overall and within major at graduation level.
- Maintain a course load of at least 12 credit hours per semester or be classified as a fulltime student (as defined by the institution), in accordance with the university's policies and practices.
- 3. Be matriculated in a bachelor's degree/major program in a nuclear or specifically identified (to NRC) nuclear-related discipline (as listed above). The degree program must be outlined in the proposal.

NOTE:

- Trade Schools are not eligible for Scholarship grants. Community Colleges that offer 4year bachelor's degrees in nuclear science, engineering, health physics, and other disciplines are eligible to apply for Scholarship grants.
- If a student is performing research under a separate NRC research and development (R&D) grant, the student should receive funding from the R&D grant for the work being completed under *that* award, not from an NRC scholarship/fellowship award.

2.B. Eligible Fellowship Students

The Fellowship Program provides funding to colleges and universities to award fellowships to individuals pursuing nuclear science, engineering and other disciplines which may be beneficial in developing and maintaining a nuclear workforce.

Students must be enrolled in a graduate degree program offered by an accredited institution of higher education in the United States. Institutions receiving NRC grants must implement procedures to monitor the academic progress of the fellowship students. The application must clearly describe how the funds will be applied.

Student applicants must meet the following criteria to receive a fellowship:

1. Have at the time of application and maintain a 3.3 GPA (on a 4.0 scale) overalland within major.

- 2. Maintain a course load of at least 12 credit hours per semester or be classified as a full-time student (as defined by the recipient), in accordance with the university's policies and practices.
- 3. Be matriculated in a graduate degree program in a nuclear or specifically identified (to the NRC) nuclear-related discipline. The degree program must be specifically outlined in the proposal.

NOTE:

- Trade Schools and Community Colleges are not eligible for Fellowship grants.
- If a student is performing research under a separate NRC research and development (R&D) grant, the student should receive funding from the R&D grant for the work being completed under *that* award, not from an NRC scholarship/fellowship award.

2.C. Eligible Recipients of Distinguished Faculty Advancement Grants

Eligible faculty for distinguished faculty advancement grants are probationary, untenured assistant/associate professors who are on the tenure track. Recipient institutions will determine that the distinguished faculty advancement grant participant (faculty member) is committed to an academic career in Nuclear, Nuclear Fusion, Mechanical, Civil, Environmental, Electrical, Fire Protection, Geotechnical, Structural and Materials Sciences Engineering, as well as Health Physics Faculty supported under a comparable early career development award funded by other federal agencies are not eligible.

Exception to the eligibility will be considered for individuals who have had a major life event requiring an extended absence (3 months or longer) from the workplace including, but not limited to, active military service, an absence due to personal disability, or an absence covered by the Family and Medical Leave Act. Requests for extended eligibility must be made by including in the application a letter signed by the dean, research vice presidents or equivalent official stating that the proposed faculty will, as of the application deadline. The request for an eligibility extension will be evaluated as part of the application selection assessment.

The application must describe how the institution will select the faculty participant, what levelof support the institution will provide, the procedures that will be used to evaluate, and the type of follow-up that will be provided for the completion of the advancement plan. The application must also describe how it will work toward building institutional capacity once theparticipant completes their faculty advancement activities.

A C.V. is required for each proposed faculty candidate, as well as upon selection of a faculty member(s), the recipient agrees to provide to the NRC with the selected faculty's C.V. for NRC approval.

Proposed faculty can be supported for a 4-year period. The PI cannot be the faculty participant selected to receive support.

NOTE:

• Trade Schools and Community Colleges are not eligible for Distinguished Faculty Advancement grants.

• If a student is performing research under a separate NRC research and development (R&D) grant, the student should receive funding from the R&D grant for the work being completed under *that* award, not from an NRC distinguished faculty advancement award.

2.D. Eligible Trade School and Community CollegeScholarship Students

The Trade School and Community College scholarship program provides funding to institutions to award scholarships to individuals pursuing certifications or Associates degrees in disciplines that are beneficial in developing and maintaining a nuclear workforce.

Institutions receiving NRC grants must implement procedures to monitor the academic progress of the scholarship recipients. The application must clearly state how the funds will be applied.

Student applicants must meet the following criteria to receive a trade school and community college scholarship:

- 1. Maintain satisfactory academic progress in the student's field of study.
- Maintain a course load of at least 12 credit hours per semester or be classified as a full-time student (as defined by the recipient), in accordance with the institution's policies and practices.
- 3. Be matriculated in a Certificate or Associates degree program for the field of nuclearrelated study for which the scholarship was approved.

2.E. Citizenship Requirement

1. Scholarships and Fellowships

Pursuant to Section 243 of the Atomic Energy Act of 1954, as amended, a student supported by a scholarship or fellowship must be a United States citizen. Students must also have full-time status at the recipient institution (universities, colleges, community colleges, and trade schools). Students holding a F1 student visa are not eligible.

2. Distinguished Faculty Advancement Grants

Pursuant to Section 31b and 141b of the Atomic Energy Act of 1954, as amended, faculty supported by a distinguished faculty advancement grant must be a United States citizen.

For the duration of the grant period, all students, faculty, PIs, Co-PIs, and other participants supported under or participating in the grant must meet the following citizenship requirements:

(1) a United States citizen; or

(2) a non-citizen national of the United States (i.e., person born in outlying possessions of the United States such as American Samoa and Swains Island); or (3) a non-citizen of the United States who has been lawfully admitted to the United States for <u>permanent residence</u> (i.e., in possession of a currently valid Alien Registration Receipt Card I-551) for the term of the grant. Individuals on temporary or student visas, as well as refugees and asylees, are not eligible.

*Noncitizen nationals are persons born in outlying possessions of the United States (i.e., American Samoa and Swains Island).

COMPLIANCE WITH U.S. IMMIGRATION LAWS AND REGULATIONS

1) <u>Scholarships and Fellowships</u>

Students supported by a scholarship or fellowship must be United States citizens.

2) Distinguished Faculty Advancement Grants

For faculty supported by a distinguished faculty advancement grant, recipient institutions are responsible to ensure that their foreign faculty and personnel (including PIs or Co-PIs) are not in violation of United States immigration laws and regulations, including employment authorization documents and visa requirements. Each institution receiving a distinguished faculty advancement grant under this award must ensure that foreign faculty supported are lawfully admitted to the U.S. for permanent residence **for the duration of the grant period**, as evidenced by Permanent Resident Form I-551 (Green Card). The U.S. Citizenship and Immigration Services provides information to grant recipients to help them understand the employment eligibility verification process for non-US citizens. The NRC reserves the right to take any number of administrative actions (e.g., disallow costs, termination) should the recipient institution violate its responsibility under this clause.

Applicants shall include a certification statement regarding compliance with the Citizenship Requirement of this announcement. The required certification template is provided in Section IV.I. and must be submitted as a separate attachment to the application.

- Name(s), address, email address and affiliations of other investigator/collaborative personnel who will contribute significantly to the project.
- The project's total funding request.
- Concise statement of the project's objectives and benefits.

C. Project Description:

The project description shall address the evaluation criteria in Section V.2 and is limited to five (5) pages or less, including text, tables, and visual materials (e.g., charts, graphs, maps, photographs).

Section V. Application Review Information

1. Review Process

Applications received will be evaluated by the NRC. Applications that are received after the closing date and time, incomplete or non-responsive will not be reviewed or considered for award. Applications that are submitted under the incorrect NOFO number shall not be reviewed or considered for award.

Prior to a comprehensive technical evaluation, the NRC will perform a preliminary review to assess the responsive of each application. This review includes an administrative review of the application to determine if it's complete and complies with the NOFO requirements. If an application is determined to be noncompliant or nonresponsive it will not receive a technical evaluation. Only applications meeting the preliminary review criteria will be considered for technical review.

2. Selection Criteria

Technical evaluation of applications shall be based on how well the applications meet or exceed the selection criteria. Applications are evaluated and rated individually by a panel of peer reviewers comprised of both Federal and non-Federal experts in the field. **The following criteria items must be addressed and clearly labeled.** These items are used to evaluate applications using the corresponding weighted value.

Scholarship and Fellowship Program

- 1. Capacity and ability of the institution to effectively conduct the program including the merit of the recruitment and marketing strategies.(**25 points**)
- 2. Type and degree of proposed student academic/technical support and assistance, including the merit of the technical programs for scholars and fellows.(**25 points**)
- 3. Merit completeness of an evaluation plan to measure the effectiveness of the

scholarship or fellowship program. (15 points)

- 4. Institutional support for the program and plans for sustainability, as well as the merit of the students who will be served by the program. (**25 points**)

- 4. Institutional support for the program and plans for sustainability. (25 points)
- 5. Cost Sharing or Matching contribution must be proposed in the form of a written agreement or commitment letter in response to this announcement. Trade Schools and Community College Scholarship Program

3. Review and Selection Process

3.A. Review Process

The NRC conducts an initial administrative review to determine that the proposal is complete and complies with the announcement's requirements. Ineligible applications or non-responsive applications may not be reviewed. The recipient may withdraw its application at any time.

The decision not to award a grant, or to award a grant at a particular funding level, is discretionary and is not subject to appeal to any NRC official or board.

Intangible and intellectual property of this award shall generally follow provisions established in <u>2 CFR § 200.315.</u>

Inventions Report

<u>Copyright</u>

The Recipient may copyright any work produced under an NRC federal financial assistance award subject to NRC's royalty-free nonexclusive and irrevocable right to reproduce, publish or otherwise use the work or authorize others to do so for Government purposes. Works jointly authored by NRC and recipient employees may be

copyrighted, but only the part authored by the recipient is protected because, under <u>17</u> <u>U.S.C. § 105</u>, works produced by Government employees are not copyrightable in the United States. On occasion, NRC may ask the Recipient to transfer to NRC its copyright in a particular work when NRC is undertaking the primary dissemination of the work. Ownership of copyright by the Government through assignment is permitted under <u>17</u> <u>U.S.C. § 105</u>.

Record Retention and Access

Conflict of Interest

Conflict of Interest standards for this award will follow the Organizational Conflict of Interest (OCOI) requirements set forth in Section 170A of the Atomic Energy Act of 1954, as amended, and provisions set forth at <u>2 CFR § 200.112</u>, Conflict of Interest.

Dispute Review Procedures

a. Any request for review of a notice of termination or other adverse decision should be addressed to the Grants Officer. It must be postmarked or transmitted electronically no later than 30 days after the postmarked date of such termination or adverse decision from the Grants Officer.

b. The request for review must contain a full statement of the Recipient's position and the pertinent facts and reasons in support of such position.

c. The Grants Officer will promptly acknowledge receipt of the request for review and shall forward it to the Director, Acquisition Management Division, unless otherwise delegated, who shall appoint an intra-agency Appeal Board to review a recipient appeal of an agency action, if required, which will consist of the program office director, the Deputy Director of Office of Administration, and the Office of General Counsel, or their designees.

d. Pending resolution of the request for review, the NRC may withhold or defer payments under the award during the review proceedings.

The review committee will request the Grants Officer who issued the notice of termination or adverse action to provide copies of all relevant background materials and documents. The committee may, at its discretion, invite representatives of the recipient and the NRC program office to discuss pertinent issues and to submit such additional information as it deems appropriate. The chairman of the review committee will insure that all review activities or proceedings are adequately documented.

Modification to Period of Performance - 2 CFR § 200.309

The recipient may charge to the Federal award only allowable costs incurred during the period of performance.

Unless otherwise authorized in <u>2 CFR Part 200</u> or by special award condition, any extension of the award period can only be authorized by the Grants Officer in writing.

Assurances of funding from anyone other than the Grants Officer shall not constitute authority to obligate funds for programmatic activities beyond the expiration date.

The NRC Grant Officer may authorize a no cost extension of the period of performance. The recipient must submit a no cost extension request no less than 60 business days prior to the award end date. Any request for a no cost extension after the grant has expired will not be approved. Any modification of the award to increase funding and/or to extend the period of performance is at the sole discretion of the NRC.

Incremental Funding

Additional funding for this award is contingent upon the availability of appropriated funds, satisfactory performance, and the recipient's capacity to manage the award and comply with award requirements. The recipient agrees to perform work up to the amount obligated as specified in Attachment A of the grant award. NRC is not obligated to reimburse the recipient for expenditures in excess of the total funds obligated by NRC. The recipient is not authorized to continue performance beyond the amount obligated to this award. Any work performed by the grantee beyond the funding amount obligated in Section A will be at the grantee's risk.

Automated Standard Application for Payments (ASAP) Procedures

Unless otherwise stated, recipient payments are made using the Department of Treasury's Automated Standard Application for Payment (ASAP) system, <u>ASAP.gov</u>, through preauthorized electronic funds transfers. To receive payments, recipients are required to enroll with the Department of Treasury, Financial Management Service, and Regional Financial Centers, which allows them to use the on-line method of withdrawing funds from their ASAP established accounts. III. Programmatic Requirements

Service Agreement

The recipient is responsible for providing documentation to the NRC that tracks each student's progress in achievement of the academic program for which Federal funds were provided. This includes: (1) ensuring that the service agreement is signed by the student, institution coordinator and countersigned by the NRC Program Manager **prior** to providing support; (2) providing the NRC with student contact information upon student entry into the program, upon completion or withdrawal from the program, and upon request by the NRC; and (3) monitoring the student's fulfillment of the service agreement for the duration of the award. The institution shall immediately notify the NRC if a student is not fulfilling the academic program or the service agreement.

Students have up to 6 months after graduation to secure nuclear related employment. If a student does not obtain nuclear related employment in the 6-month timeframe, the student can request a waiver, or the NRC will seek repayment of funds.

Failure to complete service for any reason is a breach of the NRC Service Agreement. The NRC will work with students to assist them, to the extent possible, to avoid a breach and fulfill the service obligation. A recipient should immediately contact the NRC if a situation arises in which a student is potentially unable to fulfill his/her service obligation. Individuals who breach their NRC Service Agreement contract are subject to monetary damages as follows:

- (1) Failure to complete degree program Institutions that support students who are dismissed from school for academic or disciplinary reasons or who voluntarily terminate the degree program before graduation from for which the support was awarded will be in breach of the service agreement and will be liable to the NRC for repayment of all NRC funds received by the students.
- (2) Students who for any reason fail to comply with the terms and conditions of deferring or postponing the service obligation for nuclear related employment or who for any reason fail to begin or complete their service obligation after completion of degree program, will be in breach of their service obligation contract and will be liable to the NRC for repayment for all NRC funds paid to them on their behalf.

At this time, the amount owed to the NRC is a valid debt of the Federal government subject to all laws and provisions governing the administration of the debt. In accordance with Federal regulations, if payment is not received by the NRC within 30 days from notification of indebtedness, the debt becomes past due and will be subject to interest, penalties, and administrative charges incurred by the Federal government to service the debt. After 120 days of being past due, the debt will be referred to the Department of the Treasury for collection.

An installment agreement may be requested by the debtor if a single lump sum payment is

not possible. An installment agreement can be up to 3 years in length and will include all applicable interest, penalties, and administrative charges incurred by the Federal government to service the debt. Failure by the debtor to meet the terms and conditions of the installment agreement will result in the debt being referred to the Department of the Treasury for collection and subject to the various collection actions administered by the Department of the Treasury.

The debtor may submit a request for an installment agreement to the NRC Office of the Chief Financial Officer at (301) 415-7554 or by email at <u>Fees.Resource@nrc.gov</u>. The request should include a justification to establish an installment agreement to repay the debt.

If a waiver is submitted by a student, NRC may waive, in whole or in part, the service obligation, upon determining that compliance by the student is impractical. Waiver requests must be submitted in writing including the reason the waiver is being sought and documentation evidencing that he/she attempted to secure nuclear related employment but was unable to do so. If the requested waiver is denied, a written request for payment may be issued to the student by the NRC under the provisions found in 10 CFR 15.21.

Prohibition Against Assignment by The Recipient

The recipient will not transfer, pledge, mortgage, or otherwise assign the award, or any interest to the award, or any claim arising under the award, to any party, banks, trust companies, or other financing or financial institutions without the written approval of the Grants Officer.

Site Visits

The NRC, through authorized representatives, has the right to make site visits to review project accomplishments and management control systems and to provide technical assistance as required. If any site visit is made by the NRC on the premises of the recipient or contractor under an award, the recipient shall provide and shall require his/her contractors to provide reasonable access to all facilities and provide necessary assistance for the safety and convenience of the Government representative in the performance of his/her official duties.

IV. Additional Requirements Criminal and Prohibited Activities

The Program Fraud Civil Remedies Act (<u>31 U.S.C. §§ 3801-3812</u>), provides for the imposition of civil penalties against persons who make false, fictitious, or fraudulent claims to the Federal government for money (including money representing grant/cooperative agreements, loans, or other benefits).

False statements (<u>18 U.S.C. § 287</u>), provides that whoever makes or presents any false, fictitious, or fraudulent statements, representations, or claims against the United States shall be subject to imprisonment of not more than five years and shall be subject to a fine in the amount provided by 18 USC §287.

False Claims Act (<u>31 U.S.C. § 3729 et seq.</u>), provides that suits under this Act can be brought by the government, or a person on behalf of the government, for false claims under Federal assistance programs.

Copeland "Anti-Kickback" Act (<u>18 U.S.C. § 874</u>), prohibits a person or organization engaged in a Federally supported project from enticing an employee working on the project from giving up a part of his compensation under an employment contract.

American-Made Equipment and Products

Recipients are encouraged to purchase American-made equipment and products with funding provided under this award.

Increasing Seat Belt Use in the United States

E.O. 13043, amended by E.O. 13652, requires recipients to encourage employees and contractors to enforce on-the-job seat belt policies and programs when operating company-owned, rented or personally-owned vehicle.

Federal Leadership of Reducing Text Messaging While Driving

E.O. 13513 requires recipients to encourage employees, sub-awardees, and contractors to adopt and enforce policies that ban text messaging while driving company-owned, rented vehicles or privately-owned vehicles when on official Government business or when performing any work for or on behalf of the Federal Government.

Federal Employee Expenses

Federal agencies are barred from accepting funds from a recipient to pay transportation, travel, or other expenses for any Federal employee unless specifically approved in the terms of the award. Recipients and subrecipients are prohibited from obligating or expending loan or grant funds to: (1) Procure or obtain; (2) Extend or renew a contract to procure or obtain; or (3) Enter into a contract (or extend or renew a contract) to procure or obtain equipment, services, or systems that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. As described in Public Law $115\hat{a}\in^{\circ}232$, section 889, covered telecommunications equipment is telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation (or any subsidiary or affiliate of such entities).

(i) For the purpose of public safety, security of government facilities, physical security surveillance of critical infrastructure, and other national security purposes, video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company (or any subsidiary or affiliate of such entities).

(ii) Telecommunications or video surveillance services provided by such entities or using such equipment.

(iii) Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of the National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the government of a covered foreign country.

In implementing the prohibition under Public Law 115–232, section 889, subsection (f), paragraph (1), heads of executive agencies administering loan, grant, or subsidy programs shall prioritize available funding and technical support to assist affected businesses, institutions and organizations as is reasonably necessary for those affected entities to transition from covered communications equipment and services, to procure replacement equipment and services, and to ensure that communications service to users and customers is sustained.

Minority Serving Institutions (MSIs) Initiative

Pursuant to Presidential E.O., 13889, "Continuance of Certain Federal Advisory Committees", and E.O.13592 "Improving American Indian and Alaska Native Educational Opportunities and Strengthening Tribal Colleges and Universities"; E.O. 13621, "White House Initiative on Educational Excellence for African Americans"; 13779, "White House Initiative to Promote Excellence and Innovation at Historically Black Colleges and Universities (HBCUs); 13872, "Economic Empowerment of Asian Americans and Pacific Islanders", 13935, "White House Hispanic Prosperity Initiative", and E.O.s 13309 and 12994, President's Committee for People with Intellectual Disabilities.

The NRC is strongly committed to broadening the participation of MSIs in its financial assistance program. The NRC's goals include achieving full participation of MSIs/HBCUs in order to advance the development of human potential, strengthen the Nation's capacity to provide high-quality education, and increase opportunities for MSIs/HBCUs to participate in

and benefit from Federal financial assistance programs. The NRC encourages all applicants and recipients to include meaningful participation of MSIs/HBCUs. Research Misconduct

Scientific or research misconduct refers to the fabrication, falsification, or plagiarism in proposing, performing, or reviewing research, or in reporting research results. It does not include honest errors or differences of opinions. The recipient organization has the primary responsibility to investigate allegations and provide reports to the Federal Government. Funds expended on an activity that is determined to be invalid or unreliable because of scientific misconduct may result in a disallowance of costs for which the institution may be liable for repayment to the awarding agency. The Office of Science and Technology Policy at the White House published in the Federal Register on December 6, 2000, a final policy that addressed research misconduct. The policy was developed by the National Science and Technology Council (<u>65 FR 76260</u>). The NRC requires that any allegation be submitted to the Grants Officer, who will also notify the OIG of such allegation. Generally, the Recipient organization shall investigate the allegation and submit its findings to the Grants Officer. The NRC may accept the recipient's findings or proceed with its own investigation. The Grants Officer shall inform the recipient of the NRC's final determination.

Publications. Videos. and Acknowledgment of Sponsorship

Publication of the results or findings of a research project in appropriate professional journals and production of video or other media is encouraged as an important method of recording and reporting scientific information. It is also a constructive means to expand access to federally funded research. If the recipient releases information related to an NRC-funded project, the recipient is required to—(1) submit a copy of such information to the NRC, and (2) include a statement that the project or effort undertaken was/is sponsored by the NRC. The recipient is also responsible for assuring that every publication of material (including Internet sites and videos) based on or developed under an award, except scientific articles or papers appearing in scientific, technical, or professional journals, contains the following disclaimer:

"This **[report/video]** was prepared by **[Recipient name]** under award **[number]** from **[name of operating unit]**, Nuclear Regulatory Commission. The statements, findings, conclusions, and recommendations are those of the author(s) and do not necessarily reflect the view of the **[name of operating unit]** or the U.S. Nuclear Regulatory Commission."

<u>Trafficking In Victims Protection Act Of 2000 (as amended by the Trafficking Victims</u> <u>Protection Reauthorization Act of 2003)</u>

Section 106(g) of the Trafficking In Victims Protection Act Of 2000 (as amended as amended, directs on a government-wide basis that:

"...any grant, contract, or cooperative agreement provided or entered into by a Federal department or agency under which funds are to be provided to a private entity, in whole or in part, shall include a condition that authorizes the department or agency to terminate the

grant, contract, or cooperative agreement, without penalty, if the recipient or any subrecipient, or the contractor or any subcontractor (i) engages in severe forms of trafficking in persons or has procured a commercial sex act during the period of time that the grant, contract, or cooperative agreement is in effect, or (ii) uses forced labor in the performance of the grant, contract, or cooperative agreement." (See 22 U.S.C. §7104(g).)

Grant Recipient Protection from Reprisal for Disclosure of Certain Information

An employee of a grantee or subgrantee may not be discharged, demoted, or otherwise discriminated against as a reprisal for disclosing information that the employee reasonably believes is evidence of gross mismanagement of a Federal grant, a gross waste of Federal funds, an abuse of authority related to a Federal grant, a substantial and specific danger to public health or safety, or a violation of law, rule or regulation related to a Federal grant, in accordance with 41 USC 4712. Grantee organizations and subgrantee organizations shall notify their employees in writing of their rights and remedies under 41 USC 4712.

Executive Compensation Reporting

2 CFR § 170.220 directs agencies to include the following text to each grant award to a non-Federal entity if the total funding is \$30,000 or more in Federal funding.

Reporting Subawards and Executive Compensation.

a. Reporting of first-tier subawards.

1. *Applicability.* Unless you are exempt as provided in paragraph d. of this award term, you must report each action that obligates \$30,000.00 or more in Federal funds that does not include Recovery funds (as defined in section 1512(a)(2) of the American Recovery and Reinvestment Act of 2009, Pub. L. 111–5) for a subaward to an entity (see definitions in paragraph e. of this award term).

2. Where and when to report.

b. Reporting Total Compensation of Recipient Executives.

1. *Applicability and what to report.* You must report total compensation for each of your five most highly compensated executives for the preceding completed fiscal year, if—

i. the total Federal funding authorized to date under this award is \$30,000.00 or more;

ii. in the preceding fiscal year, you received-

(A) 80 percent or more of your annual gross revenues from Federal procurement contracts (and subcontracts) and Federal financial assistance subject to the Transparency Act, as defined at <u>2 CFR § 170.320</u> (and subawards); and

(B) \$25,000,000 or more in annual gross revenues from Federal procurement contracts (and subcontracts) and Federal financial assistance subject to the Transparency Act, as defined at <u>2 CFR § 170.320</u> (and subawards); and

iii. The public does not have access to information about the compensation of the executives through periodic reports filed under section 13(a) or 15(d) of the Securities Exchange Act of 1934 (<u>15 U.S.C.</u> 78m(a), 78o(d)) or section 6104 of the Internal Revenue Code of 1986. (To determine if the public has access to the compensation information, see the U.S. Security and Exchange Commission total compensation filings at <u>http://www.sec.gov/answers/execomp.htm</u>.)

2. *Where and when to report.* You must report executive total compensation described in paragraph b.1. of this award term:

i. As part of your registration profile at <u>http://www.sam.gov</u>.

ii. By the end of the month following the month in which this award is made, and annually thereafter.

c. Reporting of Total Compensation of Subrecipient Executives.

1. Applicability and what to report. Unless you are exempt as provided in paragraph d. of this award term, for each first-tier subrecipient under this award, you shall report the names and total compensation of each of the subrecipient's five most highly compensated executives for the subrecipient's preceding completed fiscal year, if—

i. in the subrecipient's preceding fiscal year, the subrecipient received-

(A) 80 percent or more of its annual gross revenues from Federal procurement contracts (and subcontracts) and Federal financial assistance subject to the Transparency Act, as defined at <u>2 CFR § 170.320</u> (and subawards); and

(B) \$25,000,000 or more in annual gross revenues from Federal procurement contracts (and subcontracts), and Federal financial assistance subject to the Transparency Act (and subawards); and

ii. The public does not have access to information about the compensation of the executives through periodic reports filed under section 13(a) or 15(d) of the Securities Exchange Act of 1934 (15 U.S.C. 78m(a), 78o(d)) or section 6104 of the Internal Revenue Code of 1986. (To determine if the public has access to the compensation information, see the U.S. Security and Exchange Commission total compensation filings at <u>http://www.sec.gov/answers/execomp.htm</u>.)

2. *Where and when to report.* You must report subrecipient executive total compensation described in paragraph c.1. of this award term:

i. To the recipient.

ii. By the end of the month following the month during which you make the subaward. For example, if a subaward is obligated on any date during the month of October of a given year (*i.e.*, between October 1 and 31), you must report any required compensation information of the subrecipient by November 30 of that year.

d. Exemptions

If, in the previous tax year, you had gross income, from all sources, under \$300,000.00, you are exempt from the requirements to report:

i. Subawards, and

ii. The total compensation of the five most highly compensated executives of any subrecipient.

- e. *Definitions*. For purposes of this award term:
- 1. *Entity* means all of the following, as defined in 2 CFR Part 25:
- i. A Governmental organization, which is a State, local government, or Indian tribe;
- ii. A foreign public entity;
- iii. A domestic or foreign nonprofit organization;

iv. A domestic or foreign for-profit organization;

v. A Federal agency, but only as a subrecipient under an award or subaward to a non-Federal entity.

2. *Executive* means officers, managing partners, or any other employees in management positions.

3. Subaward:

i. This term means a legal instrument to provide support for the performance of any portion of the substantive project or program for which you received this award and that you as the recipient award to an eligible subrecipient.

ii. The term does not include your procurement of property and services needed to carry out the project or program (for further explanation, see 2 CFR 200.331).

iii. A subaward may be provided through any legal agreement, including an agreement that you or a subrecipient considers a contract.

4. *Subrecipient* means an entity that:

i. Receives a subaward from you (the recipient) under this award; and

ii. Is accountable to you for the use of the Federal funds provided by the subaward.

5. *Total compensation* means the cash and noncash dollar value earned by the executive during the recipient's or subrecipient's preceding fiscal year and includes the following (for more information see $17 \text{ CFR } \S 229.402(c)(2)$):

i. Salary and bonus.

ii. Awards of stock, stock options, and stock appreciation rights. Use the dollar amount recognized for financial statement reporting purposes with respect to the fiscal year in accordance with the Statement of Financial Accounting Standards No. 123 (Revised 2004) (FAS 123R), Shared Based Payments.

iii. *Earnings for services under non-equity incentive plans.* This does not include group life, health, hospitalization or medical reimbursement plans that do not discriminate in favor of executives, and are available generally to all salaried employees.

iv. *Change in pension value.* This is the change in present value of defined benefit and actuarial pension plans.

v. Above-market earnings on deferred compensation which is not tax-qualified.

vi. Other compensation, if the aggregate value of all such other compensation (e.g., severance, termination payments, value of life insurance paid on behalf of the employee, perquisites, or property) for the executive exceeds \$10,000.00.
